Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Altura Communication Solutions, LLC Union 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 30, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to December 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Altura Communication Solutions, LLC Union 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 30, 2022 and December 31, 2021, and for the period from January 1, 2022 to December 30, 2022, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

Emphasis of Matter

As disclosed in Note 1 to the financial statements, the Plan was merged into the Waterfield Technologies 401(k) Plan effective January 1, 2023, and all assets were transferred as of December 30, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Altura Communication Solutions, LLC Union 401(k) Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

1. Description of Plan

The following description of the Altura Communication Solutions, LLC Union 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established effective April 1, 1987, as restated effective June 30, 2020. The Plan covered all employees solely compensated under a collective bargaining agreement of Altura Communications, LLC (the Company) who met certain eligibility requirements and who have completed 30 days. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's Governance Committee was responsible for oversight of the Plan. The Plan's Governance Committee determined the appropriateness of the Plan's investment offerings, and monitored investment performance.

Plan Merger

Effective March 1, 2021, the Company was acquired by Waterfield Technologies Inc. (Waterfield). In connection with the acquisition, former eligible employees of the Company who became employees of Waterfield were eligible to participate in the Waterfield Technologies 401(k) Plan (Waterfield Plan) effective January 1, 2022, and there were no contributions or new participants added to the Plan during the period from January 1, 2022 to December 30, 2022.

Effective January 1, 2023, the Plan was merged into the Waterfield Plan. See Note 4.

Contributions

Prior to the Plan being frozen, participants could contribute up to 75% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who attained age 50 before the end of a plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. Additional discretionary amounts could be contributed by the Company at the option of the Board of Directors. For the period from January 1, 2022 to December 30, 2022, there were no participant contributions to the Plan and there were no discretionary Company contributions to the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 50% vested after two years of credited service and continued to vest in increments of 25% until 100% vested after five years of credited service.

Notes Receivable From Participants

Participants could borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined daily, was set at the prime rate, as defined. Principal and interest were paid ratably through bi-weekly payroll deductions. Loan terms ranged up to five years or greater for the purchase of a primary residence.

Payment of Benefits

Distributions and withdrawals were payable upon retirement, termination, financial hardship, disability or death. In addition, an in-service distribution could be taken prior to termination of employment after reaching age 59 1/2. If a participant's vested account balance was equal to or less than \$1,000, the balance would be distributed immediately in a lump-sum cash payment unless a direct rollover into another qualified benefit plan was requested. If the vested account balance was greater than \$1,000, the participant could consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan or postpone payment to a later date and remain in the Plan as described in the Plan document.

Forfeited Accounts

At December 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$14,025, respectively. Forfeitures could be used to pay for administrative expenses; any forfeiture not used to pay administrative expenses would then be applied to reduce the contributions of the Company. During the period from January 1, 2022 to December 30, 2022, Plan administrative expenses were reduced by \$14,062 from forfeited nonvested accounts, in accordance with plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through February 8, 2024, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Based on the Plan Merger (Note 1), there were no investment balances as of December 30, 2022. Following is a description of the valuation methodologies used for assets measured at fair value at fair value at December 31, 2021.

4. Transfers Into or Out of the Plan

As described in Note 1, effective January 1, 2023, the Plan was merged into Waterfield Technologies 401(k) Plan ("Waterfield Plan"). In connection with the Plan merger, assets totaling \$7,906,502 were transferred to the Waterfield Plan on December 30, 2022.

5. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by the Trustee (Note 8), and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Tax Status

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

For the year ended December 31, 2021, untimely remittances totaled \$35,671, of which \$23,415 and \$12,256 were corrected outside of VFCP in October 2023 and December 2022, respectively.

1. Description of Plan

The following description of the Altura Communication Solutions, LLC Union 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established effective April 1, 1987, as restated effective June 30, 2020. The Plan covered all employees solely compensated under a collective bargaining agreement of Altura Communications, LLC (the Company) who met certain eligibility requirements and who have completed 30 days. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's Governance Committee was responsible for oversight of the Plan. The Plan's Governance Committee determined the appropriateness of the Plan's investment offerings, and monitored investment performance.

Plan Merger

Effective March 1, 2021, the Company was acquired by Waterfield Technologies Inc. (Waterfield). In connection with the acquisition, former eligible employees of the Company who became employees of Waterfield were eligible to participate in the Waterfield Technologies 401(k) Plan (Waterfield Plan) effective January 1, 2022, and there were no contributions or new participants added to the Plan during the period from January 1, 2022 to December 30, 2022.

Effective January 1, 2023, the Plan was merged into the Waterfield Plan. See Note 4.

Contributions

Prior to the Plan being frozen, participants could contribute up to 75% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who attained age 50 before the end of a plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. Additional discretionary amounts could be contributed by the Company at the option of the Board of Directors. For the period from January 1, 2022 to December 30, 2022, there were no participant contributions to the Plan and there were no discretionary Company contributions to the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 50% vested after two years of credited service and continued to vest in increments of 25% until 100% vested after five years of credited service.

Notes Receivable From Participants

Participants could borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined daily, was set at the prime rate, as defined. Principal and interest were paid ratably through bi-weekly payroll deductions. Loan terms ranged up to five years or greater for the purchase of a primary residence.

Payment of Benefits

Distributions and withdrawals were payable upon retirement, termination, financial hardship, disability or death. In addition, an in-service distribution could be taken prior to termination of employment after reaching age 59 1/2. If a participant's vested account balance was equal to or less than \$1,000, the balance would be distributed immediately in a lump-sum cash payment unless a direct rollover into another qualified benefit plan was requested. If the vested account balance was greater than \$1,000, the participant could consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan or postpone payment to a later date and remain in the Plan as described in the Plan document.

Forfeited Accounts

At December 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$14,025, respectively. Forfeitures could be used to pay for administrative expenses; any forfeiture not used to pay administrative expenses would then be applied to reduce the contributions of the Company. During the period from January 1, 2022 to December 30, 2022, Plan administrative expenses were reduced by \$14,062 from forfeited nonvested accounts, in accordance with plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through February 8, 2024, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Transfers Into or Out of the Plan

As described in Note 1, effective January 1, 2023, the Plan was merged into Waterfield Technologies 401(k) Plan ("Waterfield Plan"). In connection with the Plan merger, assets totaling \$7,906,502 were transferred to the Waterfield Plan on December 30, 2022.

5. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by the Trustee (Note 8), and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Tax Status

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

8. Information Certified by Trustee

9. Delinquent Participant Contributions

For the period from January 1, 2022 to December 30, 2022, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions as of December 30, 2022, which totaled \$14,084, were corrected outside of Voluntary Fiduciary Correction Program (VFCP) in November 2023.

For the year ended December 31, 2021, untimely remittances totaled \$35,671, of which \$23,415 and \$12,256 were corrected outside of VFCP in October 2023 and December 2022, respectively.
