APRIL 17, 2023 (DATE OF MERGER) AND DECEMBER 31, 2022

NOTE 1 PLAN DESCRIPTION

The following description of Chromalox, Inc. Employee Savings Investment Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a participant-directed defined contribution plan covering substantially all employees of Chromalox, Inc. (the Company) who are not covered under a collective bargaining agreement. The Company is the plan sponsor and administrator that controls and manages the operation and administration of the Plan. The Plan’s investments and participant loans are held by State Street Bank and Trust Company, the trustee.

An employee becomes eligible to participate in the Plan on the first day of the payroll period following the date the employee completes sixty days of service. In addition, the Plan includes an automatic enrollment feature. If an employee does not submit an automatic enrollment waiver, he or she will be automatically enrolled in the Plan at a 6% deferral rate.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Merger into the Spirax Sarco Inc. 401(k) Plan

Effective April 17, 2023, the Chromalox, Inc. Employee Savings Investment Plan merged into the Spirax Sarco Inc. 401(k) Plan. As a result, the Chromalox, Inc. Employee Savings Investment Plan assets and participant accounts in the amount of \$46,778,505 were transferred from this plan into the Spirax Sarco Inc. 401(k) Plan and the Plan Sponsor became a participating employer in a the Spirax Sarco Inc. 401(k) Plan.

Contributions

Participants may contribute up to 75% of their annual eligible compensation to the Plan, subject to certain Internal Revenue Code (IRC) limitations. The Plan was amended on April 15, 2019 to permit participants to contribute Roth after-tax deferrals, rollovers and in-plan conversions. The Plan also permits rollover contributions of retirement benefits received from other qualified plans. In addition, those participants who are age 50 or older may make catch-up contributions.

The Company matches 50% of participant contributions, including catch-up contributions, up to 6% of the participant’s eligible compensation. For participants with 20 or more years of service, an additional 10% match is made by the Company on the first 6% of eligible compensation. The Company may make discretionary matching contributions up to 4% of a participant’s eligible compensation. There were no discretionary matching contributions for the period January 1, 2023 through April 17, 2023 (Date of Merger).

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions and allocations of plan earnings, and is charged with withdrawals and an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions, actual earnings thereon, and any contributions made on their behalf into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant vests 20% per year and is 100% vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The loan must be repaid within five years through payroll deductions unless the loan is utilized for a principal residence, in which case the plan administrator may permit a longer repayment term.

In the event of default, as described in the Plan, participants are considered to have received a distribution and are subject to income taxes on the distributed amount.

Payment of Benefits

Distributions from the Plan may be made in cash upon termination of employment or may be deferred until the participant's normal retirement age. Retiring participants may elect benefit distribution in a lump-sum payment amount equal to the value of his or her vested account. Required minimum distributions may also elect cash installments over the life of the participant and a designated beneficiary. If an account balance is below \$1,000 at the time of termination, the employee will automatically receive a lump-sum payment. If an account balance is greater than \$1,000 but less than \$5,000 at the time of termination, the Plan has the option of rolling the vested balance over to another qualified retirement account. A participant may also request a withdrawal from their account based upon financial hardship or at age 59½, as defined by IRC regulations.

Forfeitures

Forfeited amounts may be used to reduce future contributions made by the employer or to reduce administrative expenses. Forfeitures of approximately \$42,000 were used to reduce employer contributions or pay administrative expenses during the period ended April 17, 2023 (date of merger). Forfeited non-vested account balances totaled approximately \$0 at April 17, 2023 (Date of Merger) and \$34,000 at December 31, 2022.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of fair value measurements.

Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Company or the Plan, as provided by the plan document. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

- Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities;

- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 17, 2023 (Date of Merger) and December 31, 2022.

Mutual Funds: Mutual funds are public investment vehicles valued using the net asset value provided by the administrator of the fund on the last day of the Plan's year end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

Common collective trust fund: The Plan holds an interest in a Stable Value Fund sponsored by Transamerica Retirement Solutions Company. The Stable Value Fund is a common collective trust fund that primarily invests in fully benefit-responsive investment contracts. The fund is valued at the NAV provided by the trustee on the last day of the Plan's year end. NAV is used as a practical expedient to estimate fair value. Redemption and subscription is permitted daily, with no other restrictions. There are no unfunded commitments.

Cash: Cash is valued at cost, which approximates fair value, and classified within Level 1 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no investments held by the plan as of April 17, 2023 (Date of Merger).

NOTE 4 CERTIFIED FINANCIAL INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank & Trust Company, the trustee of the Plan, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of April 17, 2023 (Date of Merger) and December 31, 2022.

Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period January 1, 2023 through April 17, 2023 (Date of Merger).

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

NOTE 5 TAX STATUS

The Plan adopted a non-standardized profit sharing plan sponsored by Transamerica which had received an opinion letter dated June 30, 2020, from the IRS which stated the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated to Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2020.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments in cash and the stable pooled fund are sponsored and advised by Transamerica Investment Advisors (Transamerica) and SSB&T. Fiducia LLC provides investment advisory and management services. Transamerica is the recordkeeper and SSB&T is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for custodian and recordkeeping services as well as investment management services amounted to \$41,286 for the period January 1, 2023 through April 17, 2023 (Date of Merger). These transactions are not, however, considered prohibited transactions under Section 408(b) of the ERISA regulations. The Plan has notes receivable from participants subject to specific guidelines as defined in the plan agreement (Note 1). These transactions are not deemed prohibited party-in-interest transactions, because they are covered by the statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.

NOTE 8 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through February 3, 2024, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
