Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cleland Site Prep, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

1. Description of the Plan

The following description of the Cleland Site Prep, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan and was originally adopted by Cleland Site Prep, Inc.(the Company) effective October 1, 2017, and with the latest restatement on January 1, 2021, to provide deferred tax benefits to eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

The Plan covers all active employees of the Company that are at least 18 years of age. There is no service requirement and participants become eligible to participate immediately upon employment.

Contributions

Each year participants may contribute employee deferral contributions up to the dollar limitation set forth in Section 402(g) of the Internal Revenue Code (IRC) in effect at the beginning of the Plan year. Participants who have attained age 50, before the close of the Plan year, are allowed to make catch-up contributions up to the maximum allowed by the IRC. Contributions to the Plan are made voluntarily by participating employees who elect salary reduction, which is remitted to the Plan by the Company on behalf of the participants. The Company may elect to contribute to the Plan in the form of matching contributions and profit-sharing contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company funds an employer safe harbor matching contribution of 100% of the first 4% of participant contributions. Additionally, discretionary profit-sharing contributions may be made at the option of the plan sponsor. There were no profit-sharing contributions made in 2022.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, participant's earnings (losses) and is charged with an allocation of administrative expenses. Allocations are based on participant account balances, deferrals, or compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All contributions made to these accounts are directed by the participant into a particular investment offered by the Plan and the allocations between investments can be changed.

Notes Receivable from Participants

Participants' loans are not permitted by the Plan.

Vesting

Participants are immediately 100% vested in their employee deferral contributions and employer safe harbor matching contributions, plus actual earnings thereon. Participants become 100% vested in Company discretionary profit-sharing contributions, if any, after attaining three years of credited service with the Company.

1. Description of the Plan (cont.)

Payment of Benefits

The distribution to which a participant is entitled is the total that can be provided from the vested portion of the participant's account. Upon retirement, termination, disability, or death, the participant or beneficiary may elect to receive payment in the form of a lump-sum distribution. The normal retirement age is 65 years old. Certain in-service distributions are also allowed. Under certain qualifying circumstances, hardship withdrawals are permitted under the Plan.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan agreement. Certain other administrative expenses of the Plan are paid by the Company. Investment fees are paid by Plan participants and are included in net appreciation (depreciation) in fair value of investments.

Forfeited Accounts

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. Forfeited balances of terminated participant's non-vested accounts are used to offset Company contributions or pay administrative expenses. During 2022 there were no Plan forfeitures, and there was no forfeiture balance at December 31, 2022 or 2021.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Trustee to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's Trustee and those charged with governance of the Plan determine the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies (cont.)

Payment Benefits

Benefit payments to participants are recorded upon distribution.

3. Certified Information

The Plan Trustee has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.) (John Hancock) has provided certifications that the financial information included in the financial statements and supplemental schedule as of December 31, 2022 and 2021, and for the year ended December 31, 2022, provided to the Plan is complete and accurate. The information as to investment assets and transactions therein, and investment income (loss) included in the accompanying financial statements and supplemental schedule as of December 31, 2022 and 2021, and for the year ended December 31, 2022, are covered by such certifications.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022 and 2021.

Pooled Separate Accounts - The fair value of the pooled separate accounts is based on the net asset value (NAV) of each account calculated by John Hancock and is based on the NAV of the underlying investments. The NAV is used as a practical expedient to estimate fair value.

The Plan's investments at fair value as of December 31, 2022 and 2021 were made up entirely of pooled separate accounts, which are measured at the NAV as a practical expedient. In accordance with Subtopic 820-10, certain investments that were measured as such are not classified in the fair value hierarchy. The Plan has no assets at December 31, 2022 and 2021 that are classified in the fair value hierarchy.

Basis of Fair Value Measurement (cont.)

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is based on a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Spectrum Financial Services Corporation. The IRS has opined and informed Spectrum Financial Services Corporation by letter dated June 30, 2020, that the pre-approved plan is designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Parties and Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company and certain others. The custody and recordkeeping functions of the underlying investments held by the Plan are performed by John Hancock. Usual and customary fees were paid to John Hancock for those services. No officer or employee receives compensation from the Plan. Some administrative expenses are paid directly by the Company. These transactions, as defined by the Plan, qualify as party-in-interest transactions. Such transactions are exempt from prohibited transactions rules.

7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their Company contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

9. SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required optional elements, the Plan administrator will determine the option provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2022 financial statements.

11. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, January 16, 2024, and has determined that no significant events occurred after December 31, 2022, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
