## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee

### **PSC Metals 401(k) Plan**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the June 31, 2022 and December 31, 2021 Financial Statements**

We have performed an audit of the accompanying financial statements of PSC Metals 401(k) Plan an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits for the period ended June 1, 2022 and the years ended December 31, 2021 and 2020, and the related statements of changes in net assets available for benefits for the period of January 1, 2022 through June 1, 2022 and year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PSC Metals 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution for the period of January 1, 2022 through June 1, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion on the June 1, 2022 and December 31, 2021 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the June 1, 2022 and December 31, 2021 Financial Statements section:

- the amounts and disclosures in the June 1, 2022 and December 31, 2021 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the June 1, 2022 and December 31, 2021 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the June 1, 2022 and December 31, 2021 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of PSC Metals 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the June 1, 2022 and December 31, 2021 Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about PSC Metals 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the June 1, 2022 and December 31, 2021 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the June 1, 2022 Financial Statement section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the June 1, 2022 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **June 1, 2022 Supplemental Schedules Required by ERISA**

The supplemental schedules of assets held as of June 1, 2022, is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



Their report dated October 5, 2021, indicated that (a) because of the significance of the information that they did not audit, they were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, they did not express an opinion on the financial statements and supplemental schedules, and (b) the form and content of the information included in the financial statements and supplemental schedules other than that derived from the certified information, were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. PLAN DESCRIPTION**

The following description of the PSC Metals 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Merger

In April of 2022, the Plan was amended and all employees became 100% vested in all employer contributions coincident with the merger of the Plan with the new employer SA Recycling effective May 1, 2022. The Plan was frozen effective April 30, 2022 and all assets of the Plan were transferred to the SA Recycling, LLC 401(k) Profit Sharing Plan as of June 1, 2022.

General & eligibility

The Plan is a defined contribution plan available to all full-time employees of PSC Metals, LLC (the “Company”). Employees can enroll in the Plan in the month following the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). T. Rowe Price Trust Company (“T. Rowe Price”) serves as both the trustee and custodian.

Contributions

Non-highly compensated participants can elect to contribute between 1% and 50% of eligible earnings, as defined in the Plan. Highly compensated participants can elect to contribute between 1% and 6% of eligible earnings, as defined in the Plan. Participants may also elect to classify all or a portion of their elective deferral as a Roth elective deferral. Participants over age 50 may also make catch-up contributions as allowed by law. Participating employees can elect to have their contributions invested in various funds permitted under the existing contract with T. Rowe Price in any proportion, which equals 100%. The Company calculates and deducts employee contributions from gross earnings each pay period based on the percent or dollar amount elected by the employee. Employees may change their contribution election monthly and transfer between investment options on a daily basis. Employees may suspend their contributions on a date with written notice online with T. Rowe Price. Participants may also contribute amounts representing distributions from other qualified plans, commonly referred to as rollover contributions.

Employees become eligible to receive Company matching contributions one year after they are eligible to join the Plan. The Company determines the matching percentage each Plan year. During the period of January 1, 2022 through June 1, 2022 and year ended December 31, 2021, the Company matched 50% of employee contributions, up to a maximum matching contribution of \$3,000, per calendar year. Company and employee contributions are subject to certain limitations under the Internal Revenue Code (“IRC”).

Participant accounts

A separate account is established for each participant. The account is credited or charged, as applicable, with the participant's contributions, an allocation of the Company's contributions, the participant's share of investment earnings and losses, the participant's distributions and certain administrative charges. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100% vested in the Company's matching contributions plus actual earnings thereon after two years of continuous service.

Forfeitures

Any forfeited non-vested Company contributions may be used to offset future Company contributions or pay administrative expenses. During the period of January 1, 2022 through June 1, 2022 and the year ended December 31, 2021, \$17,582 and \$0 forfeitures were used to offset Company contributions, respectively. During the period of January 1, 2022 through June 1, 2022 and the year ended December 31, 2021, \$0 and \$2,280 of forfeitures were used to pay administrative expenses, respectively. There were \$0, \$17,615 and \$3,654 of available forfeitures at June 1, 2022, December 31, 2021 and December 31, 2020, respectively.

Payment of benefits

Upon termination of service due to death, disability or normal retirement (at age 65 or greater), a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or a life annuity. If the vested amount in the participant's accounts is less than \$5,000, then a lump-sum payment will be made.

For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution or "rollover" the amount to another qualified plan. Withdrawals while an active employee of the Company, including financial hardship withdrawals, are also permitted in certain circumstances, without penalty, as defined in the Plan and in accordance with the IRC.

**1. THE PLAN (CONTINUED)**

Notes receivable from participants

Employees who have been participating in the Plan for more than two years are allowed to borrow from their accounts, a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance in the previous 12 months or 50% of their vested account balances. Loan terms range from one to five years, or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with local prevailing interest rates as determined by the Company at the time the loan is made. Principal and interest are paid by the employee ratably through weekly payroll deductions or direct monthly payments. As also discussed above, the Plan was merged into another Plan in June of 2022 and there were no outstanding balances as of that date. As of December 31, 2021 and 2020, interest rates on outstanding loans ranged from 3.25% to 5.50%.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Notes receivable from participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed when they are incurred. No allowance for credit losses has been recorded for the period ended June 1, 2022 or the years ended December 31, 2021 and 2020. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Effective July 2020, the Plan adopted certain Coronavirus Aid, Relief, and Economic Security (“CARES”) Act provisions for eligible participants. Coronavirus-related distributions (“CRD”) will be allowed up to \$100,000 through December 31, 2020 and the maximum loan request has been increased to \$100,000 for loans made through September 22, 2020. The Plan also adopted the CARES Act repayment provision which allows individuals to repay all or part of the amount distributed as a CRD. The plan will treat CRD repayments as direct rollover contributions and will accept these payments for up to three years after the date the CRD was received.

Operating expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through January 12, 2024 the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the period ended June 1, 2022 and the years ended December 31, 2021 and 2020.

*Mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**3. FAIR VALUE MEASUREMENTS (CONTINUED)**

*Collective trust fund* - A stable value fund valued at the NAV of units of the collective trust. The NAV is calculated by the fund based on net assets, which includes fully benefit-responsive investment contracts at contract value. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund and is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with industry practices, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. STABLE VALUE FUND**

The Plan's investments include an investment in the T. Rowe Price Stable Value Fund (the "Fund"), a collective trust fund that is considered to be a stable value fund with underlying investments in fully benefit-responsive investment contracts. Fair value of the stable value fund is the NAV of the fund. The NAV is based on net assets, which includes the fully benefit-responsive investment contracts at contract value. The Fund is an open end commingled pool dedicated exclusively to the management of assets of defined contribution plans. The Fund's investment objective is to maximize current income consistent with the maintenance of principal and to provide for withdrawals for certain participant-initiated transactions under a retirement plan without penalty or adjustment. To achieve its investment objective, the Fund invests in underlying assets (typically fixed income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements) and enters into a "wrapper" contract issued by a third party. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Withdrawals for benefit payments and participant transfers to noncompeting investment options to be paid to plan participants shall be made 30 days after written notification has been received. Withdrawals, other than for benefit payments and participant transfers to noncompeting investment options may be made up to one year after notification is received. For the period ended June 1, 2022 and the years ended December 31, 2021 and 2020, there were no other restrictions or unfunded commitments.

Certain events can limit the ability of the Plan to transact at contract value with the Fund, and the Fund itself may be subject to circumstances that affect its ability to transact at contract value. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

**5. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price, the Plan's trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits for the period ended June 1, 2022 and the years ended December 31, 2021 and 2020;
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period of January 1, 2022 through June 1, 2022 and the year ended December 31, 2021; and

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**6. TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain Plan investments are held and managed by T. Rowe Price. T. Rowe Price serves as the trustee for the Plan. Therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

**7. PLAN TERMINATION**

The Plan was terminated on June 1, 2022 in accordance with the provisions of ERISA.

**8. TAX STATUS**

The Internal Revenue Service ("IRS") has issued an opinion letter dated March 31, 2014 stating that the form of the volume submitter plan used by the Plan is acceptable under section 401 of the IRC. Although the Plan has been amended since the opinion letter was issued, the Plan administrator believes the Plan is being operated in compliance with the applicable IRC and, therefore believes the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of the period ended June 1, 2022 and the years ended December 31, 2021 and 2020, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. FINANCIAL STATEMENT DIFFERENCES FROM FORM 5500**

The net assets available for benefits as of and for the period ended June 1, 2022 and the years ended December 31, 2021 and 2020, vary from the Plan's Form 5500 in the amount of \$0, \$46,665 and \$0, respectively, in connection with employer and employee contributions accrued on the financial statements for the period ended June 1, 2022 and the years ended December 31, 2021 and 2020, but not on the Form 5500.

**10. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
