## **INDEPENDENT AUDITOR'S REPORT**

To the Retirement Committee of  
King's Daughters Medical Center  
Matching Contribution Plan

### **Opinion**

We have audited the accompanying financial statements of King's Daughters Medical Center Matching Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2022 and 2021, and the changes in its net assets available for benefits for the year ended December 31, 2022, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2022 AND 2021

### (1) DESCRIPTION OF PLAN

The following description of the King's Daughters Medical Center (KDMC) Matching Contribution Plan (the "Plan") provides only general information. The participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, established under Section 403(b) of the Internal Revenue Code and subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all non-union employees of KDMC hired after January 1, 1993 and certain non-union employees of KDMC who elected not to be a member of the King's Daughters Medical Center Retirement Plan (the "Defined Benefit Plan") as of January 1, 1993 or any subsequent January 1. Additionally, due to the freeze of the Defined Benefit Plan in 2011, non-union employees who previously participated in the Defined Benefit Plan became eligible to participate on January 1, 2011 and union employees became eligible to participate on April 9, 2011.

During 2012, KDMC initiated a legal restructuring in which King's Daughters Health System, Inc. was formed to become the new parent company. As a result, KDMC became a subsidiary of King's Daughters Health System, Inc. with King's Daughters Medical Center Ohio, Kentucky Heart and Vascular Physicians (KHVP), King's Daughters Medical Specialties (KDMS), King's Daughters Integration Practices (KDIP), Child Development Center (CDC) and Kingsbrook Nursing Home (KBNH), who also participate in the Plan, as subsidiaries of KDMC.

In April 2021, KDHS entered into a joint venture agreement with Beyond Blue Corporation, an affiliate of the University of Kentucky to form Royal Blue Health, LLC (RBH) with KDHS retaining 60% ownership of RBH. At that time, KDHS transferred all ownership of KDMC and related subsidiaries to RBH. Then, effective December 1, 2022, KDHS transferred 100% of its ownership of RBH to Beyond Blue Corporation (BBC), whereby BBC became the sole member of RBH. As a result, KDMC and related subsidiaries, are considered affiliates of the University of Kentucky.

#### Contributions

Each year, participants may contribute up to the maximum allowable contribution, as defined in Federal legislation. The employer may elect to contribute a matching contribution of up to 100% of the first 3% of eligible employee contributions. To be eligible for a matching contribution, an employee must be twenty-one years of age or older, not classified as a PRN employee, and not be an employee of CDC or KBNH. Additionally, a participant must generally be actively employed on the last day of the Plan year to receive an employer contribution. For the year ending December 31, 2022, the employer elected to match 50% of participant contributions up to 3% of compensation, plus 50% of any catch-up contribution.

Participants may rollover amounts from other eligible retirement plans to the Plan. The amounts transferred shall be allocated to the participant's rollover contribution account. Such amounts and any earnings or losses shall be fully vested at all times.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's contribution and (b) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in both, the voluntary contributions and the employer match contribution plus actual earnings thereon.

### Notes Receivable from Participants

The Plan allows for participants to borrow from their account. The maximum loan amount cannot exceed 50% of the participant's vested interest in his or her account, or \$50,000. The loan interest rate, determined quarterly, is set at 1 percent above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

### Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options available to the Plan as advised by Empower Annuity Insurance Company of America. Participants may change their investment options at their discretion.

### Payment of Benefits

On termination of service, the participant receives a lump-sum amount equal to the vested value of his or her account.

If a participant terminates employment for any reason and at any age (including retirement), and the value of the participant's vested benefit does not exceed \$5,000, including any rollover contributions, then a distribution will automatically be paid to the participant. Any distribution under this provision will be paid in a lump-sum within a year after the participant terminates employment.

## **(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared using U.S. generally accepted accounting principles and the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. At December 31, 2022 and 2021, the Plan held no contracts that are considered fully benefit-responsive.

### Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (3) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. Delinquent participant loans are recorded as distributions based on the terms of the Plan document. Loans totaling \$5,495 were defaulted during the year ending December 31, 2022, due to employee terminations.

### Payments of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses incurred maintaining the Plan are paid directly by the KDMC and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

### Subsequent Events

Subsequent events have been evaluated through October 13, 2023, which is the date the financial statements were available to be issued.

## **(3) FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: a) quoted prices for similar assets or liabilities in active markets, b) quoted prices for identical or similar assets or liabilities in inactive markets, c) inputs other than quoted prices that are observable for the asset or liability, d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts:* Consists of mutual funds that are valued on the basis of readily determinable market prices and a money market sweep account.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

#### **(4) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

As of December 31, 2022, Empower Annuity Insurance Company of America, formerly Massachusetts Mutual Life Insurance Company ("Empower") is the recordkeeper for the Plan and, therefore, transactions with Empower qualify as party-in-interest transactions. Fees paid by the Plan to Empower totaled \$443,767 for the year ended December 31, 2022.

Highland Associates, Inc. provides investment advisory services to the Plan. Fees paid by the Plan to Highland Consulting totaled \$63,092 for the year ended December 31, 2022.

Certain employees and officers of KDMC, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

#### **(5) PLAN TERMINATION**

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **(6) TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator and the plan's tax counsel believe that terms of the Plan have been prepared to conform with the written plan requirements of Regulation 1.403(b)-3 of the Code. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

#### **(7) RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The University of Kentucky (“UK” or “University”) is an independent body politic within the Executive Branch of the Commonwealth of Kentucky. As such, it is a political subdivision subject to the United States and Kentucky Constitutions as well as the Kentucky statutes relating to public entities. A Board of Trustees governs the University, pursuant to Kentucky Revised Statutes 164.101(1)(a), which consists of twenty (20) members. The Governor of the Commonwealth appoints sixteen (16) of those members with the confirmation of the state Senate. The remaining four (4) are elected by the University’s faculty, non-faculty staff and student body. The treasury of the Commonwealth supports the University and its wholly owned corporations. The University has sovereign, or governmental, immunity from lawsuits in federal courts, the courts of the Commonwealth of Kentucky, and the courts of other states. Wholly owned corporations, which exist to solely serve the University, are alter egos of the University. Consequently, UK’s wholly owned corporations are subject to the same constitutional and statutory limitations as UK itself.

In 2013, UK created a wholly owned corporation, Beyond Blue, to coordinate the University’s health care activities outside of its main campus. In 2021, Beyond Blue entered into a transaction with King’s Daughters Health System, by which a new corporation, Royal Blue Health (“RBH”) was created. Ownership of RBH, and all of its wholly owned subsidiaries, including Ashland Hospital Corporation (“AHC”) was split with King’s Daughters Health System having a 60% ownership share and Beyond Blue having a 40% ownership interest. The relationship between UK and RBH/AHC was created to support the functions of the University and to create new opportunities to serve patients from the greater Ashland/Tri-State community that reaches across northern and eastern Kentucky, southern Ohio and western West Virginia.

The agreement for that transaction provided Beyond Blue a membership substitution option after October 1, 2022, if certain financial metrics were met. On October 27, 2022, the Board of Trustees of the University of Kentucky authorized and approved the acquisition of RBH and all of its wholly owned subsidiaries, including AHC. In addition to directing Beyond Blue to take the necessary steps to exercise the membership substitution option, the Board of Trustees designated RBH as an affiliated corporation of the University of Kentucky and appointed a new Board of Governors for RBH. Accordingly, UK now has 100% stake in RBH, including AHC. RBH is administered by individuals who are responsible to public officials (i.e., the University Board of Trustees). Thus, effective December 1, 2022, RBH (and AHC), became an alter ego of the University of Kentucky and a political subdivision. As a result, King’s Daughters Health System and related subsidiaries, are considered wholly owned subsidiaries of the University of Kentucky and, therefore, its employee benefit plans are no longer subject to ERISA
