I sold my practice (business) for which I had a 401 (K) Profit Sharing Plan & Trust in April, 2022. I terminated the plan through Paychex at that time and the funds were distributed to the participants. In past years Paychex would notify me when Form 5500-SF for the prior year was due. They provided a link to review the form which they had completed. I would then sign it and submit it to the DOL. They failed to notify me of when the form/return for that final year was due. I recently received a letter from Albert Scott with the DOL Ref No. 24-12363W, indicating I had not submitted a final filing. I have attached this letter to the 2022 form which I am now filing. I am asking for forgiveness of any penalties for failing to file until now for reasonable cause. Thank you so much for your consideration.
