Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Eagle Granite 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation available for benefits as of May 31, 2023 and December 31, 2022, the related statement of changes in net assets in liquidation available for benefits for the period ended May 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2023 and 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended May 31, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of a Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, Eagle Granite, the Plan's sponsor, voted on February 7, 2023 to terminate the Plan, effective February 20, 2023 and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2021 and prior financial statements to the liquidation basis used in presenting the 2023 and 2022 financial statements. All assets were liquidated from the Plan by May 31, 2023. Our opinion is not modified in respect to this matter.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Eagle Granite 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Eagle Granite Company, Inc. and its affiliates (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Eligible employees include all regular employees of the Company over the age of 21, who are not covered under a collective bargaining agreement and who are not a non-resident alien. Employees are eligible to participate in the Plan on the first day of the Plan year and the first day of the seventh month of the Plan year subsequent to completing one year of service or 1,000 hours.

Contributions

Each year, participants may contribute up to 100% of pretax or post tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, a stable value collective trust fund, and a money market mutual fund as investment options.

The Plan is a safe harbor 401(k) Plan, which requires the Company to make safe harbor matching contributions. The Company, as required by the Plan, made safe harbor matching contributions equal to 100% of each participant's elective deferral up to and not exceeding 4% of base compensation that a participant contributes to the Plan. Additional matching contributions may also be contributed at the discretion of the Company. During the year ended December 31, 2023, the Company made safe harbor matching contributions of \$32,650 to the Plan. The Company did not make any discretionary additional matching contributions for the period ended May 31, 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, and allocations of (a) the Company's discretionary additional matching contributions, (b) plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary additional matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service.

Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months.

As a result of the plan termination effective February 20, 2023, all participants became fully vested in their account balances on February 20, 2023.

Termination of the Plan

Effective February 20, 2023, the Company elected to terminate the Plan. The Plan has wound down plan operations and all balances were disbursed by May 31, 2023. As part of the liquidation process, the Plan sent out distribution request forms to participants in the first quarter of 2023. Participants were able to elect how they wish to receive their distributions (i.e. rollovers options or cash distributions). See Note 2 Summary of Significant Accounting Policies for more information.

Payment of Benefits

Prior to the Plan terminating, on termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments if the participant was subject to lifetime required minimum distributions payable monthly, quarterly or annually. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account were permitted if certain criteria were met. The Plan also allowed for in-service distributions upon attaining age 59 ½.

Effective January 1, 2020, the new IRS hardship distribution regulations were implemented to allow participants to have access to earnings on the deferral portion of their account, to include federal disasters as a hardship category, to eliminate the suspension period subsequent to receiving a hardship distribution, and to eliminate the requirement to exhaust plan loans.

Forfeitures

At May 31, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$563, respectively. These accounts were used to reduce Company safe harbor matching contributions, Company discretionary additional matching, contributions, or to pay administrative expenses of the Plan in accordance with the plan document. During the period ended May 31, 2023, all forfeited nonvested amounts were exhausted.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Upon termination of the Plan, management determined that liquidation of the Plan is imminent and the financial statements for 2023 and 2022 have been prepared using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are measured at the expected cash proceeds from liquidation and liabilities are measured in accordance with accounting principles generally accepted in the United States that otherwise apply to those liabilities.

Reclassifications

Certain prior year balances have been reclassified to conform with current year presentation. There was no impact on net assets available for benefits or net decrease from the reclassifications.

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with Generally Accepted Accounting Principles (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

All investments on the 2023 and 2022 statement of net assets in liquidation available for benefits are reported at liquidation value which approximates fair value. For all investments, fair value approximates the amount the Plan expects to collect at liquidation.

Investment Valuation and Income Recognition, continued

All investments on the 2023 and 2022 statement of net assets available for benefits are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date (assuming single-year statement of changes).

Purchases and sales of securities are recorded on a settlement-date basis. Interest income and dividends are recorded on the liquidation basis for 2023 and 2022. The liquidation basis includes amounts expected to be earned through the final distribution of Plan assets. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through February 8, 2024, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2023:

Stable value collective trust fund: A stable value fund that is valued at the net asset value (NAV) of units of the collective trust as provided to the plan administrator by the trustee of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities' liquidations will be carried out in an orderly business matter.

Mutual funds and money market mutual fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Certain Plan investments were managed by American Funds, collectively with Capital Bank, the Capital Group. Capital Group was the custodian and corporate trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Direct fees incurred and paid by the Plan for various services were \$357 for the period ended May 31, 2023. Raymond James provided certain investment management services to the Plan. The fees paid to Raymond James (which qualify as party-in-interest transactions) amounted to \$8,983 for the period ended May 31, 2023.

NOTE 6. SUBSEQUENT EVENTS

The Company has evaluated subsequent events through the date of the audit report, which represents the day the financial statements were available to be issued. Subsequent events have not been evaluated beyond this date.

NOTE 7. TAX STATUS

The Company adopted a nonstandard preapproved profit sharing/money purchase/CODA document with an IRS notification letter which states the preapproved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter, which is dated June 30, 2020; however, the plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

FASB ASC requires the plan administrator to annually evaluate the Plan's tax positions, including accounting and measurement of uncertain tax positions. For the period ended May 31, 2023, the plan administrator concluded that no uncertain tax positions had been taken that would require adjustment to or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by federal, state, or local tax authorities for years before 2020.
