This is a summary of the Form 5500-SF Annual Return/Report of Small Employee Benefit Plan for the J. WHITE RESTAURANT ENTERPRISES 401(K) PLAN, EIN 47-1955085, Plan 001, for period January 1, 2023 through June 30, 2023. The Form 5500-SF annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, age/service weighted or new comparability, profit-sharing, ERISA section 404(c), total participant-directed account, Code section 401(k), Code section 401(m), default investment account, pre-approved, single employer type of plan.

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. A total of 0 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of June 30, 2023, compared to \$897,702 as of January 1, 2023. During the plan year, the plan experienced a decrease in its net assets of (\$897,702). This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$108,794, including employer contributions of \$25,301, employee contributions of \$29,396 and earnings from investments of \$54,097.
