### Notes to Financial Statements

#### NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Landrum & Brown 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to their Landrum & Brown 401(k) and Profit Sharing Plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan. All full time employees of Landrum & Brown, Incorporated (the "Company") are currently eligible for participation in the Plan if they have attained the age of 21. Eligibility for employer contributions requires the participant to have earned 1,000 hours of service during the Plan year and have attained the age of 21. Eligible employees are automatically enrolled at 10 percent unless the employee affirmatively elects otherwise. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

##### ***Contributions***

As noted in note 6, effective January 1, 2023, the Plan was terminated and the Plan was deemed a frozen plan. Accordingly, no contributions were made in 2023. Prior to 2023, participants could contribute up to 75% of pretax annual compensation, as defined in the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code ("IRC") of 1986 as amended. Additionally, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. Participants who do not complete a salary deferral agreement on or after 30 days notice of eligibility will have 10 percent of their compensation automatically withheld. The plan also includes an auto-escalation feature, whereby auto-enrolled participants' contribution percentage increases by 1 percent at the beginning of the plan year until a maximum deferral percentage of 15 percent is reached. In 2022, the Company made discretionary matching contributions of 25% of each participant's elective deferrals, up to a maximum of 10% of eligible annual compensation subject to certain limits required by the IRC. There were no discretionary profit sharing contributions in 2022.

##### ***Rollover Contributions***

Participants are eligible to roll over their taxable portion of funds previously held for their account in another qualified retirement plan to the Plan on a tax-free basis. Rollovers on a post-tax or "Roth" basis are not permitted by the Plan.

##### ***Participant Accounts***

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings and expenses. The pro-rata allocation is based upon each participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements (Continued)

### NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

#### ***Investments***

Participants direct the investment of their contributions into various investment options offered by the Plan. The Company matching and discretionary profit sharing contributions are invested as directed by the participants. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. The Plan currently offers twenty-eight mutual funds, two common/collective funds and self-directed investing.

#### ***Vesting***

Participants become immediately vested at the time of participation in the Plan in their contributions and the discretionary matching contribution plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts, plus actual earnings thereon is based on years of continuous service. Participants become partially vested after two years of service and 100 percent vested after six years of credited service.

#### ***Forfeitures***

As of May 1, 2023 and December 31, 2022, the balance of unallocated forfeited non-vested accounts totaled \$0 and \$29, respectively. Forfeited balances of terminated participants' non-vested accounts are first used to pay Plan administrative expenses and reduce employer contributions and then allocated to active participants. During 2023, there were no forfeitures used to reduce employer contributions.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance. The vested account balance is reduced by the highest note receivable balance in the participant's account during the prior twelve month period for the calculation of the maximum note receivable allowed. The notes receivable are secured by the vested balance in the participant's account. All notes receivable shall bear a reasonable rate of interest as determined by the Plan administrator. For participants employed by the Company, principal and interest is paid ratably through payroll deductions. Upon termination of employment for any reason, the participant may remit the outstanding balance of the note receivable within 90 days provided such repayment is made before the participant requests a distribution. A participant may have up to three notes receivable outstanding at any given time.

#### ***Payment of Benefits***

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed in a lump sum.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested benefit in a lump-sum payment.

In conditions of "financial hardship" a participant may apply to the Plan administrator for approval to withdraw that portion of his 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the IRC.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

#### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### *Administrative Expenses*

Certain expenses and costs of the Plan were paid by Landrum & Brown, Incorporated (the Plan sponsor) and accordingly, are not reflected in the Plan's financial statements.

##### *Basis of Presentation*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Investment Valuation*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

##### *Related-Party Transactions*

Certain Plan investments are investment contracts managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the asset custodian and trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

##### *Estimates*

The preparation of financial statements in conformity with U.S. generally accepted accounting principles ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Benefit Payments*

Benefit payments are recorded upon distribution.

##### *Subsequent Events*

The Company has evaluated all events subsequent to the balance sheet date of May 1, 2023, through December 29, 2023, which is the date these financial statements were available to be issued.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at May 1, 2023 and December 31, 2022.

*Common stock:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year end.

*Self-directed investments:* Valued at the closing price reported on the active market on which the individual securities within the self-direct investment accounts are traded.

#### NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

*Interest in common/collective trusts:* Values based on the NAV of units of a collective trust as published by the trustee.

Common collective trusts are investment funds formed by the pooling of investments by institutional investors, such as a group of not necessarily affiliated pension or retirement plans, typically with the intention of achieving cost savings over similar investment options such as mutual funds. Common collective trusts are similar to mutual funds, with a named investment manager and documented investment objective. These investments, however, are not registered with the SEC (unlike mutual funds, which are registered) and participation is not open to the public. The NAV is measured by the custodian or investment manager as of the close of regular daily trading. These investments are classified within Level 2 of the fair value hierarchy. When measuring the fair value of such funds, the NAV, as provided by the fund sponsor, is corroborated with observable inputs provided by pricing services for the securities. In certain instances, NAVs may require adjustments to more appropriately reflect the fair value. No adjustments to NAVs were required.

The existence of certain conditions can limit the trust's ability of the Plan to transact with participants at fair value of the common collective trust. Specifically, any event outside the normal operation of the trust which causes a withdrawal from an investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to:

- The plan's failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code.
- The establishment of a defined contribution plan that competes with the plan for employee contributions.
- Any substantive modification of the Portfolio or the administration of the Portfolio that is not consented to by the wrap issuer.
- Any change in law, regulation or administrative ruling applicable to the plan that could have a material adverse effect on the Portfolio's cash flow.
- Any communication given to unitholders by the plan sponsor, any other plan fiduciary or FMTC that is designed to induce or influence unitholders not to invest in the Portfolio or to transfer assets out of the Portfolio.
- Any transfer of assets from the Portfolio directly to a competing investment option.

As of May 1, 2023, the occurrence of an event outside the normal operation of the fund which would cause a withdrawal from an investment contract is not considered to be probable.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Plan management considered liquidation of the Plan to be imminent upon the decision to terminate the Plan. All participant accounts became 100% vested as of the decision to terminate the plan. In 2023, assets were transferred to another qualified plan.
