Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the REV Energy Services, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (in Liquidation) as of August 16, 2023 (Liquidation Date) and December 31, 2022, and the related statement of changes in net assets available for benefits (in Liquidation) for the period from January 1, 2023 through August 16, 2023 (Liquidation Date), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of August 16, 2023 (Liquidation Date) and December 31, 2022, and for the period from January 1, 2023 through August 16, 2023 (Liquidation Date), stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As described in Note 1 to the financial statements, the Plan Sponsor resolved to terminate the Plan effective December 29, 2022. As a result, the Plan's financial statements have been presented on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Note 1 – Description of the Plan

The REV Energy Services, LLC 401(k) Plan (the "Plan") was established January 1, 2018. The following is a brief general description of the Plan. Participants and all others should refer to the Plan document for a complete description of the Plan's provisions.

General. The Plan was a defined contribution plan that was established by REV Energy Services, LLC (the "Company," "Employer," "Plan Sponsor," or "Plan Administrator") under the provisions of 401(a) of the Internal Revenue Code ("IRC"). The Plan was generally available to all the employees of the Company. In order to be eligible to participate in the Plan employees were required to attain age 18 and complete three months of service. Employees were able to enter the Plan on the first of the month coincident with or after meeting the Plan's eligibility requirements. The Plan excluded union employees, certain non-resident aliens, and leased employees. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan were not guaranteed by the Pension Benefit Guaranty Corporation.

Plan Termination. Effective December 29, 2022, the Plan Sponsor resolved to terminate the Plan. In connection with the Plan's termination the following occurred:

- The Plan was frozen. No new participants will enter the Plan and there will be no more participant or Employer contributions to the Plan.
- The Plan's termination created a distributable event for all the Plan's participants. Final distributions commenced and the Plan was fully liquidated on August 16, 2023.
- All participants became 100% vested in their accounts effective December 29, 2022.
- The Plan was amended to ensure document compliance with the most recent statutory or regulatory changes.

Plan Amendment. On March 28, 2023, the Plan was amended in accordance with the SECURE 2.0 Act of 2022. Such amendment was generally effective January 1, 2023.

Contributions. Prior to December 29, 2022, the following types of contributions were allowed under the Plan:

- Salary Deferral Contributions – Participants had the option to contribute a percentage of their pre-tax compensation, as defined in the Plan document, subject to limitations. Additionally, participants had the option to contribute a percentage of their after-tax compensation and designate it as a Roth deferral contribution. The Plan had a qualified automatic contribution arrangement ("QACA"). Unless an eligible employee made an affirmative election otherwise, such employee was automatically enrolled into the Plan at a 3% pre-tax salary deferral contribution percentage rate. Such rate would increase annually by 1% until a 6% elective pre-tax deferral contribution percentage was reached. Participants who were auto-enrolled under the QACA had the option to elect a permissible withdrawal within 90 days of their first automatic deferral. A participant's total salary deferral contribution could not exceed \$20,500 (\$27,000 if age 50 or older) in 2022.

- Employer Safe Harbor Matching Contributions - The Employer made an Employer Safe Harbor matching contribution each payroll period equal to 100% of a participant's deferral contributions up to 1% of a participant's eligible compensation, plus 50% of a participant's deferral contributions between 1% and 6% of a participant's eligible compensation.
- Rollover Contributions - Amounts distributed to participants from other qualified employee benefit plans were allowed to be rolled into the Plan.

All contributions were allocated to the Plan's investment funds at the direction of the participants.

The total annual additions to a participant's account may not exceed the lesser of \$61,000 in calendar year 2022, or 100% of the participant's compensation, as defined.

Participant Accounts. Each participant's account was credited with the participant's contributions (salary deferral and rollovers, if any) and an allocation of (a) the Employer's safe harbor matching contributions, (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Vesting. Effective December 29, 2022, participants became 100% vested in their accounts. Prior to December 29, 2022, participants were vested immediately in their salary deferral contributions, rollover contributions, and related earnings thereon. Vesting in Employer safe harbor matching contributions occurred according to the following schedule:

Furthermore, employed participants became 100% vested in their Employer matching contribution portion of their accounts upon the following events:

- Participant's death;
- Participant becomes disabled as defined under the Plan;
- Participant attains normal retirement age; or
- Termination or partial termination of the Plan.

Forfeitures. When certain terminations of participation in the Plan occurred, the non-vested portion represents a forfeiture. Forfeitures were used to pay administrative expenses of the Plan or were used to reduce Employer contributions. During the period from January 1, 2023 through August 16, 2023 (Liquidation Date), forfeitures of \$6,625 were used to pay administrative expenses of the Plan and forfeitures of \$305 were used to reduce Employer contributions. As of August 16, 2023 (Liquidation Date) and December 31, 2022, unutilized forfeitures totaled \$0 and \$6,906, respectively.

Investments. Participants had the option to direct their investments into various mutual funds and a money market account.

Notes Receivable from Participants. Participants had the option to borrow from their fund accounts a minimum of \$1,000. The maximum loan was the lesser of (i) \$50,000 minus the highest loan balance in the previous 12-month period, or (ii) 50% of their vested account balance. Loan terms ranged up to a maximum of five years (a longer term was available if used for the purchase of a principal residence). The loans were secured by the balance in the participant's account and bore a rate of interest equal to the Prime Rate plus 2% at the date the loan was granted. Principal and interest payments were paid ratably through payroll deductions.

Payment of Benefits. Benefits to participants or beneficiaries generally were payable as a lump sum equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. Participants also had the option to rollover their account balance into another qualified retirement plan or Individual Retirement Account. Additionally, the Plan provided for in-service distributions of a participant's rollover contributions account, upon attainment of age 59½, for a qualified reservist distribution, and in the event of a financial hardship, as defined, if certain criteria were met.

Note 2 – Summary of Significant Accounting Policies

Liquidation Basis of Accounting. As further discussed in Note 1, the Plan was terminated effective December 29, 2022 and Plan management determined liquidation was imminent. As a result, the accompanying financial statements have been prepared on a liquidation basis of accounting.

Use of Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 16, 2023 (Liquidation Date) and December 31, 2022. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Administrative expenses paid by the Plan also include fees paid for investment management, administration, consulting, distribution, and other fees. Certain investment related expenses are included in net appreciation in fair value of investments.

Benefit Payments. Benefits are recorded when paid.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at August 16, 2023 (Liquidation Date) and December 31, 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.
- Money market accounts are valued at amortized cost.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Tax Status

The Plan sponsor has adopted a FIS Business Systems LLC Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan sponsor believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of August 16, 2023 (Liquidation Date) and December 31, 2022. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 16, 2023 (Liquidation Date) and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan assets were mutual funds, a money market account, and a non-interest bearing cash account offered by Schwab. As Charles Schwab Trust Bank is the trustee of the Plan, these transactions qualify as party-in-interest transactions. Additionally, the Plan maintains notes receivable from participants.

The Plan's trustee, Charles Schwab Trust Bank; the Plan's third-party administrator and recordkeeper; the Plan's investment advisor; the Plan's auditors; the Plan's external legal counsel; the Employer; and Plan participants are all parties-in-interest to the Plan. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 7 – Concentrations

As of December 31, 2022, there were two investments which individually represented more than 10% of net assets available for Plan benefits.

Note 8 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through February 8, 2024, which is the date the financial statements were available to be issued.


