- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

For the Period from January 1, 2023 to April 3, 2023

### **1. Description of Plan**

The Big 3 Precision Products, Inc. 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan of Big 3 Precision Products, Inc. (the Company or Plan Sponsor). The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan covers all employees of Big 3 Precision Products, Inc. (a division of The Eastern Company) who have completed 3 months of service and are at least 18 years old. In general, eligible participants may enter the Plan on the first day of the quarter following the date that the age and service requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2022, the Plan was amended and restated to bring the Plan into compliance with the IRS regulatory changes.

Effective April 3, 2023, the Plan was terminated and all assets of the Plan were transferred to other existing plans maintained by The Eastern Company. Participants were notified by Plan management that their account balances were rolled over into the new plans.

#### **Contributions**

The Plan allowed for participants who are at least 18 years of age and have completed 3 consecutive months of employment to make pre-tax and Roth contributions (elective deferral contributions). Participants may contribute any portion of their compensation up to the maximum allowed by the Internal Revenue Code (IRC). The maximum amount of elective deferral contributions that participants under the age of 50 were permitted to contribute was \$22,500 in 2023. The maximum amount participants age 50 or older were able to defer as additional catch-up contributions was \$7,500 in 2023.

The Plan allowed for rollover contributions. The Plan will accept eligible rollover contributions received on behalf of an eligible employee regardless of whether the age and service requirements of the Plan have been met by the eligible employee.

Effective January 1, 2023, the Plan was amended to become a safe harbor 401(k) plan, where the Company agrees to make safe harbor nonelective contributions equal to 3% of employee compensation each year. Participants are 100% vested in these contributions.

Additionally, discretionary employer matching contributions may be made on behalf of Plan participants who made elective deferral contributions during the year who are at least 18 years of age and have completed 3 consecutive months of employment.

### 1. Description of Plan (continued)

#### Contributions (continued)

The Plan Sponsor may also make a discretionary profit-sharing contribution on behalf of eligible Plan participants employed on the last day of the Plan year who have completed at least 1,000 hours of service.

Participants terminated due to death, disability or attainment of normal retirement age were still eligible to receive a profit-sharing contribution during the year regardless of whether any service requirement or last day requirement was met.

In addition to the discretionary employer match, safe harbor contribution and profit-sharing contributions described, the Plan Sponsor may also make additional qualified non-elective contributions to the Plan on behalf of participants.

For the period from January 1, 2023 to April 3, 2023, the Company made discretionary employer matching and safe harbor matching non-elective contributions of \$271 and \$109,081, respectively.

For the period from January 1, 2023 to April 3, 2023, the Company did not make any profit sharing or qualified non-elective contributions to the Plan.

#### Participant Accounts and Forfeitures

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings (losses) and is charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited balances of terminated participants' nonvested accounts are used to reduce administrative expenses and future Company contributions. Such forfeitures and earnings thereon amounted to \$5,015 for the period from January 1, 2023 to April 3, 2023. At April 3, 2023 and December 31, 2022, there were unallocated forfeitures and related earnings thereon of \$0. The Company transferred \$5,015 in unallocated forfeitures out of the Plan in conjunction with the Plan termination effective April 3, 2023.

### 1. Description of Plan (continued)

#### Vesting

Participants were immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after one year of vesting service, 40% vested after two years, 60% vested after three years, 80% vested after four years, and 100% vested after five or more years.

Special vesting rules also apply for particular participant groups. Participants that reach normal or early retirement age, die, or become disabled during employment with the Plan Sponsor will become 100% vested in Company matching and profit-sharing contributions.

#### Investment Options

Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan had offered various mutual funds and a stable value fund as investment options for participants.

#### Payment of Benefits

On termination of employment due to death, disability or retirement, a participant or beneficiary will receive the vested interest of his or her account in the form of either a single lump sum distribution, or in installments. Hardship distributions are also allowed for Plan participants.

#### Plan Termination

Effective April 3, 2023, all assets of the Plan were transferred to other affiliated plans maintained by The Eastern Company. Upon transfer, the Plan was terminated and no further contributions, loan payments, distributions, or new loans were allowed into or out of the Plan.

### 2. Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared using U.S. generally accepted accounting principles.

#### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 2. Significant Accounting Policies (continued)

#### Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. Shares of mutual funds were valued at quoted market prices.

The Plan's investment in the stable value fund is measured using the NAV per share of the investment as a practical expedient as permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures*.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

#### Fair Value Measurements

The Plan follows ASC 820 for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

ASC 820 defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability.

The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity. In addition, the fair value of liabilities should include consideration of non-performance risk including the Plan's own credit risk.

In addition to defining fair value, ASC 820 requires the disclosures around fair value and establishes a fair value hierarchy for valuation inputs. The hierarchy prioritizes the inputs into three levels based on the extent to which inputs used in the measuring fair value are observable in the market. Each fair value measurement is reported in one of three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety.

##### **Fair Value Measurements (continued)**

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

##### **Payments of Benefits**

Benefits are recorded when paid or when authorized to be paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to investment related expenses are included in administrative expenses.

#### **3. Information Prepared and Certified by the Custodian**

All investment information disclosed in the accompanying financial statements, including investments held at April 3, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments for the period from January 1, 2023 to April 3, 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the John Hancock Life Insurance Company (U.S.A.), the Custodian.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 3, 2023 and December 31, 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Assets held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### **5. Income Tax Status**

Effective January 1, 2022, the Plan adopted a prototype plan sponsored by Ascensus LLC. The prototype plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The prototype plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the IRC as of the financial statement dates.

Accounting principles generally accepted in the United States require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

### **6. Party-in-Interest and Related Party Transactions**

Section 3(14) of ERISA defines party-in-interest transactions to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, administrative expenses paid by the Company and transactions with investment funds managed and held by the Custodian are considered related party and party-in-interest transactions.

### **7. Risks and Uncertainties**

The Plan invests in various investment securities, such as mutual funds and a stable value fund. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **8. Subsequent Events**

The Plan has evaluated events occurring between April 3, 2023, and February 8, 2024, the date the financial statements were available to be issued.
