Dear Sirs,

Please accept this explanation to the reason behind late filing of GMB Plastics 5500-SF final report dated 8/17/2022. GMB Plastics was sold to a private investor in September 2021. Paychex Retirement Services was our payroll company hired to administer the companies payroll services and to include the 401k retirement plan. During the transfer and dissolution process of GMB Plastics to new owners, GMB initiated the paperwork with Paychex retirement services for the request for Involuntary Distribution dated 7/7/2022 to proceed with Rollover IRA for plan participants.

I was unaware that the final report 5500-SF was delinquent until receiving an email to my personal email account on January 25, 2024 from Albert Scott@dol.gov. At which time I contacted Paychex for retaining a copy of the 5500-SF final return report they had generated on 8/17/2022. I then promptly referred back to the email from Albert Scott and called to speak with an EFAST representative who was very helpful in guiding me through the process on how to navigate the online system for completing the return and in uploading this letter of explanation on the reason why the filing is being submitted late.

Paychex retirement services had completed form 5500-SF final return/report however we were unaware they had not submitted the form to EFAST as they were contracted to do. They gave no reason why the final report form 5500-SF had not been properly filed/submitted to EFAST, since our customer account with them had since been closed.

I do apologize for the delinquency in filing GMB Plastics 5500-SF final return report and hope that with the now submitted filing of the form and this letter of explanation, any penalty that may be associated with the late filing will be graciously waived.
