INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Pinnacle Advertising 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Pinnacle Advertising 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of January 10, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to January 10, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 10, 2022 and December 31, 2021, and for the period from January 1, 2022 to January 10, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of Financial Statements section:

Basis for Opinion

A. DESCRIPTION OF PLAN

The following description of the Pinnacle Advertising 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established effective June 1, 2021, is a defined contribution plan covering substantially all employees of Pinnacle Advertising & Marketing Group (the "Company") who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee is responsible for oversight of the Plan. The Plan was terminated in 2022 (see Note F).

Contributions

Each year, participants may make either pre-tax or Roth after-tax elective contributions of eligible compensation, as defined by the Plan, not to exceed the maximum amount allowable under applicable income tax regulations. The limit is \$20,500 for 2022. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, up to \$6,500 for 2022. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company also matches 20% of a participant's deferrals up to 5% for a maximum match of 1% of compensation. The Company may also make discretionary profit sharing contributions. During the period from January 1, 2022 to January 10, 2022, the Company did not make a matching or profit-sharing contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, as well as allocations of the Company's matching contribution plus Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the vested balance in the participant's account and bear interest at the rate established by the Plan Administrator based on the current prime lending rate over a period not to exceed five years unless for the purchase of primary residence which may be repaid over a period not to exceed 15 years. Principal and interest are paid ratably through semi-monthly payroll deductions. As of January 10, 2022 and December 31, 2021, the balance of notes receivable from participants was \$0 and \$90,715, respectively.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% per year and become fully vested after five years of service.

Upon death or attaining normal retirement age (the later of age 65 or the fifth anniversary of participation in the Plan), participants will be 100% vested in the Company's matching and profit-sharing contributions.

A. DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

On termination of service due to death, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the vested balance of the participant's account or to receive partial payments from time to time until the entire vested benefit is distributed.

Hardship distributions, as well as in-service distributions for participants who have attained age 59-1/2, are also available as described in the Plan.

Forfeitures

Forfeitures, if any, are used to pay administrative expenses, restore forfeited balances of eligible rehires, and supplement employer contributions of the Plan in the year following forfeiture. As of January 10, 2022, and December 31, 2021, there were \$0 and \$651 of unallocated forfeitures. No forfeitures were used during the period from January 1, 2022, to January 10, 2022.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, which represents fair value. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 10, 2022 or December 31, 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through December 26, 2023, the date the financial statements were available to be issued. No such matters were identified.

During the period from January 1, 2022 to January 10, 2022, the Plan's investments (including investments bought, sold and held during the period) depreciated in value by \$126,862.

D. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy give the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable input (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of January 10, 2022 and December 31, 2021.

Pooled Separate Accounts: Pooled separate account contracts with an insurance company are valued at the net asset value (NAV) as a practical expedient. The NAV as a practical expedient, as provided by the custodian, is used to estimate fair value. The NAV as a practical expedient is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV as a practical expedient is an estimate of fair value and is therefore excluded from the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan pays administrative fees to John Hancock Life Insurance Company (U.S.A.), the Plan's custodian and recordkeeper. The transactions qualify as party-in-interest transactions. During the period from January 1, 2022 to January 10, 2022, the Plan made direct payments to John Hancock Life Insurance Company (U.S.A.) of \$25 for administrative services. The Plan Sponsor pays directly any other fees related to the Plan's operations.

F. PLAN TERMINATION

Effective January 1, 2022, the Pinnacle Advertising & Marketing Group entered into a co-employer agreement with Real World Marketing, Inc. The Real World Marketing 401(k) Plan was amended and renamed the Pinnacle Advertising 401(k) Plan.

Effective January 1, 2022, the Pinnacle Advertising 401(k) Plan was terminated, and on January 10, 2022, all its assets were merged into the amended and renamed Real World Marketing 401(k) Plan. Upon termination of the Plan, participants were 100% vested in their employer contributions.

G. TAX STATUS

The Plan operates under the provisions of the Volume Submitter Profit Sharing Plan, with CODA sponsored by the DATAIR Employee Benefit System Inc. as amended and restated. The IRS determined and informed by a letter dated March 31, 2014, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). This amendment and restatement of the prototype plan was to bring it into compliance with the Pension Protection Act of 2006 and other legislative and regulatory changes.

The provisions of the Plan do not vary from the prototype plan. Accordingly, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax exempt.
