Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following brief description of the Redwood School & Rehabilitation Center, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering certain employees of Redwood School & Rehabilitation Center, Inc. (the "Company") as defined in the plan document and are age twenty-one or older. The Plan was amended effective March 4, 2022 to change the restrictions on hardship distributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Termination of the Plan and Transfers to another Plan

On December 16, 2022, the Company entered into a Plan Merger/Transfer of Assets Agreement with Easter Seals TriState LLC to merge the Plan into the Easter Seals TriState LLC 401k Retirement Plan ("Easter Seals Plan") effective March 1, 2023. This agreement called for the transfer of assets from the Plan to the Easter Seals Plan as soon as administratively possible after March 1, 2023. The last date of contributions into the Plan was March 30, 2023. The Plan's participants were eligible to contribute into the Easter Seals Plan beginning April 10, 2023. The final transfer of assets from the Plan to the Easter Seals Plan occurred on April 17, 2023.

Contributions

Each year, participants may contribute a portion of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified plans (rollover). The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The deferral rate will automatically increase 1% per year up to a maximum elective deferral of 10% of compensation, unless the participant elects otherwise. Participants direct the investment of their contribution into various investment options offered by the Plan. The Company contributes 100% of the first 3% of compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company's board of directors. For the period ended April 30, 2023 and year ended December 31, 2022, there were no additional contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching and additional contribution, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expense. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Payment of Benefits

Benefits are payable to participants upon termination of employment, death, disability or retirement. The participant may elect to receive a lump-sum distribution or rollover into another qualified plan the value of the participant's vested interest in his or her account.

Forfeited Amounts

Forfeited balances of terminated participant's non-vested accounts are used to reduce future Company contributions or used to pay plan expenses. During the period ended April 30, 2023 and year ended December 31, 2022, there were \$2,751 and \$6,374 respectively, of forfeitures that were used to reduce company contributions or pay plan expenses. The balance of forfeitures at April 30, 2023 and December 31, 2022 were \$0 and \$1,445, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company and, accordingly, are not reflected in the Plan's financial statements. Investment-related expenses are included in net change in fair value of investments.

Date of Management's Review

Subsequent events were evaluated through February 12, 2024, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, (formerly named Great West Trust Company, LLC), the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of April 30, 2023 and December 31, 2022, and investment related activity reflected in the statement of changes in net assets available for benefits for the period ended April 30, 2023.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest

priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at April 30, 2023 and December 31, 2022.

- *Mutual funds.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Stable value common/collective trust fund.* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. PARTY-IN-INTEREST TRANSACTIONS

A party-in-interest is defined under the DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. Empower Annuity Insurance Company of America is the recordkeeper and Empower Trust Company, LLC is the trustee and, therefore, these transactions qualify as party-in-interest transactions. During 2023 and 2022, the Plan paid administrative fees to Empower Annuity Insurance Company of America (formerly named Great West Life and Annuity Company) of \$9,586, and \$25,387, respectively. Blue & Co., LLC is the independent auditor for the Plan and receives payments from the Company.

6. TAX STATUS

The Plan is based on a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan which has received a favorable opinion letter dated November 14, 2022, from the Internal Revenue Service (IRS) that the plan is designed to qualify as being exempt from Federal income taxes. The plan administrator has not separately applied for a determination letter from the IRS. However, the plan administrator believes that the Plan was designed and is currently being operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code, and therefore, no income taxes have been provided.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
