INDEPENDENT AUDITOR'S REPORT

To the Members and Plan Trustees of the
vXchnge Operating, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the vXchnge Operating, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of November 21, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the period January 1, 2022 through November 21, 2022 (in liquidation) and the statement of net assets available for benefits as of December 31, 2021 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the vXchnge Operating, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period January 1, 2022 to November 21, 2022 and as of December 31, 2021, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the vXchnge Operating, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Notes A1 and F to the financial statements, the governing body of vXchnge Operating, LLC 401(k) Plan approved a plan of liquidation on April 12, 2022 and the plan was liquidated on November 21, 2022. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the vXchnge Operating, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the vXchnge Operating, LLC 401(k) Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE A - DESCRIPTION OF THE PLAN

The following description of the vXchnge Operating, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Summary Description for a more complete description of the Plan's provisions.

1. General

The Plan, adopted January 1, 2013 and subsequently amended and restated April 1, 2015, is a defined contribution plan and trust covering employees of vXchnge Operating, LLC (the "Company"). In order to be eligible to participate in the Plan, employees must have attained age 21 and completed one month of service during the year of entry to be eligible for employee salary deferrals. In addition to employee deferrals, the Company may make a discretionary matching contribution equal to a uniform percentage of each tier of employee salary deferrals. Each year, the Company will determine the amount of the discretionary percentage, if any. The Company may also make discretionary profit sharing contributions to employee accounts. In order to share in any profit sharing contribution for a plan year, the employee must be employed on the last day of the plan year and completed a year of service during the plan year. Furthermore, the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On April 12, 2022 the Company approved the termination of the Plan and the Company ceased operations on June 1, 2022. Subsequent to June 1, 2022, no contributions, loan payments or new loans were allowed into or out of the Plan. The plan was liquidated and was fully terminated on November 21, 2022.

2. Contributions

Participants were permitted to make elective deferrals in any amount up to the amount of the Internal Revenue Service limits, which was \$20,500 during the period ended November 21, 2022, plus an additional \$6,500 for employees over 50 years of age. Participants were also permitted to make Roth deferrals. The Company may make matching contributions and/or profit-sharing contributions at the discretion of the Company's management.

3. Participant Accounts

Each participant in the Plan has a separate account that is credited with (a) the Company's contributions, (b) the employee's elective contributions, and (c) the allocation of Plan's earnings or losses based on investment fund or account elections. Allocations are based on the prorated earnings of the employee compared to the total earnings of all participants in the same investment. Participants may also elect to invest in an insurance company general account that has a guaranteed interest crediting rate.

4. Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon.

NOTE A - DESCRIPTION OF THE PLAN - CONTINUED

Vesting in their Employer Contribution Account for profit sharing or matching contributions are on a sliding scale based on their number of years of service as follows:

| <u>Years of Service</u> | <u>Vested Percentage</u> |
|-------------------------|--------------------------|
| 1 | 25% |
| 2 | 50% |
| 3 | 75% |
| 4 | 100% |

One hundred percent vesting occurs, regardless of the number of years of service, when a participant reaches normal retirement age (65), meets the requirements for early retirement, dies, or becomes totally and permanently disabled. Any elective deferrals, qualified non-elective contributions, qualified matching contributions, rollover contributions, plus or minus any earnings or losses, are 100% vested and cannot be forfeited for any reason.

The plan was terminated November 21, 2022 at which point all participants became 100 percent vested in their accounts.

5. Payment of Benefits

Benefit payments are made in the form of a single lump-sum payment if the employee's vested balance is less than \$5,000; or the participant can elect a single lump-sum payment, installment payments, or a partial withdrawal for vested balances over \$5,000. Plan participants were entitled to 100% of their account balance upon normal retirement, death, or becoming permanently disabled. Prior to the plan termination, if employment was terminated for any reason other than those previously mentioned, the participants will only be entitled to that portion of the employer contributions for which they are vested. Participants are entitled to 100% of the account balance of any salary reduction or voluntary contributions made on their own behalf.

6. Forfeitures

Forfeitures consist of matching and profit-sharing contributions and the Company may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. The Plan had \$-0- in forfeitures from non-vested accounts at November 21, 2022 and used approximately \$27,000 of forfeitures since the date of elective termination.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows:

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

2. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

3. Investment Valuation and Income Recognition

The Plan's pooled separate accounts investments were stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Units in the pooled separate accounts were valued at the net asset value ("NAV") of units held by the Plan at year-end. The investment in the insurance company guaranteed return account was stated at contract value, as determined by the issuer of the contract based on the fair value of the underlying investments and then adjusted by the issuer to contract value. Contract value represents contributions made, plus earnings, less participants' withdrawals. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the guaranteed return account at November 21, 2022 and December 31, 2021 was \$-0- and \$374,541, respectively.

Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net gains or losses on the disposal of investments and changes in the current value of investments were reported in the statement of changes in net assets available for benefits as a net appreciation or depreciation in fair value of investments.

Management fees and expenses charged to the Plan for investments in the pooled separate and insurance company guaranteed account were deducted from income earned. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

4. Payment of Benefits

Benefits were recorded when paid.

5. Notes Receivable from Participants

Participants could borrow monies from the Plan at an amount that does not exceed the lesser of \$50,000 or 50% of a participant's vested account balance. Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant failed to make payments when they were due under the terms of the loan, the loan will be considered to be in default. The Plan considered a loan to be in default if any scheduled loan repayment was not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. Participant notes receivable balances were distributed as part of the plan termination.

The Plan has the authority to take all reasonable actions to collect the balance owed on the loan. This could include filing a lawsuit or foreclosing on the security for the loan. Under certain circumstances, a loan that is in default may be considered a distribution from the Plan and could be considered taxable income to the participant. In any event, failure to repay a loan will reduce the benefit an employee would otherwise be entitled to receive from the Plan.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's Investments were held by Minnesota Life Insurance Company during 2021 and through November 21, 2022. The Plan adheres to the provisions of Financial Accounting Standards Board, *Accounting Standards Codification* 820 ("FASB ASC 820). FASB ASC 820 establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted price in active markets for identical assets or liabilities (level 1 measurement), a middle priority to quoted prices for similar assets or liabilities (level 2 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at November 21, 2022 and December 31, 2021:

Pooled separate accounts: Valued at the net asset value ("NAV") of units held by the Plan at year end. Investments in these accounts are valued at quoted market prices of the issuer and are Level 2 measurements.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - GUARANTEED RETURN ACCOUNT

The Plan had a fully benefit-responsive guaranteed return account totaling \$-0- and \$374,541 at November 21, 2022 and December 31, 2021, respectively. The guaranteed return account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed return account issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and was reviewed on a periodic basis for resetting. The guaranteed return account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer.

Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure to the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events were probable of occurring that limited the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants as of December 31, 2021.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Upon discontinuance of the contract with Securian Retirement Solutions (a unit of Minnesota Life Insurance Company), the Plan was paid in a single sum, the market value of the investments less any termination fees associated with the guaranteed return account.

NOTE F - PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and terminate the Plan pursuant to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts. On April 12, 2022, the Company approved the termination of the Plan and the plan was terminated on November 21, 2022.

NOTE G - TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan's investment trustee has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan sponsor's management and Trustees do not believe any uncertain tax positions have been taken with respect to the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. All tax years after 2018 are subject to examination by the Internal Revenue Service.

NOTE H - PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets are administered through Securian Retirement Solutions ("Securian"), a unit of Minnesota Life Insurance Company. Securian, as the administrator of the Plan, provides recordkeeping for the Plan. Company contributions are managed by the administrator who invests cash received, interest and dividend income and makes distributions to participants. Fees paid to Securian for recordkeeping and investment management services amounted to \$30,053 for the period ended November 21, 2022.

Administrative functions are also performed by employees of the Company. No officer or employee received compensation from the Plan. Expenses for the independent auditor fees are paid directly by the Company in 2021 and by the Plan in 2022, and administrative fees were paid by the Plan.
