### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of OVM Financial, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit (ERISA Section 103(a)(3)(C)). The financial statements comprise the statements of net assets available for benefits as of November 30, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through November 30, 2023, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of November 30, 2023 and December 31, 2022 and for the period from January 1, 2023 through November 30, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### *Opinion*

As described in Notes A and F to the financial statements, the Plan sponsor determined liquidation was imminent January 1, 2023 and the Plan was amended to terminate effective July 14, 2023. Participant accounts were liquidated and distributed during the period from January 1, 2023 through November 30, 2023. As a result, the Plan changed its basis of accounting on January 1, 2023 for the period from January 1, 2023 through November 30, 2023 from the going concern basis of accounting to the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**A. DESCRIPTION OF PLAN**

The following description of the OVM Financial, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

**1. General**

The Plan is a defined contribution plan covering substantially all employees of OVM Financial, Inc. (the Company) who have completed three months of service and attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan. The Company's management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's trustees.

**2. Plan Termination**

By action of the Plan sponsor as discussed in Note F, Company management determined Plan liquidation was imminent January 1, 2023 and subsequently amended the Plan with a termination date effective July 14, 2023. All participant accounts were previously 100% vested in 2022, following a partial plan termination. Subsequent to January 1, 2023, no employee or employer contributions, loan payments, or new loans were allowed into or out of the Plan. Participant balances were distributed to participant IRA accounts, the participant's current employer's plan, or directly to the participant. All balances were distributed through November 30, 2023.

**3. Contributions**

Each year, participants may contribute before-tax and qualified Roth deferrals to the Plan, up to 100% of annual compensation, as defined in the Plan documents. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation with a 1% increase annually up to 12% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company may elect to make discretionary matching and discretionary nonelective contributions each year. The Company did not make any discretionary matching or discretionary nonelective contributions for the Plan period from January 1, 2023 through November 30, 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**A. DESCRIPTION OF PLAN (Continued)**

**4. Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's discretionary matching contributions and discretionary nonelective contributions, as well as allocations of the Plan's earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**5. Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. Participants became fully vested in the Company's contribution portion of their accounts in 2022, following a partial plan termination.

**6. Notes Receivable from Participants**

Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts. The loans bear interest based on the Prime rate plus 1%. Principal and interest is paid ratably through monthly payroll deductions.

**7. Payment of Benefits**

On termination of service due to disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. On termination due to death, a complete distribution of the participant's account will be made by December 31 of the calendar year containing the fifth anniversary of the participant's death. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**8. Forfeited Accounts**

At November 30, 2023, there were no forfeited non-vested accounts. At December 31, 2022, forfeited non-vested accounts totaled \$10,532. These accounts may be used to pay future Plan expenses. Any forfeitures left after paying Plan expenses will be used to reduce future employer contributions. During the period from January 1, 2023 through November 30, 2023, \$10,997 from forfeited non-vested accounts were used to pay Plan expenses.

**B. SUMMARY OF ACCOUNTING POLICIES**

**1. Basis of Accounting**

The financial statements of the Plan are prepared on the liquidation basis of accounting.

**B. SUMMARY OF ACCOUNTING POLICIES (Continued)**

**2. Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**3. Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment advisor determines the Plan's valuation policies utilizing information provided by the investment advisor, trustees and custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

**4. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses on the statement of changes in net assets available for benefits and are expensed when they are incurred.

**5. Payments of Benefits**

Benefits are recorded when paid.

**6. Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses on the statement of changes in net assets available for benefits. Investment-related expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

**C. CERTIFIED INVESTMENT INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at November 30, 2023 and December 31, 2022, and net appreciation in fair value of investments and interest income on notes receivable from participants for the period from January 1, 2023 through November 30, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (the Custodian).

#### D. FAIR VALUE MEASUREMENTS

Financial Accounting Standard Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, (ASC 820), defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not assumptions specific to the entity.

ASC 820 specifies a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon the market data obtained from independent sources (observable inputs). In accordance with ASC 820, the following summarizes the fair value hierarchy:

While the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methods or assumptions to estimate the fair value of certain financial statement items could result in a different estimate of fair value at the reporting date. Those estimated values may differ significantly from the values that would have been used had a readily available market for such items existed, or had such items been liquidated, and those differences could be material to the financial statements.

Level 1 – Unadjusted quoted market prices for identical assets in an active market that the Plan has the ability to access.

Level 2 – Inputs other than the quoted market prices in active markets that are observable either directly or indirectly.

Level 3 – Inputs based on prices or valuation techniques that are unobservable and significant to the overall fair value measurements.

ASC 820 requires the use of observable market data, when available, in making fair value measurements. When inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2023 and December 31, 2022.

*Pooled separate accounts:* Valued at the net asset value (NAV) of units of an insurance company trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Fair Value of Other Financial Instruments**

Due to their short-term nature, the carrying value of cash and cash equivalents and short-term receivables approximate their fair value as of December 31, 2022. There were no short-term assets at November 30, 2023.

**E. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as risk of foreign currency fluctuations relative to the U.S. Dollar, interest rate risk, credit risk, issuer going concern risk, and overall market volatility. During the period from January 1, 2023 through November 30, 2023, net appreciation in fair values of investments approximated \$162,000. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

ERISA mandates certain fidelity bond requirements. The Plan's ERISA fidelity bond policy expired October 26, 2023. From expiration through the period ending November 30, 2023, the Plan was not in compliance with ERISA requirements and was not insured against losses due to fraud or dishonesty by those handling the Plan's funds or property. The absence of fidelity bond coverage exposes the Company, trustees, and fiduciaries to a certain level of risk and liability which would otherwise be covered by a properly maintained fidelity bond policy.

**F. PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions. The Company's management determined liquidation was imminent January 1, 2023 and formally approved a plan of liquidation on June 23, 2023, which amended the Plan to terminate effective July 14, 2023. Prior to the Plan's termination, participants were determined to be 100% vested in their accounts in 2022, resulting from a partial plan termination. During the period from January 1, 2023 through November 30, 2023, plan assets were liquidated and distributed in accordance with instructions received from the Plan's participants.

**G. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Custodian and therefore these transactions qualify as party-in-interest transactions.

The Company pays certain Plan accounting and administrative fees. The Company incurred \$11,402 for accounting and administrative fees during the period from January 1, 2023 through November 30, 2023. These fees are not reflected in the accompanying financial statements.

Effective July 18, 2017, the Custodian provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and the Custodian. The Custodian receives revenue from mutual fund service providers for services the Custodian provides to the funds. This revenue is used to offset certain amounts owed to the Custodian for its administrative services to the Plan.

**G. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (Continued)**

If the revenue received by the Custodian from such mutual fund service providers exceeds the amount owed under the MSA, the Custodian remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2023, there were no excess amounts. The Plan or Plan Sponsor may make a payment to the Custodian for administrative expenses not covered by revenue sharing.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits as they are paid through revenue sharing, rather than direct payment. The Company pays directly any other fees related to the Plan's operations. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**H. TAX STATUS**

The Plan uses a prototype plan document sponsored by PBMares, LLP. PBMares, LLP received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the prototype plan received the determination letter, the Plan's management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**I. SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through December 13, 2023, the date on which the financial statements were available to be issued.
