Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control - related matter that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of delinquent participant contributions is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from, and relates directly to, the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information. In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1: Description of Plan

The following description of Supply Chain Services, LLC 401(k) Profit Sharing Plan (the Plan) provides general information only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Supply Chain Services, LLC. (the Company). The Plan became effective January 1, 2010 and was amended and restated on December 1, 2021. The Plan is subject to the provisions of ERISA. Plan management is responsible for oversight of the Plan. They determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

All full-time employees of the Company, except as noted in the Plan Agreement, who have reached the age of twenty-one (21), become eligible to participate in the Plan immediately. There is no minimum service requirement to be eligible to participate in the Plan. Eligibility requirements to receive safe harbor employer matching contributions are the same as for participation in the Plan.

Contributions

Participants may contribute up to one hundred percent (100%) of pre-tax or after-tax (Roth) compensation, not to exceed the annual limit set by the Internal Revenue Service (IRS). Catch-up contributions may be made by a participant who attains the age of fifty (50) by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions to eligible employees. The safe harbor matching contributions are equal to one hundred percent (100%) of the employee's first three percent (3%) of salary deferrals, plus fifty percent (50%) of the subsequent two percent (2%) of participant salary deferrals.

The Company may make additional discretionary contributions to the Plan. Participants who have given one (1) year of service (with at least one thousand [1,000] hours of service) during the Plan year, and who are twenty-one (21) years of age, are eligible to receive discretionary contributions. No discretionary contributions were made during the period January 1, 2023 through January 19, 2023.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, if any, (b) Plan earnings (losses) and (c) an allocation of any administrative expenses paid by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Expense allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always fully vested in their rollover contributions, elective deferrals, safe harbor matching contributions, qualified nonelective contributions, and any earnings thereon. Discretionary contributions vest in accordance with the following schedule:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested account balance, reduced by the highest outstanding loan balance in their account during the prior twelve (12) month period. Participants may only have two (2) loans outstanding at any given time. Loan terms may not exceed five (5) years, except for the purchase of a principal residence of the participant in which case the loan term may not exceed ten (10) years. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account either by cash, direct rollover, or a combination of cash and direct rollover. Cash distributions are subject to federal income tax withholding. In-service withdrawals are also permitted for participants who have reached the age of fifty-nine and one-half (59 ½).

If the participant's vested account balance is \$5,000 or less, the Plan will make an automatic distribution of the vested balance to an individual retirement account or annuity, unless otherwise requested. If the vested account balance is \$1,000 or less, the Plan will make an automatic distribution of the amount by rolling it into an IRA, unless otherwise requested.

Forfeitures

At January 19, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$-0- and \$3,757, respectively. During the period January 1, 2023 through January 19, 2023, all assets were transferred out of the Plan (see Note 6). These accounts may be used to pay administrative expenses or to reduce future employer contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, as well as disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for direct investments in fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of January 19, 2023 and December 31, 2022, no allowance for credit loss has been recorded. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan balance is reduced and a benefit payment is recorded based on the terms of the Plan Agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of the Plan, including administration of notes receivable from participants and payment of benefits, are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Date of Management's Review

The Plan has evaluated events and transactions that occurred during the period from the date of the financial statements through November 15, 2023, the date the Plan's financial statements were available to be issued. There were no events or transactions that occurred during the period that materially impacted the amounts or disclosures in the Plan's financial statements.

Note 3: Information Prepared and Certified by the Plan's Trustees

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company, the trustees of the Plan, except for comparing such information certified by the trustees to information included in the Plan's financial statements as of January 19, 2023 and December 31, 2022.

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three (3) levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 19, 2023 and December 31, 2022.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5: Guaranteed Investment Contract with Insurance Company

The Plan entered into a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company. Empower Annuity Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer. Interest rates are reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 5: Guaranteed Investment Contract with Insurance Company (Continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

Note 6: Plan Termination

On January 19, 2023, the Plan merged with Peak Technologies, Inc. 401(k) Retirement Plan (Successor Plan). All Plan assets were transferred to the Successor Plan.

Note 7: Tax Status

The Plan is a qualified plan under the Internal Revenue Code (IRC) as per opinion letter dated June 30, 2020. The Plan has since been amended; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The previous three (3) tax years remain subject to examination by the IRS.

Note 8: Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Empower Trust Company, LLC and Guaranteed Investment Contracts are managed by Empower Annuity Insurance Company, the trustees. Therefore, these transactions qualify as party-in-interest transactions. Additionally, any transactions with RBC Capital Markets, LLC, the investment advisor, also qualify as party-in-interest transactions. The Plan made a direct payment for certain administrative expenses of \$13,827.

The Company pays any other fees related to the Plan's operation.

Some trustees of the Plan are also participants in the Plan.

All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
