To whom it may concern:

Today I received an email from Nicole Blunt of the Employee Benefits Security Administration (DOL), Office of the Chief Accountant. Ms. Blount's email was a follow-up to a January 25, 2024, email from Scott Albert, Chief of the Division of Reporting Compliance. In Mr. Albert's email, he indicated that a 2022 Form 5500 or 5500-SF had not been filed with the US Department of Labor for the Gibb Epidemiology Consulting L 401(k) Profit Sharing Plan & Trust (EIN/PN 46-4932901/001). The day that I received Mr. Albert's email, I contacted ADP Retirement Services and spoke with Alejandra Martinez about how to resolve the problem. I then forwarded Mr. Albert's email to ADP Retirement Services.

Upon today's receipt of Ms. Blount's email, I again contacted ADP Retirement Services and spoke with Monica. Monica indicated that I should write a letter to the Department of Labor explaining why a 5500 had not been filed for Gibb Epidemiology Consulting, that I should send this letter to ADP Retirement Services at ADP, and that ADP would forward the letter to DOL. Hence, the current letter.

On August 1, 2022, Gibb Epidemiology Consulting became Gibb & O'Leary Epidemiology Consulting. ADP managed the Retirement Plan for Gibb Epidemiology Consulting; they continued to manage the plan after the company became Gibb & O'Leary Epidemiology Consulting. All the retirement assets in Gibb Epidemiology Consulting (EIN 46-4932901) were transferred to Gibb & O'Leary Epidemiology Consulting (EIN 88-2957733). I understood that ADP would continue to prepare the necessary forms.

Along with this letter, which I am sending by email to ADP to forward to DOL, I am including as attachments to the email the emails from Mr. Albert and Ms. Blount.

I look forward to a quick and successful resolution of this matter. Thank you to all concerned.
