**INDEPENDENT AUDITOR'S REPORT**

To the Administrative Committee of

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of The Kimmins 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the years ended December 31, 2022 and 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Kimmins 401(k) Savings Plan Employee Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

**Opinion**

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Kimmins 401(k) Savings Plan Employee Benefit Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Kimmins 401(k) Savings Plan Employee Benefit Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Kimmins 401(k) Savings Plan Employee Benefit Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The supplemental schedules of Schedule of Assets Held for Investment Purposes at end of year are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## THE KIMMINS 401(K) SAVINGS PLAN NOTES TO FINANCIAL STATEMENTS

### NOTE A - DESCRIPTION OF PLAN

The following brief description of The Kimmins 401(k) Savings Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a contributory, defined contribution plan covering eligible employees of Kimmins Corp. It also covers eligible employees of Qualex Consulting, Inc, which is under common control of Kimmins Corp.'s ownership. Collectively these entities are referred to as the "Company." Employees are eligible to participate upon the later of completing six months of service and attaining age twenty. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions.* Each year, participants may contribute, subject to certain limitations, a portion of their annual compensation to their deferred contribution accounts. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, in its discretion, the Company may contribute a matching contribution equal to a percentage of the participant's elective deferral on the first 4% of participant's eligible compensation. In addition, each employer may make additional discretionary non-elective contributions upon the approval of the Board of Directors.

*Participant Accounts.* Each participant's account is credited with the participant's elective deferral, an allocation of the Company's contribution, if any, plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting.* Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

*Notes Receivable from Participants.* Loans are available upon approval by the Plan administrator. The minimum loan is \$1,000 with the maximum being the lesser of 50% of the participant's vested balance or \$50,000 as reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period. The loans are secured by up to 50% of the participant's vested account balance and bear interest at rates commensurate with those of prevailing commercial loans as determined by the Plan administrator. Principal and interest is paid ratably through weekly payroll deductions.

*Payment of Benefits.* There are various methods by which benefits may be distributed to a participant from the Plan as a result of retirement, termination, or other events that may result in distribution of benefits. The method depends on the participant's marital status as well as the election made by the participant and his or her spouse.

*Forfeited Accounts.* At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$12,341 and \$0 respectively. During the years ended December 31, 2022 and 2021, \$20,783 and \$0 respectively, were used to reduce employer contributions.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *Date of Management's Review*

The Plan administrator has evaluated subsequent events through February 12, 2024, which is the date financial statements were available to be issued.

#### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value except for fully-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefit of a defined contribution plan attributable to fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. At December 31, 2022 and 2021, no allowance for credit losses has been recorded. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value except for the guaranteed interest account (GIA) investment option for its investment contract which is valued at contract value with an insurance company (NOTE D). The Plan's investment in the separate investment accounts (SIA) with the insurance company are valued at the net fair value of the underlying assets of the Plan's units of participation determined generally by using commercial quotation services as of the last day of the calendar year. See NOTE C for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits*

Benefits are recorded when paid

*Excess Contributions Payable*

There were no excess contributions for the years ended December 31, 2022 and 2021, respectively.

*Operating Expenses*

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in the fair value of investments. Fees for participant loans and account maintenance are charged to individual participants' accounts.

**NOTE C - FAIR VALUE MEASUREMENTS**

Accounting Standards Codification Topic 820, Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification Topic 820 and Disclosures are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The guaranteed investment contract with an insurance company is not actively traded and significant other observable inputs are not available. Thus, the fair value of the guaranteed investment contract is determined using an income approach based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer (3.00% and 2.75% at December 31, 2022 and 2021, respectively).

For those assets with fair value measured using Level 3 inputs, the Plan administrator determines the fair value measurement policies and procedures in consultation with the Plan trustee. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Notes receivable from participants:* Valued at amortized cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Empower Retirement f/k/a Massachusetts Mutual Life Insurance Company (Mass Mutual) as of and for the years ended December 31, 2022 and 2021, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Subject to certain limitations, the investment contract with Empower Retirement requires the Plan sponsor to deposit 100% of Plan contributions with Empower Retirement. Plan participants may choose between investing their contributions, including the employer's contribution, in either a guaranteed interest account (GIA) or to any combination of separate investment accounts (SIA).

The GIA is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The principal of the GIA is guaranteed as long as the contract is in force. The GIA is fully benefit-responsive and is included in the financial statements at contract value as reported to the Plan by Mass Mutual. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**NOTE D – INFORMATION PREPARED AND CERTIFIED BY EMPOWER RETIREMENT f/k/a MASSACHUSETTS MUTUAL LIFE INSURANCE COMPANY (MASS MUTUAL) (UNAUDITED) (Continued)**

Under the contract, a crediting rate is established for a specific period of time (a rate period) and contributions invested in the GIA are credited with that rate. At the expiration of the rate period, a new crediting rate is declared. Empower Retirement takes all market, credit and interest rate risks of the assets supporting the GIA. For each contract, experience is tracked using the Investment Year Method (IYM). Mass Mutual Retirement Services (MMRS) tracks each contract's cash flow into and out of the GIA during each calendar year and the overall investment results of the MMRS segment of the Mass Mutual general investment account for that year to determine the IYM experience of the contract for that "investment year". There are no reserves against contract value for credit risk of the contract insurer or otherwise. The average yield and crediting interest rate was 3.00% for 2022 and 2.75% for 2021. The crediting interest rate is based on a formula agreed upon with the issuer and are reviewed on a semi-annual basis for resetting.

The assets of the SIA are separate from GIA. MMRS invests these accounts according to the stated objectives of the various SIAs. The principal is not guaranteed. Contract holders are allocated units of the SIA, not specific securities. The value of the SIA units is the net fair value of the underlying assets on the last day of the 5500 reporting period as determined generally by using commercial quotation services.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor's business; (5) removal from the plan of one or more groups or classifications of participants; (6) partial or complete plan termination; or (7) plan disqualification. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **NOTE F - PLAN TERMINATION**

Although the Company has not expressed any intention to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

#### **NOTE G - TAX STATUS**

The Plan's most recent determination letter from the Internal Revenue Service expired on January 31, 2014. The Plan was amended and restated into the Plan's law firm pre-approved volume submitter plan effective January 1, 2013 as the Internal Revenue Service no longer issues individual favorable determination letters on pre-approved volume submitter plans. The Plan's administrator and counsel believe the Plan as it is currently designed and operating is in compliance with the applicable requirements of the Internal Revenue Service.

The earliest plan year that remains subject to examination by major tax jurisdiction is 2019.

#### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
