Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 401(k) Profit-Sharing Plan for Employees of Major Custom Cable, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of 401(k) Profit-Sharing Plan for Employees of Major Custom Cable, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 401(k) Profit-Sharing Plan for Employees of Major Custom Cable, Inc. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 2 of the financial statements, the governing body of the 401(k) Profit-Sharing Plan for Employees of Major Custom Cable, Inc. approved a plan of liquidation on June 14, 2022 and the Plan was fully liquidated as of December 31, 2022. As a result, the Plan's basis of accounting is presented using the liquidation basis. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 401(k) Profit-Sharing Plan for Employees of Major Custom Cable, Inc.'s ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit the section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of delinquent participant contributions for the year ended December 31, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the 401(k) Profit-Sharing Plan for Employees of Major Custom Cable, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

General

The Plan is a defined contribution plan covering eligible employees of Major Custom Assemblies, Inc. (formerly Buse Industries, Inc.) and Major Custom Cable, Inc. (the "Company"). Non-union employees are eligible to participate upon completion of one month of service and attaining age 18. The Plan has an auto enrollment feature that automatically enrolls employees as soon as they are eligible to participate in the Plan. These employees are automatically enrolled at a 3% pre-tax deferral rate. The Plan is a salary reduction plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan management elected a plan to terminate the plan on June 14, 2022. Subsequent to that date, the Company made no further elective deferral contributions to the Plan on behalf of participants who have an executed salary reduction agreement in effect. The Plan was fully dissolved as of December 31, 2022.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined by the Plan, not to exceed certain dollar limits established by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollovers"). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions not to exceed certain dollar limits established by the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes matching contributions equal to 25% of the first 6% of base compensation for each participant's contribution to the Plan. The Company may contribute additional profit-sharing amounts at the discretion of the Company's Board of Directors. The Company made no profit-sharing contributions during the years ended December 31, 2022 and 2021.

1. DESCRIPTION OF THE PLAN (continued)

Participant accounts

Each participant's account is credited with the participant's deferral contributions, rollover contributions, matching contributions and allocations of (a) the Company's profit-sharing contributions, and (b) Plan earnings. Participant accounts are charged with any withdrawals or distributions, allocation of Plan losses as defined, and an allocation of administrative expense paid out of the Plan. The Company's discretionary profit-sharing contribution is allocated as of the last day of the Plan year and is based on a ratio of each eligible participant's compensation to total compensation for all eligible participants. Plan earnings are allocated to participant accounts in direct proportion to their respective account balances, based on the performance of the participant's investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants vest immediately in their participant deferral and rollover contributions plus the actual earnings thereon. Effective June 1, 2019 the Plan was amended to establish a new set of vesting requirements for participants who were employees of Major Custom Assemblies, Inc. on or after May 1, 2017. These participants become 25% vested in the Company's contributions after two years of service, 50% vested after three years of service, 75% vested after four years of service, and 100% vested after five years of service. All other participants become 25% vested in the Company's contributions after 1 year of service, 50% vested after two years of service and 100% vested after three years of service.

All active participants as of the termination of the Plan at June 14, 2022 became 100% vested in employer contributions.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, excluding Roth contributions. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is defined as a comparable rate charged as similar persons in the business of lending money. Principal and interest is paid ratably through monthly payroll deductions. A participant may have only one outstanding loan at any time.

Payment of benefits

Participants are entitled to receive the balance of their account upon death, total disability, retirement or termination of employment, or upon request after reaching age 59 ½. A participant may elect to receive a single lump-sum payment equal to the value of his or her vested account balance, installments over a specified period of time, or a direct rollover distribution. Participants who have suffered a hardship (as defined by the IRC and the Plan) also may withdraw all or any portion of their vested account balances.

Forfeited accounts

Upon termination of employment, participants forfeit their non-vested balances as defined above. At December 31, 2022 and 2021, there were no unallocated forfeiture balances. Available amounts can be used to reduce future Company contributions. Forfeitures totaling \$0 and \$153 were used to reduce Company matching contributions during the years ended December 31, 2022 and 2021, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

As disclosed in Note 1, the Company elected to terminate the Plan during 2022. As a result, the Plan's basis of accounting is the liquidation basis of accounting for the year ended December 31, 2022. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

For the year ended December 31, 2021, the financial statements were prepared using the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect reported amounts of net assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value (except for the Plan's fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Corrective distributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. These amounts payable totaled \$0 and \$4,345 as of December 31, 2022 and 2021, respectively.

Payment of benefits

Benefit payments to participants are recorded upon distribution.

Expenses

Administrative expenses of the Plan can be paid by the Company or by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable are charged directly to the participant's account and reduce the loan proceeds received. Fees related to benefit payments to participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through February 13, 2024, the date the financial statements were available for issue.

3. INFORMATION PREPARED AND CERTIFIED BY PLAN CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained a certification from Mutual of America Life Insurance Company ("MOA"), that all of the investment information provided by the Plan custodian and included in the accompanying financial statements and supplemental schedule, is complete and accurate.

Information as to the investments in the accounts of the Plan custodian, investment income, and related interest income and all financial information appearing in the accompanying financial statements, excluding notes receivable from participants, is presented in reliance solely upon this certification.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology included:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable relevant inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2022 and 2021, there were no transfers between fair value levels.

5. GROUP ANNUITY CONTRACT

MOA maintains certain contributions in a group annuity contract. The contracts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by MOA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the group annuity contract at December 31, 2022 and 2021, was \$0 and \$229,092, respectively, as reported by MOA. The crediting interest rate is based on a formula agreed upon with the issuer and there is no underlying guarantee of a minimum crediting rate. Such interest rates are reviewed on a quarterly basis for resetting.

5. GROUP ANNUITY CONTRACT (continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition and competing investment options or deletion of equity wash provisions, or (3) termination of the contract by the Company. Following receipt of a Plan termination request, Mutual of America has the right to defer payment of a total withdrawal for up to six months. The Plan notified MOA and participants of the Plan's termination on June 14, 2022 (see Note 7) and MOA was required to transfer the remaining contract balance to the Plan on or before December 14, 2022. The Plan Administrator does not believe that any additional events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. TAX STATUS

The Plan Agreement is based on a Principal prototype plan that was determined by the Internal Revenue Service in a letter dated November 30, 2020, to be in accordance with applicable sections of the IRC. Although the Plan has been amended and restated since its adoption, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

On June 14, 2022 the Company terminated the Plan and participants became 100% vested in their employer contributions. The Company liquidated all account balances by December 31, 2022.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments include an interest in a group annuity contract and shares of mutual funds managed by the custodian or related parties to the custodian; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian for administrative services amounted to \$0 and \$646 for the years ended December 31, 2022 and 2021, respectively. The Plan Sponsor may directly pay fees related to the Plan's operations.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. LATE CONTRIBUTION REMITTANCES

In connection with an internal review of the Plan's operations performed by the Plan Sponsor, certain errors related to payroll deductions for elective deferrals, matching Company contributions, forfeitures and compliance testing were identified that occurred during the years ended December 31, 2020 and 2019. The Plan Sponsor corrected these errors with a \$16,074 contribution on March 11, 2022.
