### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kansas Children's Service League 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 11, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 11, 2023 and December 31, 2022, and for the periods then ended, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

**Note 1: Description of the Plan**

***General***

The following description of Kansas Children's Service League 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan was a defined contribution plan sponsored by Kansas Children's Service League and its related entities (Organization) for the benefit of its employees who had at least 30 days of service. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Various members of the Organization's management were the trustees of the Plan.

Great-West Trust Company, LLC and Great-West Life & Annuity Insurance Company (collectively, Great-West) served as custodians of the Plan until Great-West was rebranded. Effective August 1, 2022, Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, Empower) served as custodians of the Plan.

Effective April 11, 2023, the Plan merged into the OneDigital Open Pooled Employer Plan. The Plan merger initiated a blackout period beginning April 5, 2023. During this period, participants were unable to direct, diversify or withdraw the assets held in their accounts.

***Contributions***

The Plan permitted eligible employees through a salary deferral election to have the Organization make annual contributions of up to 100% of eligible compensation. Employee rollover contributions were also permitted. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Contributions were subject to certain limitations. Each year, the Board of Directors determined the amount of discretionary contributions to the Plan. The Organization made matching contributions of fifty percent of employees' salary deferral amounts on the first six percent of employees' compensation in 2023 and 2022.

***Participant Investment Account Options***

Each participant had the option of directing contributions into any of the various investment options offered by the Plan and could change the allocation daily.

The Plan Document also included an automatic deferral feature whereby a participant was treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise.

### ***Participant Accounts***

Each participant's account was credited with the participant's contribution, the Organization's contribution, and plan earnings (losses) and was charged with an allocation of administrative expenses. Allocations were based on participant earnings (losses) or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants were immediately vested in their voluntary contributions plus earnings (losses) thereon. Vesting in the Organization's contribution portion of their accounts plus earnings (losses) thereon was based on years of continuous service. A participant was fully vested after five years of continuous service.

### ***Notes Receivable from Participants***

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined quarterly, was set at 1% above the prime interest rate as published in the Wall Street Journal. Principal and interest was paid ratably through monthly payroll deductions.

### ***Payment of Benefits***

On termination of service, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. A participant could also receive a distribution of their deferral contributions if a participant had a financial hardship as defined in the Plan.

### ***Forfeited Accounts***

At April 11, 2023 (prior to the merger) and December 31, 2022, forfeited nonvested accounts totaled \$3,417 and \$9,559, respectively. These accounts were used to pay plan expenses or reduce future employer contributions. In 2023 and 2022, employer contributions were reduced by \$6,155 and \$18,333, respectively, from forfeited nonvested accounts.

### **Note 2: Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan were required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value was the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value was the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments were reported at fair value (except for fully benefit-responsive contracts which were reported at contract value). Mutual funds were valued at the net asset value (NAV) of shares held by the Plan at year-end.

Fully benefit – responsive contracts were valued at contract value. Contract value represented contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable From Participants***

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.

#### ***Payment of Benefits***

Benefit payments to participants were recorded upon distribution.

### **Administrative Expenses**

Administrative expenses could be paid by the Organization or the Plan, at the Organization's discretion.

### **Note 3: Certification of Plan Custodian**

The plan administrator elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, a qualified institution, has certified the following investment information included in the accompanying financial statements was complete and accurate.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of April 11, 2023 and December 31, 2022.
- Investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period ended April 11, 2023 and December 31, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

### **Note 4: Related Party and Party-in-Interest Transactions**

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provided services to the Plan, an employer whose employees were covered by the Plan, an employee organization whose members were covered by the Plan, a person who owned 50% or more of such an employer or employee association or relatives of such persons.

The Plan invested in certain funds of the Plan custodian and, therefore, these transactions qualified as party-in-interest transactions. The plan sponsor paid certain fees related to the Plan's operations on behalf of the Plan.

The Plan paid \$23,935 and \$49,456 of recordkeeping fees to Empower during 2023 and 2022, respectively. Individually nonmaterial expenses paid to parties in interest aggregated \$1,125 and \$2,103 during 2023 and 2022, respectively. The Organization provided certain administrative services at no cost to the Plan.

### Note 5: Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

### *Investments*

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

### **Note 6: Investment Contract with Insurance Company**

The Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America, who maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract was fully benefit responsive; therefore, contract value was the relevant measurement. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator did not believe the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, was probable.

### **Note 7: Plan Termination**

Although the Plan did not terminate, it was merged into the OneDigital Open Pooled Employer Plan (PEP). All assets were transferred to the PEP on April 11, 2023.

### **Note 8: Tax Status**

The Plan operated under an adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Great-West Trust Company, LLC. This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter from the IRS stating that the prototype constituted a qualified plan under Section 401 of the Internal Revenue Code. Although the Plan was amended since the prototype received the opinion letter, the Plan Administrator and the Plan's tax counsel believed the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

### **Note 9: Subsequent Events**

Subsequent events have been evaluated through February 15, 2024, which is the date the financial statements were available to be issued.
