Their report, dated October 14, 2020, indicated that (a) because of the significance of the information that they did not audit, they were unable to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, they did not express an opinion on the financial statements and (b) the form and content of the information included in the financial statements other than that derived from the information certified by the Plan Custodian, were presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

Year Ended December 31, 2020

NOTE 1 - PLAN DESCRIPTION

The following brief description of Animax Designs, Inc. (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan, which was established on January 1, 2018, is classified as a defined-contribution plan covering substantially all employees of Animax Designs, Inc. (“Animax” or the “Employer”) who have completed 90 days of service. Leased employees, as defined, are excluded from the Plan. An employee is eligible for participation on the first day of the month coinciding with or following satisfaction of the eligibility requirements. The purpose of the Plan is to encourage and assist eligible employees of Animax to establish a regular savings program to provide additional security for their retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s management is responsible for overseeing the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Contributions

Each year, participants may contribute a percentage of their pre-tax or after-tax (Roth) annual compensation, as defined in the Plan. The Plan currently includes a Qualified Automatic Contribution Arrangement (“QACA”) Safe Harbor provision with auto-enrollment at 6% of eligible compensation. Under this provision, the Company makes Safe Harbor matching contributions of 100% of deferrals up to 1% of pre-tax compensation, as defined in the Plan, plus 50% of deferrals on the next 5% of compensation, measured on a pay period basis.

Participant Accounts

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

NOTE 1 - PLAN DESCRIPTION (Continued)

Investment Options

The Plan allows participants to direct the investment of their contributions into various investment options available under the Plan which are held by John Hancock Life Insurance Company (U.S.A.) (the “Plan Custodian”). Participants may change their investment options at any time.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service.

Employer QACA Safe Harbor contributions vest as follows:

<u>Years of Service</u>	<u>Percentage Vested</u>
Less than 2 years	0%
At least 2 years	100%

Upon the death or disability of a participant while an employee, the entire account balance becomes fully vested.

Payment of Benefits

On termination of services due to death, disability, or retirement, a participant or their beneficiary may elect to receive the participant’s vested balance in a lump-sum cash payment, partial withdrawals, or annual installments over a fixed period, if the balance is greater than \$5,000. For termination of service for other reasons, a participant may receive their vested balance as a lump-sum distribution.

Participants may elect to make an in-service withdrawal due to financial hardship only if the participant has an immediate and significant financial need and the withdrawal is necessary to meet such need. There were no unpaid amounts allocated to participants who elected to withdraw from the Plan at December 31, 2020.

Forfeited Accounts

Forfeitures represent non-vested portions of Employer contributions on the day of a participant’s termination or death, as defined. Forfeitures may be first used to pay any administrative expenses. Any remaining forfeitures are used to reduce Employer contributions. At December 31, 2020 and 2019, unallocated forfeited accounts totaled \$-0-, respectively. During the year ended December 31, 2020, approximately \$4,200 of forfeitures were used to reduce Plan expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value and are held in pooled separate accounts with the Custodian. The pooled separate accounts represent subaccounts under the group annuity contract with the Plan Custodian and are valued using a market valuation basis at the calculated net asset value ("NAV") of the funds. NAV is based upon the fair market value of the funds' underlying investments, less any fund liabilities.

Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of investments are recorded on a trade-date basis.

Investment Risk

The Plan's investments are not insured and are subject to credit and market risks. Financial information relating to those investments is included in these financial statements, based on information provided by the Plan Custodian.

The Plan's investments may be exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

Contributions

Employer and participants' contributions are recorded in the plan year in which the Employer makes the payroll deductions.

Payment of Benefits

Benefit payments to participants are recorded when paid. No amounts were allocated to accounts of individuals who have elected to withdraw.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administrative Expenses

Plan administration costs charged to the Plan for the year ended December 31, 2020 were approximately \$28,000. Certain other administration costs are paid by the Company. Investment fees, commissions, and related expenses are included in net change in fair value of investments in these financial statements.

Subsequent Events

In preparing these financial statements, the Company has evaluated events and transactions for potential recognition through February 13, 2024, the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN CUSTODIAN

The Plan Custodian holds the Plan's investments and executes all investment transactions. All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2020 and 2019, net change in fair value of investments, and dividends and interest for the year ended December 31, 2020, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan Custodian.

NOTE 4 - INCOME TAX STATUS

The Plan is designed to be a qualified trust under Section 401 of the Internal Revenue Code ("IRC") and is subject to the provisions of ERISA. The Plan adopted a Volume Submitter Plan which received a favorable opinion letter dated March 31, 2014, in which the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, qualified under Section 401 of the IRC. The Plan has been amended since receiving the most recent determination letter. The Plan administrator believes that the Plan, as currently amended, is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's accompanying financial statements.

NOTE 5 - FAIR VALUE MEASUREMENT

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right, under the Plan agreement, to discontinue all contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Animax is a party-in-interest as defined by ERISA. In addition, the Plan invests in pooled separate accounts with the Plan Custodian as defined by the Plan. Therefore, transactions with these parties qualify as party-in-interest transactions.

NOTE 8 - COVID-19 AND CARES ACT

In late 2019, a new coronavirus (“COVID-19”) was identified as the cause of a disease outbreak. In March 2020, the World Health Organization declared COVID-19 a pandemic. This pandemic has adversely affected global economic activity and greatly contributed to instability in financial markets. Because the values of the Plan’s individual investments have and will fluctuate in response to changing market conditions, the amount of losses that will be recognized in subsequent periods, if any, and related impact on the Plan’s liquidity cannot be determined at this time.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was signed into law. The CARES Act, among other things, added a new type of hardship withdrawal that waived the withdrawal penalty to participants that (1) were diagnosed with COVID-19, (2) had a spouse or dependent that were diagnosed; or (3) experienced adverse financial consequence as a result of being quarantined, furloughed or laid off, or having reduced work hours, or who were unable to work because of a lack of child care or the closing or reduced hours of a business they own or operate, or other factors, as determined by the Secretary of Treasury. The CARES Act also provided relief for payments due under notes receivable from participants by increasing the maximum borrowing amount to \$100,000 or 100% of the participant’s vested account balance, and permitting repayments of loans to be delayed by up to one year for qualifying participants. The CARES Act also allowed plans to suspend making the required minimum distributions in 2020 that would otherwise have been required. The above provisions were available for retirement plans, if adopted by Plan sponsor, until they expired on December 31, 2020. During the year ended December 31, 2020, management approved these provisions for Plan operation. The Plan had until December 31, 2022 to formalize these amendments.

NOTE 9 - PLAN OPERATIONAL FAILURES

During Plan years 2018 through 2020, the Employer incorrectly calculated certain employer contributions totaling approximately \$71,000. The Employer made corrective contributions to the Plan during Plan years 2021 and 2022.
