Attached please find the Final Form 5500-SF (Annual Return/Report of Employee Benefit Plan) filed with respect to the Unique-Prescotech, Inc. 401(K) Capital Accumulation Plan (the "Plan"), for the plan year ending December 31, 2023. Unique-Prescotech, Inc., the Plan Sponsor, filed a voluntary petition for relief under Chapter 7 of the United States Bankruptcy Code (the "Bankruptcy Code") on November 8, 2023. The Office of the United States Trustee appointed me to serve as the Chapter 7 trustee in the bankruptcy case (the "Bankruptcy Trustee").

As the Bankruptcy Trustee, and pursuant to section 704(a)(11) of the Bankruptcy Code, I shall continue to perform the obligations required of the administrator of the Plan. Accordingly, I have overseen the termination and liquidation of the Plan. I have signed the Final Form 5500-SF for the plan year ending December 31, 2023, solely in my capacity as the Bankruptcy Trustee. The third-party administrator for the Plan is Watkins Ross, which prepared the 2023 Final Form 5500-SF. As a result of the Plan Sponsor's bankruptcy, and given my limited role as Bankruptcy Trustee, I cannot confirm the accuracy of all the information contained in the 2023 Final Form 5500-SF (notwithstanding the fact that I have signed the form).
