Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mid America Pipe 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period January 1, 2023 through June 30, 2023, and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mid America Pipe 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1: Description of the Plan

General

The following description of Mid America Pipe 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the plan administrator.

The Plan is a defined contribution plan sponsored by Mid America Pipe Fabricating and Supply, LLC (Company) for the benefit of its employees who have one year of service (defined as the completion of at least 1,000 hours of service), excluding union employees, nonresident aliens, and leased employees. The Plan also includes employees of certain related companies as defined in the plan document. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). John Hancock Life Insurance Company (John Hancock) is the insurance company that serves as contract administrator. The trustees are responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Plan Merger

The Board of Directors of Mid America Pipe Fabricating and Supply, LLC, the Plan's sponsor, voted during 2022, to merge the Plan into G&A Partners Inc. Multiple Employer 401(k) Plan. On May 5, 2023, plan participants were notified that the plan sponsor intended to merge the Plan. The merger initiated a "Black Out" period beginning June 5, 2023 and continued through July 7, 2023. During this period, participants had limited access to their accounts until the recordkeeper and custodian had time to accurately complete the conversion. Plan assets transferred to the new custodians were transferred into funds comparable to those offered by the previous custodian. Effective January 1, 2023, all participants were eligible and contributing to the new plan, effectively leaving no contributions into the John Hancock plan during all of 2023.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, up to 100 percent, of eligible compensation contributed as pre-tax 401(k) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Notes to Financial Statements

June 30, 2023 and December 31, 2022

Each year, the Company may make matching contributions at the discretion of the Company's Board of Directors. For 2022, the Company made safe harbor matching contributions of 100 percent of employee salary deferral amounts in the amount of \$380,939. In addition, the Company may make a discretionary profit-sharing contribution. The Plan made no discretionary profit-sharing contribution for the period and year ended June 30, 2023 and December 31, 2022. Contributions are subject to certain limitations.

Participant Investment Account Options

Participants have the option of directing their contributions as well as the Company's contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service. The nonvested balance is forfeited upon termination of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age of 65, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. All loans are repayable over a period not to exceed five years (or 30 years in the case of a loan used to purchase the participant's principal residence) through payroll deductions unless the participant is paying the loan in full. The loan interest rate is set at 2 percent above the current prime rate, as defined.

Payment of Benefits

Participants may request to make a withdrawal of their contributions to the Plan due to financial hardship as defined by the Internal Revenue Code. Upon termination of service a participant whose account balance exceeds \$5,000 may elect to either remain in the Plan or receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In the event of default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative expenses may be paid by the sponsor or the Plan, at the sponsor's discretion.

On May 5, 2023, plan participants were notified that the plan sponsor intended to merge the Plan. The merger initiated a "Black Out" period beginning June 5, 2023 and continued through July 7, 2023. During this period, participants had limited access to their accounts until the recordkeeper and custodian had time to accurately complete the conversion. Plan assets transferred to the new custodians were transferred into funds comparable to those offered by the previous custodian. Note 1: Description of the Plan

General

The following description of Mid America Pipe 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the plan administrator.

The Plan is a defined contribution plan sponsored by Mid America Pipe Fabricating and Supply, LLC (Company) for the benefit of its employees who have one year of service (defined as the completion of at least 1,000 hours of service), excluding union employees, nonresident aliens, and leased employees. On May 5, 2023, plan participants were notified that the plan sponsor intended to merge the Plan. The merger initiated a "Black Out" period beginning June 5, 2023 and continued through July 7, 2023. During this period, participants had limited access to their accounts until the recordkeeper and custodian had time to accurately complete the conversion. Plan assets transferred to the new custodians were transferred into funds comparable to those offered by the previous custodian. Effective January 1, 2023, all participants were eligible and contributing to the new plan, effectively leaving no contributions into the John Hancock plan during all of 2023.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, up to 100 percent, of eligible compensation contributed as pre-tax 401(k) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Each year, the Company may make matching contributions at the discretion of the Company's Board of Directors. For 2022, the Company made safe harbor matching contributions of 100 percent of employee salary deferral amounts in the amount of \$380,939. In addition, the Company may make a discretionary profit-sharing contribution. The Plan made no discretionary profit-sharing contribution for the period and year ended June 30, 2023 and December 31, 2022. Contributions are subject to certain limitations.

Participant Investment Account Options

Participants have the option of directing their contributions as well as the Company's contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service. The nonvested balance is forfeited upon termination of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age of 65, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. All loans are repayable over a period not to exceed five years (or 30 years in the case of a loan used to purchase the participant's principal residence) through payroll deductions unless the participant is paying the loan in full. The loan interest rate is set at 2 percent above the current prime rate, as defined.

Payment of Benefits

Participants may request to make a withdrawal of their contributions to the Plan due to financial hardship as defined by the Internal Revenue Code. Upon termination of service a participant whose account balance exceeds \$5,000 may elect to either remain in the Plan or receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A lump-sum distribution will automatically be made for those terminated participants with an account balance of \$5,000 or less.

Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts are used to reduce future employer contributions. Forfeited accounts as of December 31, 2022, totaled \$4,163. During 2022, no forfeitures were used to reduce employer contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Pooled separate accounts are valued at estimated fair value as provided by John Hancock Life Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. A loan is considered to be in default if a participant fails to make all or any part of a required loan repayment by the end of the calendar quarter which follows the calendar quarter in which the repayment was due. In the event of default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the sponsor or the Plan, at the sponsor's discretion.
