## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of the  
Integrated Rehabilitation Services, LLC 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Integrated Rehabilitation Services, LLC 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of September 14, 2023 (date of liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits for the period January 1, 2023 through September 14, 2023 (date of liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of September 14, 2023 (date of liquidation) and December 31, 2022 (ongoing), and for the period January 1, 2023 through September 14, 2023 (date of liquidation), stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter—Basis of Accounting***

As discussed in Note 7 to the financial statements, the governing body of the Plan approved a plan of liquidation on May 31, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Integrated Rehabilitation Services, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees (as defined by the Plan) of Integrated Rehabilitation Services, LLC. (the “Company” or “Employer”) who have completed two months of service and 1,000 hours. Employees are eligible to participate in the Plan at the beginning of the following calendar month after they have satisfied the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On May 24, 2023, the trustees of the Plan approved termination of the Plan effective May 31, 2023. The Plan was fully liquidated as of September 14, 2023. See Note 7 for further information.

#### Participant Contributions

Prior to May 31, 2023, participants could make pretax and Roth contributions ranging from 1 percent to 100 percent of their earnings as elective contributions up to the limits prescribed by the Internal Revenue Service (“IRS”). The Plan also allowed for participants who are 50 years old or older to make catch up contributions up to the limits prescribed by the IRS.

Participants could modify their contribution percentage at their discretion. Participants were permitted to revoke their election at any time during the plan year. The modifications became effective as soon as administratively feasible.

#### Employer Contributions

The Company makes matching contributions equal to 25 percent of employee salary deferrals that do not exceed 6 percent of the participant’s eligible compensation. At its discretion, the Company may also make an additional contribution to the Plan for eligible participants, subject to limits for tax deductions under the Internal Revenue Code. The Company made aggregate matching contributions of \$26,971 for the period January 1, 2023 through September 14, 2023 (date of liquidation). The Company did not make any additional contributions to the Plan for the period January 1, 2023 through September 14, 2023 (date of liquidation).

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, plan earnings and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Withdrawals

Withdrawals prior to the age of 59½ are allowed only at termination of employment or for the purpose of a participant loan.

## **NOTE 1 - DESCRIPTION OF THE PLAN - (CONTINUED)**

### Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a rollover distribution paid directly to an eligible retirement plan. Participants with vested benefits of less than \$5,000 must elect a lump-sum payment. Benefits are recorded when distributed.

### Vesting

Participants are immediately vested in their contributions and Company contributions, and all earnings on those contributions.

### Forfeitures

At December 31, 2022, forfeited accounts totaled \$19,239. These accounts may be used to reduce Employer contributions and Plan expenses. During the period January 1, 2023 to September 14, 2023 (date of liquidation), \$17,345 and \$1,433 of forfeitures were utilized to reduce Employer contributions and Plan expenses, respectively.

### Investment Options

Participants may direct participant contributions, Employer contributions, and Employer discretionary contributions to various investment options available under the Plan.

### Plan Amendments

The Employer reserves the authority to amend certain provisions of the Plan by taking the appropriate action. However, any amendment may not eliminate certain forms of benefits under the Plan or reduce the existing vested percentage of the participants account balance derived from Employer contributions.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The 2023 financial statements were prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The 2022 financial statements were prepared using the going concern basis of accounting in accordance with GAAP.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefits are recorded when paid.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - (CONTINUED)

### Expenses

Expenses incurred in connection with the administration of the Plan may be paid from the net assets of the Plan unless paid by the Company. Administrative expenses of \$41,882 were incurred by the Plan for the period January 1, 2023 to September 14, 2023 (date of liquidation). All other expenses were paid by the Company. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

### Use of Estimates

The preparation of the Plan's financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Cash and Cash Equivalents

The Plan considers all highly liquid instruments with a maturity of three months or less to be cash and cash equivalents.

### Subsequent Events Measurement Date

The Plan has monitored and evaluated any subsequent events from September 14, 2023 (date of liquidation) through February 14, 2024, the date on which financial statements were available to be issued.

## NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification* ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;
- Level 2      Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability;
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### **NOTE 3 - FAIR VALUE MEASUREMENTS - (CONTINUED)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

As of December 31, 2022, all of the Plan’s investments, at fair value were mutual funds at Level 1 in the fair value hierarchy.

### **NOTE 4 - SUMMARY OF INFORMATION CERTIFIED BY THE CUSTODIAN OF THE PLAN**

Certain information related to investments disclosed in the accompanying financial statements, including investments, at fair value, held at December 31, 2022, and net appreciation in fair value of investments for the period January 1, 2023 to September 14, 2023 (date of liquidation), was obtained or derived from information supplied to the Company and certified as complete and accurate by Empower Trust Company, LLC (“Empower”).

### **NOTE 5 - TAX STATUS**

The IRS has informed the volume submitter plan sponsor, by an opinion letter dated May 26, 2021, that the Plan is acceptable under the appropriate sections of the Internal Revenue Code. The Plan is designed to constitute a qualified tax-exempt plan under section 401(a) of the Internal Revenue Code. As such, the Plan is exempt from federal income tax, and amounts contributed by the Employer will not be taxed to the participant until the participant receives a qualifying distribution from the Plan. The Plan has been amended since the date of the opinion letter, however the Employer believes that the Plan is operating in accordance with the applicable sections of the Internal Revenue Code. The Employer believes the Plan was terminated in accordance with IRS regulations.

Accounting principles generally accepted in the United State of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds held by Empower, who is the custodian of the Plan. The Plan also hires firms for investment advice and recordkeeping services. Fees incurred by the Plan to these firms were \$41,882 for the period January 1, 2023 to September 14, 2023 (date of liquidation).

**NOTE 7 - PLAN TERMINATION**

Effective May 31, 2023, the Employer terminated the Plan subject to the provisions of ERISA. Participants became 100 percent vested in their Employer contributions. As part of the Plan termination, participant balances of \$6,910,014 were distributed, and all plan assets were liquidated as of September 14, 2023.
