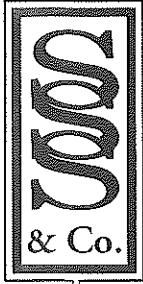

## INDEPENDENT AUDITOR'S REPORT

February 12, 2024

To the Administrative Committee of  
Unitex Union 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Unitex Union 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of May 30, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the periods then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 30, 2023 and December 31, 2022, and for the periods then ended, stating that the certified investment information, as described in Note 4 of the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material aspects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material aspects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis of Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date of the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material aspects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Supplemental Schedules Required by ERISA**

The supplemental schedule of Reportable Transactions for the period ended May 30, 2023 is presented for additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF PLAN

The following description of Unitex Union 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering members of the Laundry Distribution and Food Service Joint Board, Workers United/SEIU (the "Union") who work at the Unitex Textile Services LLC's ("Company's") Linden, NJ facility and have completed one year of service as of the plan entry dates (on the first day of each calendar quarter). It is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

On February 1, 2023, the Company resolved to merge the Plan's assets with the National Plus Plan, a defined contribution plan that covers union employees. The last employee contributions were made on February 15, 2023, and the Plan's total assets of \$186,632 were distributed to the National Plus Plan on May 30, 2023.

Contributions

In 2023 and 2022, participants were able to defer up to \$22,500 and \$20,500, respectively, of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions of \$7,500 for 2023 and \$6,500 for 2022. Those amounts may increase each year according to federal law. For 2023, total additions to a participant's account through salary deferral and employer matching and contributions may not exceed the lesser of \$66,000 or 100% of the participant's annual compensation. The compensation limitation is \$330,000 for 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participant contributions to the plan can be either pre-tax or Roth.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offered 14 mutual funds as investment options for the participants.

The Company makes a profit sharing contribution to each participant who has completed one year of service, in the amount of 1.85% of his or her annual gross wages, regardless of whether or not the participant makes deferrals. The participants must be employed on December 31 of the relevant year to receive the profit sharing contribution. This profit sharing contribution is to be made by the Company no later than January 31 of the following year. See Note 10 for details on the Company's 2023 contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings, and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF PLAN (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts plus actual earnings thereon is based on the elapsed time method. A participant is 100% vested after six years of credited service. Participants' accounts become fully vested in the event of death or total disability. As a result of the merger discussed in Note 1, the Plan's participants became fully vested in the Company's profit sharing contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and will bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator at loan inception. Principal and interest will be paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, or other reasons, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over any period not extending beyond the life expectancy of the participant and his or her beneficiary. Plan balances less than \$1,000 will automatically be distributed in a lump sum.

Forfeitures

Amounts forfeited by terminating participants of the Plan are reallocated upon termination. These amounts may be used by the Company to pay plan expenses or to pay company contributions to the Plan. There were no forfeitures at May 30, 2023 and December 31, 2022, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through February 12, 2024, which is the date the financial statements were available to be issued.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Corrective Distributions and Refunds Payable

Amounts payable to participants totaling \$17,539 for contributions in excess of amounts allowed by the IRS are recorded as corrective distributions and refunds payable, with a corresponding reduction to 2022 participant contributions. The Plan distributed the 2022 excess contributions prior to March 15, 2023. There were no excess contributions for the period ended May 30, 2023.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

The Company pays the financial advisory service fees and audit fees for the Plan, while the participants pay the administrative expenses for the Plan. Administrative expenses are comprised of small fees charged to participant accounts for specified services. There were \$0 and \$489 in administrative fees for the periods ended May 30, 2023 and December 31, 2022, respectively.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statement of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3 – FAIR VALUE MEASUREMENTS (continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 inputs were available to the Plan, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

*Level 1 – Quoted Prices in Active Markets for Identical Securities*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

*Level 2 – Other Significant Observable Inputs*

The fair values of other collective trusts are measured using a market approach based on quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.

NOTE 5 – PLAN TERMINATION

The Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination or merger, participants would become 100% vested in their employer contributions. Upon the merger of the Plan with the National Plus Plan effective February 1, 2023, participants became 100% vested in their employer contributions.

NOTE 6 – RECONCILIATION TO FORM 5500

As also discussed in the Emphasis of Matter section of the opinion to the financial statements, the Form 5500 is not prepared on the accrual basis. NOTE 7 - TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan was amended on March 12, 2021. The Plan administrators believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – RELATED PARTY TRANSACTIONS

As stated in Note 2, the Company pays financial advisor fees to Ascensus, Hooker & Holcombe and Vanguard Fiduciary Trust Company ("Vanguard") on behalf of the Plan. Ascensus, Hooker & Holcombe and Vanguard are fiduciaries as defined by ERISA, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Company to Ascensus amounted to \$250 and \$0 for the periods ended May 30, 2023 and December 31, 2022. Fees paid by the Company to Hooker & Holcombe for financial advisory services amounted to \$2,500 and \$6,250, respectively, for the periods ended May 30, 2023 and December 31, 2022. Fees paid by the Company to Vanguard amounted to \$10,746 and \$13,663, respectively, for the periods ended May 30, 2023 and December 31, 2022.

All of these party-in-interest transactions are exempt for the prohibited transaction rules of ERISA.

The Company paid the 2023 and 2022 profit sharing contributions of \$15,060 and \$99,820, respectively, to the National Plus Plan in September 2023.
