Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Anord Mardix (USA) 401(k) P/S Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of March 16, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits (in liquidation) for the period from January 1, 2023 through March 16, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of March 16, 2023 and for the year ended December 31, 2022, and for the period from January 1, 2023 through March 16, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 6 to the financial statements, Anord Mardix (USA) Inc. was acquired by an unrelated party, and the Plan began a termination process that concluded March 16, 2023. As a result, the Plan has changed its basis of accounting from the going concern basis to the liquidation basis used in presenting the 2023 and 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements (In Liquidation)

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

MARCH 16, 2023 AND DECEMBER 31, 2022

Note 1—Plan description

The following description of Anord Mardix (USA) 401(k) P/S Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all eligible employees of Anord Mardix (USA) Inc. (the “Company” and “Plan Sponsor”). An eligible employee is an individual employed by Anord Mardix (USA) Inc. or any affiliate who has adopted the Plan. To be eligible, an employee must complete three months of service and be at least 18 years of age. The term eligible employee shall not include Union employees and non-resident aliens. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (“ERISA”).

On March 27, 2020, Congress signed the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”). The CARES Act took immediate effect and contained several provisions that temporarily impact qualified plans, including a new hardship withdrawal option and a loan payment pause option. The Company incorporated these provisions into the Plan effective March 27, 2020.

Plan Administration – The Company is the Plan Sponsor and Plan administrator. Assets of the Plan are held by PAI Trust Company, Inc., the “Trustee” and “qualified institution” of the Plan. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan.

Contributions – The Plan provided for participant contributions of after-tax and pre-tax annual compensation, up to 100% of their annual compensation, as defined by the Plan. Participants who had attained the age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions were subject to certain limitations allowed under Section 402(g) of the Internal Revenue Code (“IRC”).

Due to the circumstances described in Note 6, the Company made no contributions for the period from January 1, 2023 through March 16, 2023.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Company’s contribution, (b) Plan earnings or losses, and (c) charged with an allocation of any administrative expenses and participant withdrawals. Allocations are based on participant earnings or account balances, as defined.

Vesting – Participants are 100% vested after three or more years of vesting service (0% vested if less than three years). A participant will also become fully vested upon attainment of normal retirement age while an employee, death while an employee or becoming disabled while an employee. A Year of Vesting Service is a period in which more than 1,000 hours of service are completed during the Plan year.

Investments Options – Participants direct the Trustee as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

Payment of Benefits – Distribution of the vested portion of a participant’s account will occur upon the participant’s termination of service, retirement, death, or disability. If a participant becomes entitled to receive their benefit for any reason other than death the account will be distributed in a lump-sum payment in an amount equal to the vested value of his/her account as defined by the Plan. On March 16, 2023, there were no benefit payments that had been requested but not yet paid, subject to the circumstances described in Note 6.

Forfeitures – Amounts forfeited from a participant’s account shall be used to restore forfeitures, reduce company contributions, or to pay reasonable Plan expenses. There were no forfeitures used in 2023 to reduce expenses. As of March 16, 2023 and December 31, 2022, the forfeiture balance was \$-0-.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”). Management determined that liquidation was imminent upon the governing body’s decision to terminate the Plan as described in Note 6. Accordingly, the Plan changed its basis of accounting from the ongoing basis to the liquidation basis as of and for the period from January 1, 2023 through March 16, 2023 and for the year ended December 31, 2022. Management determined that the liquidation value of the Plan’s investments approximated their fair value and no adjustment to the carrying amounts was necessary.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

Risks and Uncertainties – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are recognized in the period in which they occur. Interest and dividends are recognized in the period earned and realized gains or losses on securities are recorded in the period of sale. Net depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the period.

Payment of Benefits – Benefit payments are recorded when paid.

Administrative Expenses – The Plan permits the payment of Plan expenses to be made from the Plan’s assets. If expenses are paid using the Plan’s assets, then the expenses will generally be allocated among the accounts of all participants in the Plan.

Excess Contributions Payable – The Plan is required to make corrective distributions when the Internal Revenue Service (“IRS”) limits are exceeded due to excess contributions, which are returned to employees during the subsequent Plan year.

Note 3—Information prepared and certified by the qualified institution (unaudited)

The Plan management has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Pai Trust Company, the qualified institution of the Plan has certified to the completeness and accuracy of the following data included in the accompanying financial statements as of March 16, 2023 and December 31, 2022, and for the period from January 1, 2023 through March 16, 2023.

- Investments, at fair value, as shown on the statements of net assets available for benefits as of March 16, 2023 and December 31, 2022.
- Net appreciation in fair value of investments, including realized gains and losses, as shown in the statement of changes in net assets available for benefits for the period from January 1, 2023 through March 16, 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 4—Fair value measurements

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability and in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used to measure the Plan's investments at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There were no transfers between levels during the period from January 1, 2023 through March 16, 2023.

Note 4—Fair value measurements (continued)

The following is a description of the valuation methodologies used for assets measured at fair value:

Exchange Traded Funds – These investments are public investment vehicles valued using net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Below are the Plan’s financial instruments carried at fair value on a recurring basis by the fair value hierarchy levels described above. There were no investments at fair value as of March 16, 2023.

Note 5—Tax status

The volume submitter plan has received an opinion letter dated March 31, 2014, from the IRS stating that the written form of the underlying volume submitter plan document is qualified under Section 401(k) of the IRC and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(k) of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 16, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6—Plan termination

Effective November 30, 2021, Anord Mardix (USA) Inc. (the Plan Sponsor) was acquired by an unrelated party, and the Plan began a termination process that concluded March 16, 2023. Upon acquisition, all participants became fully vested and no further contributions were made. Beginning December 1, 2021, all participants became members of a separate plan, and had the option of receiving a distribution or a rollover to the new plan. Post-acquisition distributions and rollovers began in 2022 and concluded as of March 16, 2023.

Note 7—Related party and party-in-interest transactions

Certain expenses are paid to the qualified institution of the Plan for investment management services. Therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. During the period from January 1, 2023 to March 16, 2023, the Plan paid \$1,139 of administrative expenses to the qualified institution.

Note 8—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent to the statements of net assets available for benefits date of March 16, 2023 through February 1, 2024, which is the date these financial statements were available to be issued.
