No new accounting policies were adopted and the application of existing policies was not changed during the period from January 1, 2022 to March 31, 2022.

We noted no transactions entered into by the Plan during the year that were both significant and unusual, and of which, under professional standards, we are required to inform you, or transactions for which there is a lack of authoritative guidance or consensus.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The most sensitive accounting estimates affecting the financial statements are those relating to the fair value estimate of the Plan's investments. Management's estimate of these items is based on historical data and current information. We evaluated the key factors and assumptions used to develop the estimates and determined that they are reasonable in relation to the financial statements taken as a whole. Although the Plan's investments are generally based upon observable inputs and quoted market prices, it is at least reasonably possible that changes in the investments' fair values could occur in the near term and such changes could materially impact the financial statements. We believe these estimates are reasonable as of March 31, 2022 and the appropriate disclosures have been made in the Plan's financial statements.

The disclosures in the financial statements are neutral, consistent, and clear. Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the Plan's financial statements relates to fair value estimates.

#### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of the Plan's Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

#### *Difficulties Encountered During the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

#### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. There were no misstatements identified.

#### *Disagreements with Management*

## 1. Description of Plan

The following description of the Italian Rose Garlic Products, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan was a defined contribution plan covering substantially all employees of Italian Rose Garlic Products, LLC (the Company) who had completed three months of service and were age twenty-one or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management was responsible for oversight of the Plan as well as determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

On July 6, 2021, the Company's parent company, Perimeter Brands LLC, was acquired by Apollo BidCo, Inc. and as a result, Perimeter Brands LLC became a wholly-owned subsidiary of Apollo BidCo, Inc.

Effective February 28, 2022, the Plan merged into the Lakeview Farms, LLC 401(k) Plan, which is sponsored by another wholly-owned subsidiary of Apollo BidCo, Inc. As such, all of the Plan's net assets were transferred to the Lakeview Farms, LLC 401(k) Plan on March 31, 2022. There were no contributions made to the Plan in 2022 as employees of the Company were eligible to participate in the Lakeview Farms, LLC 401(k) Plan effective January 1, 2022.

### Contributions

Each year, participants may have contributed up to 90% of pretax annual compensation, as defined by the plan document up to the maximum limits of the Internal Revenue Code (IRC). Participants may have also designated all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who had attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may have also contributed amounts representing distributions from other qualified retirement plans. Participant contributions to the Plan were recorded in the period that payroll deductions were made from participants.

The Company made safe harbor matching contributions each pay period equal to 100% of the participant's elective deferrals, not to exceed 3% of the participant's eligible compensation. The Company may have also made a discretionary matching contribution as a percentage of eligible participant deferrals. The Plan also provided for a discretionary profit sharing contribution as determined by the Company's management. Participants directed the investment of all contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account was credited with the participant's contributions and the Company's contributions as well as allocations of the Plan's earnings. Participants were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

### **Vesting**

Participants were immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in discretionary matching and profit sharing contributions (if any) were based on years of continuous service. A participant was 20% vested after two years of credited service and 100% vested after an additional four years of credited service at a graded rate of 20% per year of service.

### **Notes Receivable From Participants**

Participants may have borrowed from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest was paid ratably through weekly payroll deductions. Terms ranged from one to five years or greater for the purchase of a primary residence.

### **Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may have elected to receive a lump-sum amount, installments or partial withdrawals equal to the value of the participant's vested interest their account. In-service distributions were permitted to participants who had reached the age of 59½. In addition, the Plan allowed for hardship distributions if certain criteria were met.

### **Forfeited Accounts**

At March 31, 2022, there were no forfeited non-vested accounts. At December 31, 2021, forfeited non-vested accounts were not significant. These accounts were used to reduce future Company contributions or to pay administrative expenses of the Plan. In 2022, forfeitures used to reduce Company contributions or pay administrative expenses were not significant.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's custodian and investment advisor. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net depreciation includes gains and losses on investments bought and sold as well as held during the period.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of March 31, 2022 and December 31, 2021.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

## Payment of Benefits

Benefits are recorded when paid.

## Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through January 27, 2023, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2022 and December 31, 2021.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan held no assets at fair value as of March 31, 2022. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021:

#### 4. Administration of Plan Assets

The Plan's assets were administered under a contract with Reliance Trust Company, the custodian of the Plan. The custodian invested funds received from contributions, investment sales, interest, and dividend income and made distribution payments to participants.

### **5. Related-Party and Party In Interest Transactions**

Fees incurred by the Plan for the investment manager services are included in net depreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issued loans to participants, which were secured by the participant's account balances. These transactions qualified as party in interest transactions.

Certain administrative functions of the Plan were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

### **6. Tax Status**

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Risks and Uncertainties**

Prior to the plan merger described in Note 1, the Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2021, the Plan had investments of \$1,472,064 that were concentrated in four funds.

### **8. Information Certified by Custodian**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for the period from January 1, 2022 to March 31, 2022 and for 2021. Accordingly, Reliance Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of March 31, 2022 and December 31, 2021 and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2022 to March 31, 2022.
