## **INDEPENDENT AUDITOR'S REPORT**

### **TO THE PLAN TRUSTEES OF CHR EMPLOYEES 401k PLAN:**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of CHR Employees 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

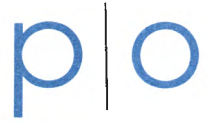
Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2022

#### Note:

#### **1. DESCRIPTION OF THE PLAN:**

The following description of CHR Employees 401k Plan, referred to as the “Plan”, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is sponsored by CHR Employees LLC, referred to as the “Company”. The purpose of the Plan is to allow eligible employees to accumulate funds on a tax-deferred basis, thereby promoting future retirement security.

The Plan is a defined contribution plan covering all eligible, nonunion employees of the Company. Employees become eligible for participation in the Plan after six months of service, worked a minimum of 500 hours in those six months, and are age 21 or older. Each participant has a separate account to which employer contributions, individual participant contributions, investment income and loss, and forfeitures are allocated in accordance with Plan provisions. The Plan consists of a 401(k) pay deferral plan with annual discretionary employer matching contributions.

All of the Plan’s assets are held in a trust fund which is the sole source of all benefit payments. The assets of the trust fund are not commingled with Company assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may elect to contribute to the Plan as 401(k) salary contributions of up to 100% of their eligible compensation, not to exceed a specific dollar amount determined by the Internal Revenue Service. For 2022, the dollar amount is \$20,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, the company may make a discretionary matching contribution. The Company matched 15% of employee contributions up to a maximum of \$1,500 per employee.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contributions, and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**1. DESCRIPTION OF THE PLAN (Continued):**

**Vesting**

Participants are immediately vested in their voluntary and rollover contributions, plus their actual earnings thereon. Vesting in the remainder of their accounts is based on each employee's length of service.

In the event of death, disability, or termination of the Plan, participants become fully vested in their account balance.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of: a) 50% of the value of the vested portion of the participant's total accrued benefits, or b) \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates determined to be the market prime rate plus 1%. All loans must be repaid by an assignment of wages sufficient enough to repay the loan and the accumulated interest within five years from the date the participant receives the loan from the Plan. A longer repayment period may be granted by the Trustees only if the loan is used to purchase or repair a primary residence.

All loans must be repaid on or before the participant reaches their normal retirement date. If the participant otherwise stops working for the company, the loan must be repaid in full within a reasonable amount of time as determined by the plan administrator, or the balance of the loan will be considered a distribution and the participant will become responsible for any taxes and penalties due as a result of the distribution.

**Payment of Benefits**

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount, in annual installments over a period not longer than the participant's life expectancy, or a direct rollover distribution. In-service distributions from a participant's vested account are available to participants over the age of 59½.

**Forfeitures**

Forfeitures are the nonvested amounts left in the Plan by terminating Participants. The Plan provides that forfeitures shall be used to offset the employer's contribution obligation. Forfeitures remaining after offset are held in a suspense account to offset future contributions. The plan administrator directs whether plan expenses are paid before either contributions are offset or forfeitures are re-allocated. During the year ended December 31, 2022, the amount of forfeitures used to pay plan expenses was \$5,524. No amounts were used to offset employer contributions. At December 31, 2022 and 2021, unallocated plan assets resulting from nonvested accounts totaled \$135,463 and \$131,890.

**Other Withdrawals**

The Plan permits hardship withdrawals from pre-tax 401(k) contributions. Hardship is defined as an immediate and heavy financial need of the Participant when lacking other available resources. Financial needs considered immediate and heavy include, but are not limited to expenses incurred or necessary for medical care (as described in Section 213(d) of the Internal Revenue Code) of the Employee, the Employee's Spouse or dependents; the purchase (excluding mortgage payments) of the principal residence for the Employee; payment of tuition and related educational fees for the next 12 months of post-secondary education for the Employee, the Employee's spouse, children or dependents; the need to prevent the eviction of the Employee from, or a foreclosure on the mortgage of, the Employee's principal residence; or funeral expenses of a member of the Participant's family.

**Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Excess Contributions Payable**

The Plan performs certain participant discrimination testing annually in accordance with ERISA. There were no excess contributions payable as of December 31, 2022 and 2021.

**Plan Amendment**

Effective January 1, 2022, the Plan adopted an amendment and restatement of the Plan which will allow for the option of different contribution rates for different employees and is referred to as a cross tested formula.

**Investment Product Type**

Plan management requested to change the Plan product type resulting in a new contract within Transamerica (the custodian of Plan assets) to allow for more diverse fund availability and a change in fee structure. The transfer of assets was completed April 19, 2021.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

Significant accounting practices and policies followed in the preparation of the accompanying financial statements are as follows:

**Method of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reported period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's assets are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Pooled separate accounts are valued at net asset value per share (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. The unallocated contract is a group annuity contract with Transamerica Life Insurance Company that invests in the general assets of Transamerica. Transamerica considers this contract to be benefit-responsive; however, since there are no specific securities in Transamerica's general account related to this contract and due to the contract terms, including the frequency of the interest rate reset intervals, contract value approximates fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Note 4 for more information.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation in the fair value of investments held at year-end and realized gains or losses on sales of investments during the year are determined using the beginning of the year fair value or purchase price if acquired subsequent to that date.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Net Appreciation (Depreciation) in the Fair Value of Investments**

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

**Operating Expenses**

Fees and expenses of the Plan can be paid by the Company or forfeiture account. For 2022, fees and expenses in the amount of \$5,524 were offset from the forfeiture account.

**3. CERTIFICATION OF FINANCIAL INFORMATION:**

The following financial data included in the accompanying financial statements and supplemental schedule as of and for the years ended December 31, 2022 and 2021 has been certified as complete and accurate by Reliance Trust Company, the trustee of plan assets, and has not been audited by the independent auditors for the Plan: investments at fair value, net appreciation in fair value of investments, investment income, notes receivable from participants, interest on notes receivable from participants, and the schedule of assets (held at end of year).

**4. INVESTMENT CONTRACT:**

The Plan has a fully benefit-responsive unallocated contract with Transamerica totaling \$264,997 for 2022 and \$280,932 for 2021. Transamerica maintains the contributions in its Stable Value Advantage Option investments. The account is credited with earnings and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single “portfolio rate” approach. Under this methodology, a single interest rate is applied to all contributions made to the product regardless of the timing of those contributions. Interest crediting rates are reviewed on a semi-annual basis and do not change for the six month period for which it is effective. When establishing interest credit rates for this product, Transamerica considers the current rate environment and seeks to protect against any loss of principal while providing returns in excess of money market funds and one-year U.S. Treasury bills. There is no minimum or maximum crediting rate.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan’s failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contract
3. Changes to the Plan’s prohibition on competing investment options
4. Plan termination or merger
5. Bankruptcy of the plan sponsor or other plan sponsor events that significantly affect the Plan’s normal operations

Generally, there are not any events that could limit the ability of the Plan to transact at contract value.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan’s investment guidelines
2. A breach or material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

**5. FAIR VALUE MEASUREMENTS:**

Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820, *Fair Value Measurements and Disclosure*, ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Registered Investment Companies:* Investments in registered investment companies are based on quoted net asset values of the shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. OTHER ASSETS:**

The Expense Budget Account may be used for plan expenses in accordance with the DOL's requirements. Any amounts are invested in the General Account of the insurance carrier. The Expense Budget Account is not available as an investment choice to participants. For 2022, amounts used to reduce Contract Asset Charges were \$26,656. At December 31, 2022 and 2021, the Expense Budget Account totaled \$7,837 and \$1,477, respectively.

**7. TAX STATUS:**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 15, 2011, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**8. CONCENTRATIONS:**

At December 31, 2022, there were three investment funds with individual balances over 10% of the total net assets available for benefits.

**9. PARTY-IN-INTEREST TRANSACTIONS:**

Parties in interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others.

All plan investments at December 31, 2022 were shares of registered investment companies (mutual funds) and the unallocated contract investment offered by the Transamerica Life Insurance Company. Accordingly, these investments qualify as party-in-interest investments. Additionally, the plan's third party administrator and plan auditor would also qualify as party-in-interests. Total administrative expenses paid by the plan's forfeiture account were \$5,524 for the year ended December 31, 2022.

Participants in the Plan are permitted to borrow funds from their vested balance as described in Note 1. These investments qualify as party-in-interest investments. Notes receivable from participants were \$3,101 and \$12,054 at December 31, 2022 and 2021, respectively.

**10. RISKS AND UNCERTAINTIES:**

The Plan provides for investments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risks associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**11. SUBSEQUENT EVENT:**

Subsequent events were evaluated through January 30, 2024, which is the date the financial statements were available to be issued.

As a result of a reduction of the Plan Sponsor's workforce in 2020 and 2019, the Plan experienced a partial plan termination as defined by ERISA in 2020. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan's participants are terminated because of an action taken by the Plan Sponsor. If a partial plan termination occurs, full vesting in the employer's matching contribution is required for the affected participants, but the remaining participants' vesting continues to be determined per the plan provisions.

In March 2023, but not finalized until January 2024, it was determined that certain participants who were included in the partial plan termination in 2020 and 2019 were entitled to receive back funds forfeited from their accounts due to errors in vesting calculations. Funds amounting to \$69,650 will be reallocated from the forfeiture accounts to the affected participants.
