## INDEPENDENT AUDITORS' REPORT

To the Participants and the Plan Administrator  
Cronin Auto, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Cronin Auto, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to July 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of July 31, 2023 and December 31, 2022 and for the period from January 1, 2023 to July 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

## **1. DESCRIPTION OF PLAN:**

The following description of the Cronin Auto, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan was a defined contribution plan covering all full-time employees of the Company, excluding collectively bargained employees, non-resident aliens and drivers, who have one year of service and are age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Administrator.

### **Plan merger**

Effective July 1, 2023, the Plan was merged into the TFO Advantage Pooled Employer Plan. As of July 14, 2023, all assets were transferred into the TFO Advantage Pooled Employer Plan. The Plan ceased to exist on this date as a result of these transactions.

### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to certain limitations established by law. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary match contributions. For the period from January 1, 2023 to July 31, 2023, the Company contributed 25% of the first 6% of eligible compensation that a participant contributed to the Plan, for a maximum of Company match of 1.5% of compensation. The Company may also make a discretionary non-elective contribution. No non-elective contributions were made in 2023.

### **Participant accounts**

Individual account balances were maintained for each participant. Each participant's account was credited with the participant's contributions and Company matching contributions, and Plan earnings and losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account. The Plan's investments were participant directed.

### **Vesting**

Participants were vested immediately in their voluntary contributions, catch-up contributions and rollover contributions, as adjusted for earning and losses thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after six years of credited service.

## **1. DESCRIPTION OF PLAN (CONTINUED):**

### **Forfeited accounts**

At July 31, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$-0- and \$3,146, respectively. Forfeitures were used to reduce Company contributions or pay administrative expenses of the Plan, as directed by the Company. During the period from January 1, 2023 to July 31, 2023 and the year ended December 31, 2022, nonvested forfeited accounts were not used to reduce Plan expenses.

### **Notes receivable from participants**

Prior to the merger, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account. The loan interest rate was determined at a rate commensurate with local prevailing rates. Principal and interest were paid ratably through bi-weekly or semi-monthly payroll deductions.

### **Payment of benefits**

On termination of service due to death, disability, or retirement, a participant may have elected to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may have received the value of the vested interest in his or her account as a lump sum distribution.

Participants were permitted in-service withdrawals at age 59 ½. Participants could request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined by the Plan. The Company must approve any such hardship withdrawals.

### **Administrative expenses**

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan were recorded as administrative expenses. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

## **2. SUMMARY OF ACCOUNTING POLICIES:**

### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## **2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED):**

### **Investment valuation and income recognition**

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

### **Notes receivable from participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of July 31, 2023 or December 31, 2022.

### **Payment of benefits**

Benefits are recorded when paid.

### **Subsequent events**

The Plan has evaluated subsequent events through January 31, 2024, the date the financial statements were available to be issued.

## **3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Newport Trust Company (the trustee), has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of July 31, 2023 and December 31, 2022, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the period from January 1, 2023 to July 31, 2023.

## **4. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### 4. FAIR VALUE MEASUREMENTS (CONTINUED):

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

As a result of the merger, the Plan did not have any investments at July 31, 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts. It is valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

**5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:**

Certain Plan investments were shares of mutual funds managed by Newport Trust Company. Newport Trust Company was the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services were included in net appreciation in fair value of the investment, as they were paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**6. TAX STATUS:**

The Company adopted a prototype plan. The Plan has received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**7. PLAN AMENDMENTS CARES ACT:**

The Plan Administrator has adopted the distribution relief provisions included in the CARES Act which permitted qualified individuals to request a pre-approved distribution, through participant self-certification of eligibility. The maximum dollar amount that could be requested per participant was \$100,000 up through December 30, 2020.

Additionally, the Plan Administrator has adopted the loan provisions included in the CARES Act which permitted qualified individuals to borrow from their fund accounts in the amount to the lessor of \$100,000 or 100% of the qualified individual's vested account during the period March 27, 2020 through September 21, 2020. Furthermore, qualified individuals were permitted to suspend loan repayments due between March 27, 2020 through December 31, 2020. Repayments on suspended loans were to re-commence on January 1, 2021 and the loan re-amortization period was extended up to twelve months from the original loan repayment end date.

The Company amended the Plan before the end of the applicable remedial amendment period to reflect such provisions.
