NOTE 1 - SUMMARY OF PLAN

In January 2023, the Plan Sponsor, the Chilcote Company, was purchased by Oliver Inc. As a result, the Board of Directors determined to terminate The Chilcote Company 401(k) Profit Sharing Plan, and subsequent asset distribution in the form of a rollover to a qualifying retirement plan, occurred on July 13, 2023.

The financial statements for the period ended July 13, 2023 and year ended December 31, 2022 are prepared using the liquidation basis of accounting.

General

The Chilcote Company 401(k) Profit Sharing Plan is a defined contribution plan covering all employees of The Chilcote Company. It became effective on January 1, 1994.

The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The more significant provisions of the Plan are as follows:

Eligibility

All employees of the Company are eligible to participate in the Plan after performing six months of service. Effective July 1, 2022 employees were eligible after performing 90 days of service and allowed for monthly entry dates. The Company excludes from eligibility leased employees, employees covered by a collective bargaining agreement and non-resident aliens.

Vesting Requirements

A separate account is maintained for each participant to record their share of contributions, forfeitures and investment income and losses. Participants are immediately vested in their contributions plus actual earnings thereon. The participant's portion of the Company matching contribution adheres to a six year graded vesting schedule. As of July 13, 2023 all participants are fully vested in their account due to the sale of the Company and subsequent Plan termination.

Contributions

Each year, plan participants may elect to contribute to the Plan, on a pretax basis or after tax basis, an amount up to 100% of their salary, subject to a limit of \$22,500 for 2023 and \$20,500 for 2023. These contributions will be tax-deferred within limits prescribed by the Internal Revenue Service. Eligible employees may elect to make catch-up contributions. Plan participants may also contribute amounts representing distributions from other qualified plans. All contributions are participant-directed. Effective July 1, 2022 the Plan has an automatic contribution rate of 4%. In addition, the Company, at its discretion, may make a contribution to the Plan in an amount not limited to its current or accumulated net profit which is determined by the Board of Directors. This contribution is allocated in the same ratio as compensation of each eligible participant. The employer match is the minimum of 25% of the deferred amount or 2% of compensation.

NOTE 1 - SUMMARY OF PLAN (CONTINUED)

Investment Options

Amounts contributed to the Plan are held in a trust created under the Plan. Upon enrollment in the plan, a participant may direct employee contributions into thirty-two different investment options.

Participants may change their investment options online, or over the phone through Principal Financial Group at any time.

Forfeitures

Nonvested account balances remaining in terminated participant accounts on the earlier of the last day of the fifth plan year after separation or the plan year in which the entire vested balance is removed from the account are forfeited. Forfeited balances are removed from the participant account and reserved to be used the following year to pay plan expenses or be reallocated to eligible active participants in the plan based on a ratio of a participant's annual salary compared to the total salary of all eligible participants. The total amount of forfeitures removed from participant accounts in the year period July 13, 2023 was \$1,273. Forfeited non-vested accounts totaled \$0 at July 13, 2023.

Payment of Benefits

In the case of normal retirement, retirement due to permanent disability or termination of employment, participants may elect to receive the value of their account balance either a lump sum distribution or as a rollover in whole to an eligible retirement plan, in accordance with the provisions of the Plan. Installment distributions are permitted for required minimum distributions only.

If a participant's vested balance is less than \$5,000 at the date of separation of service, the entire balance is distributed immediately in a lump sum. In the event that a participant dies before retirement, the beneficiary will receive the value of the participant's account balance either in a lump-sum distribution or as a rollover in whole to an eligible retirement plan.

Participants qualifying for a hardship withdrawal may receive all or a portion of their contributions, plus investment return earned thereon, but not more than the amount necessary to meet the financial hardship.

Note Receivables from Participants

Participants may borrow from their account any amount not less than \$1,000 and not greater than the lesser of 50% of their vested account balance or \$50,000. Only one loan from the Plan per participant may be outstanding at any time. The loans are secured by the balance in the participant's account. The interest rate will be based on the rates available for similar loans from commercial lending institutions. Participants with loan balance had interest rates ranging from 4.25% to 9.25% during the period ending July 13, 2023.

Principal and interest is paid ratably through monthly payroll deductions. Loan repayment terms may not be longer than 5 years, unless being used to purchase a primary residence. Loan origination fees of \$75 and quarterly loan maintenance fees of \$12 are paid by the participant requesting the loan.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of July 31, 2023 or December 31, 2022.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICES

Contributions

Contributions due from the Company, if any, are accrued when approved by the Board of Directors. Such accrued contributions are funded by the Company prior to filing its federal income tax return, including extensions.

Basis of Accounting

The accompanying financial statements are prepared on the liquidation basis of accounting, in conformity with generally accepted accounting principles.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts which approximates contract value for the fully benefit-responsive investment contracts held by the plan.

Valuation of Investments

The Plan's investments are administered by Delaware Charter Guarantee Trust Company d/b/a Principal Trust Company and are stated at fair value and contract value. The fair value of mutual funds is determined based on quoted market prices. Units held in pooled separate accounts are reported at fair value based on the unit prices quoted by the fund, representing the fair value of the underlying investments. Participant loans are valued at cost, which approximates fair value. Units of collective investment trusts are reported at fair value based on an analysis of the fair values of the underlying investments. Shares of the Fixed Income Guaranteed Option account are valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Distributions

Benefit distributions are recorded when paid to participants.

Administrative Expenses

The expenses necessary to administer the Plan are paid by the Plan or Plan sponsor including, but not limited to, those involved in retaining necessary professional assistance from an attorney, an accountant, an actuary or an investment advisor.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from estimates.

Risk of Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in value in the near term would materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

NOTE 3 - INCOME TAX STATUS

On June 27, 2022, the Plan was restated to use a prototype plan document sponsored by Principal Life Insurance Company. Principal Life Insurance Company received an opinion from the IRS, dated June 30, 2020, which states that the prototype document satisfies the provisions of Section 401 of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments in 2022 and 2023 are shares of funds managed by Delaware Charter Guarantee Trust Company d/b/a Principal Trust Company. Principal Trust Company is the current custodian, and therefore, these transactions qualify as party-in-interest transactions. Certain fees for administrative expenses are with the custodians and are not considered prohibitive transactions under ERISA. Participant loans also qualify as party-in-interest transactions.

NOTE 5 - INVESTMENTS

The Plan's investments are held by Principal Trust Company. Principal Trust Company maintains the investments in separate accounts, which comprise a significant portion (0.0%- 2023, 99.37%-2022) of the Plan's assets. The accounts are credited with earnings on the underlying investments and charged for plan withdrawals. With the exception of Principal Fixed Income Guaranteed Option, which is reported at contract value, the assets are reported at fair value by Principal Trust Company and are certified as of July 13, 2023 and 2022 as to the completeness and accuracy of the information reported. Investment income totaled \$996,086 for the year ended July 13, 2023. Unrealized gains on investments totaled \$966,594 for the year ended July 13, 2023. Realized gains on investments totaled \$7,921 for the year ended July 13, 2023. Reinvested dividend income totaled \$19,463 for the year ended July 13, 2023.

NOTE 6 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Statement *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at July 13, 2023 and December 31 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered by the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Pooled separate accounts (PSA) are not publicly quoted, however the majority of the underlying securities (mutual funds and domestic stocks) are level 1 assets and the fair value is publicly quoted and is used in determining the net asset value of the PSA.

Collective Investment Trusts: The Collective Investment Trusts (CIT) are not publicly quoted. The CIT's invest in a collective trust fund and a variety of separate accounts and mutual funds.

NOTE 6 - FAIR VALUE MEASUREMENTS (CONTINUED)

The mutual funds are level 1 assets with publicly quoted fair value. The trust fund has audited financials available and the pooled separate accounts are valued as previously described. The fair value of all of these investments is used in determining the net asset value (NAV) of the CIT. ASC 820 allows NAV per share to serve as a practical expedient to estimate fair value of a CIT as long as certain requirements are met. It is Principal's assessment that this CIT meets those requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan is invested in Principal Fixed Income Guaranteed Option, a benefit-responsive group annuity contract issued by Principal Life Insurance Company. The methodology for calculating the interest crediting rate is defined in Article I, Section 2 of the contract under the term “Composite Crediting Rate.” Under the terms of the existing contract, the Composite Crediting Rate is currently reset on a semiannual basis and will never be less than the Guaranteed Minimum Interest Rate.

The Principal Fixed Income Guaranteed Option is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a Stable Value fund. As a result, the average yield earned by the plan is the yield earned (i.e. interest credited) on the group annuity contract.

The Composite Crediting Rate history for the contract is as follows:

By definition, the Principal Fixed Income Guaranteed Option group annuity contract is an insurance contract. As a result, the plan may transact according to the terms defined in the contract at any time. The terms and methods under which the contract may transact are defined in Article II (Deposits and Ownership – Vintage – Primary), Article IIA (Deposits and Ownership – Vintages – Subsequent), Article IIB (Vintages), Article III (Fees), Article IV (Benefits and Other Payments) and Article V (Limitations; Termination) in the contract.

NOTE 7 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (CONTINUED)

Article V of the contract defines the circumstances and amounts for which the plan may terminate its interest in the contract. The issuer, Principal Life Insurance Company, has the right to no longer receive deposits under Article VII, Section 3. However, the circumstances for termination of the contract are still subject to Article V.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (3) the failure of the trust to qualify for exemption from federal income taxes of any required prohibited transaction exemption under ERISA, or (4) premature termination of the contract. No events are probable of occurring that might the liability of the Plan to transact at contract value with the contract issuers and that would also limit the ability of the Plan to transact at contract value with the participants.

NOTE 8 - INFORMATION CERTIFIED BY THE TRUSTEE

At July 13, 2023 and December 31, 2022, the Plan's investments were held by Delaware Charter Guarantee Trust Company d/b/a Principal Trust Company.
