Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - 2021 Financial Statements***

The accompanying statement of net assets available for benefits of the Plan as of December 31, 2021 was not audited, reviewed, or compiled by us and, accordingly, we do not express an opinion or any other form of assurance on the 2021 financial statements.

### 1. Description of the Plan

The following description of the Amergint Technologies, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan was adopted effective January 1, 2010 and restated effective June 1, 2021 by Amergint Technologies, Inc. (the Company or Employer), the sponsor of the Plan. The Plan was a defined contribution plan covering substantially all employees of the Company, as defined below. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective October 26, 2021, the Plan administrator approved the Plan merger of the Plan into the ARKA Group, L.P. Retirement Savings Plan (the ARKA Plan). No participants were allowed to enter the Plan after January 3, 2022. All participants were fully vested in their account balances, and the account balances were merged into the ARKA Plan on January 10, 2022.

#### *Trustee and Administration of the Plan*

Ascensus Trust Company and The Vanguard Group, Inc. on behalf of Ascensus, LLC were the trustee and recordkeeper of the Plan, respectively. The administrator of the Plan was the Company. The trustee held all assets of the Plan in accordance with the service provider contract with the Company.

#### *Eligibility*

Employees of the Company were considered eligible for participation, except for: (1) nonresident aliens with no U.S. source of income, (2) employees covered by a collective-bargaining agreement that does not provide for participation in the Plan, and (3) leased employees.

Participants must have been 21 years of age to participate in the Plan. An eligible participant could enter the Plan immediately upon meeting the eligibility requirements.

#### *Contributions*

Each year, participants could contribute a percentage of eligible compensation, not to exceed the limits imposed by the Internal Revenue Service (IRS). The Plan also allowed for Roth contributions.

Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company contributed 3% of the participant's eligible compensation in a Plan year. Additionally, the Company could make a non-elective discretionary contribution (profit-sharing contribution) to the Plan. No employer contributions were made for the period from January 1, 2022 through January 10, 2022.

Participants directed the investment of their contributions into various investment options offered by the Plan.

### ***Participant Accounts***

Each participant's account was credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants were entitled was the vested portion of their accounts.

### ***Vesting***

Participants were 100% vested in all participant and employer contributions.

### ***Payment of Benefits***

A participant's entire interest in the Plan was payable upon death; attainment of normal retirement age; becoming disabled, as defined; or termination of service. A participant could elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments. Participants could elect to rollover their vested balance to another qualified retirement plan or individual retirement account (IRA).

Withdrawals from the Plan could also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants could also withdraw an amount at age 59½ if certain criteria were met.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments were stated at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in the fair value of investments included the Plan's gains and losses on investments bought and sold, as well as held during the year.

Benefits were recorded when paid.

### **3. Certified Investment Information**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of January 10, 2022 and December 31, 2021 (unaudited).
- Net depreciation in fair value of investments as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 through January 10, 2022.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodology used at January 10, 2022 or December 31, 2021 (unaudited). The following is a description of the valuation methodology used for assets measured at fair value:

*Mutual Funds* - Mutual funds were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-ended funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments measured at fair value on a recurring basis:

### 5. Related Party and Party-in-Interest Transactions

Certain Plan investments were in funds and accounts that were managed by the trustee. These transactions were party-in-interest transactions, which were exempt from prohibited transaction rules.

### 6. Risks and Uncertainties

The Plan held various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 7. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. On October 26, 2021, as described in Note 1, the Company resolved to merge the Plan into the ARKA Plan effective January 10, 2022. Participants continued to be 100% vested in their accounts as of the Plan merger date.

### **8. Tax Status**

The Plan used a prototype plan document sponsored by Ascensus LLC. Ascensus LLC received an opinion letter from the IRS, dated January 1, 2018, which stated that the prototype plan document, as then-designed, satisfied the applicable provisions of the Internal Revenue Code (IRC). Although the Plan had been amended since the date of the opinion letter, Plan management believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **9. Transfer to Other Qualified Plan**

Effective January 10, 2022, the Plan merged into the ARKA Plan. The net assets of the Plan totaling \$17,922,972 were transferred.

### **10. Subsequent Events**

The Plan has evaluated subsequent events through February 15, 2024, the date the financial statements were available to be issued.
