## **Report of Independent Auditors**

To the Plan Administrator of Tejas Industries, Inc. 401(k) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Tejas Industries, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period January 1, 2023 through July 31, 2023, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 31, 2023 and December 31, 2022, and for the period January 1, 2023 through July 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

**(1) Description of Plan**

The following description of the Tejas Industries, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**(a) General**

The Plan, which was adopted on August 1, 2006, was a defined contribution plan established for the exclusive benefit of the participating employees of Tejas Industries, Inc. (the Employer, the Plan Sponsor, or the Company), a wholly owned subsidiary of Merrick Pet Care Holdings Corp. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan's recordkeeper was Transamerica Life Insurance Company ("Transamerica") and Reliance Trust Company was the custodian of the Plan's assets.

On December 20, 2019, the Setting Every Community Up for Retirement Enhancement Act (SECURE Act) was passed into law. The SECURE Act allowed participants turning age 70 ½ during 2020 or subsequent to defer required minimum distributions until age 72. The Plan adopted the provisions of the SECURE Act.

The Plan was amended and restated effective February 8, 2022 to incorporate required law changes to comply with the requirements of the 2017 Cumulative List (Notice 2017-37), which the Plan was subject to as a pre-approved plan of Transamerica.

The Plan was amended effective January 1, 2023 to cease safe harbor employer contributions, and instead implement employer matching contributions of 100% of the first 3% of employee deferrals and 50% of the next 2% of employee deferrals.

The Plan was amended effective January 1, 2023 to reflect immediate vesting for employer matching and nonelective contribution sources.

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act was signed into law. Effective January 1, 2023, the SECURE Act 2.0 updated certain rules related to required minimum distributions (RMDs), special distribution provisions (related to hardship, penalty-free early distributions and birth and adoption distributions), Roth employer contributions, employer-funded participation financial incentives and plan corrections.

The Plan was merged into the Nestlé 401(k) Savings Plan effective July 31, 2023. To facilitate this transition, there was a blackout period from mid-July to mid-August 2023. During this time, participants were not able to enroll in the Plan, change their contribution rate, transfer money between investment options, obtain a withdrawal, loan or distribution, or payoff an outstanding loan.

**(b) Eligibility**

The Plan covered all employees of the Company (excluding union employees and nonresident aliens) who were at least 18 years of age and had at least three months of service. Employees were eligible to participate in the Plan upon the first day of each month.

**(c) Contributions**

The Plan allowed employees to contribute up to 25% of their eligible compensation on a pre-tax or after-tax basis, provided that contributions did not exceed Internal Revenue Service ("IRS") limitations. The Employer allowed employees who had attained age 50 before the close of a Plan year to make a catch-up contribution subject to IRS limitations. The amount of the catch-up contribution was eligible for matching contributions under the Plan. Eligible employees were automatically enrolled in the Plan at the first of the month when the employee became eligible, at a deferral rate of 3% of compensation. The Plan also provided an automatic increase in these deferrals of 1% each year, up to 5%. Employees could opt out of the Plan or choose a different salary deferral percentage at any time. These discretionary employee contributions were made under a salary reduction program.

The Employer matched participant contributions to the Plan in an amount equal to 100% of the first 3% of employee deferrals and 50% of the next 2% of employee deferrals. Additional qualified discretionary contributions could also be made to non-highly compensated employees at the discretion of the Employer. Discretionary contributions were allocated to eligible employees in proportion to their compensation as a percentage of total compensation of all eligible employees. Employees' accounts were credited with their respective contributions, including employer contributions. For the Plan period January 1, 2023 to July 31, 2023, there were no nonelective contributions made.

**(d) Investment Options**

Participants could direct employee deferrals, employee rollovers, and employer contributions in 1% increments, provided all increments summed to 100%, to their choice of the investment options offered by the Plan, which included various mutual funds.

**(e) Notes Receivable from Participants**

Notes receivable from participants consisted of participant loans that were secured by the balance in the participant's account. The minimum loan was \$1,000 and the maximum loan allowed was the lesser of \$50,000 or 50% of the vested interest of the participant's account balance in the Plan. Only one loan could be taken out by a participant at a time. Loans to participants were secured by the participant's account balance. The loans bore interest at the prime rate of interest published by local banks and lending institutions as of the date of the loan. Principal and interest were paid ratably through weekly payroll deductions. Loans that were considered in default were deemed an in-service withdrawal, which is a taxable event for the participant. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.

**(f) Vesting and Forfeitures**

Employee deferral contributions were 100% vested at all times. Participants were vested 100% in all employer contributions made. If the employer made nonelective contributions (i.e. profit sharing contributions), the participants vested based on years of continuous service at the rate of 20% each year after two years of service, with 100% vesting at six years of service. Forfeitures available at July 31, 2023 and December 31, 2022, were \$0 and \$3,029, respectively. Forfeitures, if any, were used to pay plan expenses or reduce employer contributions. For the period January 1, 2023 to July 31, 2023, no employer contributions or Plan expenses were paid from forfeitures.

**(g) Payment of Benefits**

Upon separation from service with the Company due to death, disability, retirement, or termination, a participant could elect to receive either a full or partial withdrawal of his or her vested account balance, which was paid out in a lump sum or substantially equal installments. A participant whose vested account balance was \$5,000 or less and had not commenced receiving installment payments automatically received an immediate lump-sum distribution equal to his or her vested account balance.

In-service withdrawals were available in certain limited circumstances, as defined by the Plan. Hardship withdrawals were allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals were strictly regulated by the IRS, and a participant must have exhausted all available distributions prior to requesting a hardship withdrawal.

**(h) Participant Accounts**

A separate account was maintained for each participant in each designated fund. Each participant's account was credited with the participant's contribution and an allocation of the Employer's contribution, Plan earnings (losses), and certain administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**(2) Summary of Accounting Policies**

**(a) Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(c) Valuation of Investments**

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation included the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the period.

**(d) Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. Delinquent participant loans were reclassified as distributions based on the terms of the Plan agreement. No allowance for credit losses was recorded as of July 31, 2023 or December 31, 2022.

**(e) Payment of Benefits**

Benefits payments were recorded when paid.

**(f) Administrative Expenses**

Certain Plan expenses (such as investment-related fees and recordkeeping fees) were recorded as an offset to investment income. Certain expenses associated with specific participant activity (such as participant loan fees) were charged directly to the participant's account and were included in administrative expenses. Unless otherwise paid by the Plan, certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements.

**(3) Financial Data Certified by the Plan's Custodian**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, certain information related to investments and participant loans disclosed in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants at July 31, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2023 to July 31, 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Reliance Trust Company, the custodian of the Plan.

**(4) Fair Value Measurements**

The Plan's investments were reported at fair value in the accompanying statements of net assets available for benefits. The accounting framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's valuation methodology used to measure the fair values of mutual funds is based on quoted market prices, as substantially all of these instruments are traded on active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

**(5) Income Tax Status**

The underlying non-standardized pre-approved plan had received an opinion letter from the IRS dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the Internal Revenue Code (the "Code") and, therefore, the related trust was tax-exempt. The plan administrator has determined that it was eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan was required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan was being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan was qualified and the related trust was tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain tax positions taken or expected to be taken. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(6) Parties-in-Interest Transactions**

The Employer provided certain administrative services to the Plan at no cost. Certain Plan investments were shares of mutual funds managed by Transamerica.

Transamerica was the participant recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan had notes receivable from participants, which qualify as parties-in-interest to the Plan and were exempt from prohibited transaction rules.

In October 2022 and February 2023, invoices for ERISA legal counsel were paid out of the Plan in error, for expenses that related to Plan Sponsor activities. This resulted in non-exempt transactions with a party-in-interest. The Plan was reimbursed in July 2023 for the non-exempt transactions and the related lost earnings were calculated and remitted in August 2023. These prohibited transactions are reflected on Schedule G of the 2023 Form 5500, and are included as a supplemental schedule herein.

**(7) Plan Termination**

Although it had not expressed the intent to do so, the Employer had the right to terminate the Plan subject to the provisions of ERISA. Effective July 31, 2023, the Plan was merged into the Nestlé 401(k) Savings Plan.

**(8) Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**(9) Subsequent Events**

The Plan has evaluated subsequent events through February 22, 2024, the date these financial statements were available for issuance, and determined that there were no events or transactions which require recognition or disclosure in these financial statements.
