All Plan assets were transferred to the LG Chem America Retirement Plan and Trust on June 13, 2023. Our opinion is not modified with respect to this matter.

Due to the merger and transfer of Plan assets into the LG Chem America 401(k) Retirement Plan and Trust, all Plan assets are deemed to be transferred from the Plan as of June 13, 2023 on the Form 5500; therefore, there are no Plan assets as of that date to report on the supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. As such, the supplemental schedule of assets (held at end of year) as of June 13, 2023 is not presented with these financial statements.

#### ***Note 1 - Plan Description***

The following description of the Uniseal 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan covering all eligible employees of Uniseal, Inc. (Company) who have attained 21 years of age and two months of service (60 days), except for employees who are non-resident aliens who have no earned income from sources within the United States. Eligible employees are automatically enrolled in the Plan. The Plan is subject to the provisions of ERISA. The 401(k) Committee is responsible for oversight of the Plan. The 401(k) Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

The assets of the Plan were merged into the LG Chem America 401(k) Retirement Plan and Trust effective June 1, 2023, and the transfers were completed on June 13, 2023.

##### *Contributions*

Each year, participants may contribute up to 50 percent of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at five percent of eligible compensation and their contributions invested in T. Rowe Price Retirement Target funds based on birth date until changed by the participant. The Company elected a discretionary Safe Harbor matching contribution equal to 100 percent of the participant's voluntary contribution up to three percent and 50 percent of the next two percent, but not in excess of five percent of the participant's Plan compensation. The matching Company contribution is invested directly in the participants' investment allocation. Additional non-elective amounts may be contributed at the option of the Company's Board of Directors. During the period ended June 13, 2023, the Company did not elect to make a non-elective contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Company's Safe Harbor matching contributions, and discretionary non-elective contributions (if any), as well as allocations of Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are vested immediately in their contributions and Safe Harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary non-elective contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service. A participant also becomes 100 percent vested upon death, disability, or reaching normal retirement age, as defined by the Plan.

##### *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in a series of installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may request a hardship withdrawal of a portion of their account attributable to participant deferrals. Any hardship withdrawal is limited to the amount needed to meet the financial need.

##### *Forfeited Accounts*

At June 13, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$9,385, respectively. These accounts may be used to offset Plan expenses or reduce future employer contributions. During 2023, \$11,372 of forfeitures were transferred to the LG Chem America 401(k) Retirement Plan and Trust as part of the Plan merger. There were no forfeitures utilized by the Plan during 2023 prior to the merger.

#### ***Note 2 - Significant Accounting Policies***

##### *Basis of Accounting*

The financial statements of the Plan are prepared under the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

#### *Note 3 - Summary of Financial Data Certified by the Trustee*

#### *Note 4 - Fair Value Measurements*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

As of June 13, 2023, there were no Plan assets.

Following are descriptions of the valuation methodologies used for assets measured at fair value as of December 31, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

*Collective trust funds:* The Plan contained both a stable value collective trust fund as well as an S&P 500 indexed collective trust fund. The Putnam Stable Value Fund is a collective trust fund valued at the NAV of units of a common collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

The Putnam S&P 500 Index Fund is a common collective trust fund that provided for daily redemptions by the Plan at reported NAV with no advance notice requirement. The NAV as provided by the Trustee is used as a practical expedient to estimate fair value. Under unusual circumstances, redemptions may be suspended should the withdrawal cause a material adverse impact on other participating plans. Fair values for the investments within the index fund are based on quoted prices in active markets and securities valued using either observable inputs or quotations from inactive markets. The Plan is permitted to redeem investment units at NAV on the measurement date.

#### **Note 5 - Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments were shares of mutual funds and collective trust funds managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the Trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Some fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments of \$37,401 to other service providers that are also considered party-in-interest transactions, which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

#### **Note 6 - Plan Termination**

As disclosed in Note 1, the Plan merged with another plan effective June 1, 2023.

#### **Note 7 - Tax Status**

The Plan adopted a nonstandardized pre-approved profit sharing/money purchase plan with Cash or Deferred Arrangement sponsored by Empower Retirement, LLC. The Plan has received an opinion letter from the IRS as to the Plan's qualified status. The Plan Sponsor can rely on the qualified status to the extent the Plan Document does not deviate from the IRS pre-approved provisions. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code (IRC) and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.
