INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Luke & Associates, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021 and the related statement of changes in net assets available for benefits for the year then ended December 31, 2022, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following description of Luke & Associates, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Luke & Associates, Inc. (the “Sponsor” or “Company”) is the plan sponsor. The Plan is a defined contribution plan established in July 2005. The Plan has been amended and restated throughout the years to comply with tax legislation and was most recently restated and amended effective June 1, 2019. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Board of Directors of the Sponsor are responsible for the oversight of the Plan.

Eligibility

Company employees are eligible to participate in the deferral, discretionary matching component, and discretionary profit-sharing component of the Plan immediately upon turning 18 years of age. There is no service requirement for eligibility.

Contributions

Subject to certain limitations, under the Code Section 401(k), participants may contribute up to the maximum amount allowed by law, with 2022 annual limits of \$20,500 and an additional \$6,500 for catch-up contributions for participants that are age 50 or older. A participant may stop or change their election to contribute at any time. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

Matching and profit-sharing amounts may be contributed at the option of the Company’s Board of Directors. For the years ended December 31, 2022 and 2021, the Company did not elect to make any matching or profit sharing contributions.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company’s contributions, (b) plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions as well as any rollover contributions plus actual earnings or losses thereon. Vesting in the Company’s matching and profit-sharing contribution portions of their accounts, plus actual earnings thereon, is based on years of service. An employee must work at least 1,000 hours during each Plan Year to earn a year of vesting service.

Vesting (continued)

A participant is 100% vested after five years of service, based on the following schedule:

| 3 years | 60% |

Participants automatically become 100% vested upon death or termination due to disability.

Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount or partial payments not to exceed the participant's vested interest in his or her account.

Forfeitures

Forfeitures shall be used to first reduce plan expenses, and then to reduce employer contributions. Any remaining forfeitures shall be allocated to participants in the same proportion that each participant's compensation for the year bears to the compensation of all participants for such year. There were no forfeited non-vested accounts allocated or unallocated at December 31, 2022 and 2021 and there were no forfeited non-vested accounts used to reduce plan expenses or employer contributions in either year.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management and the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The units of pooled separate accounts are stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Individual participant accounts invested in the pooled separate accounts are maintained on a unit value basis.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses that are directly related to the value of the investments under management are paid by the Plan and allocated to the individual participant accounts on a pro rata basis based on their account balances. Other administrative expenses are paid by the Company.

Income Taxes

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 740, Income Taxes, prescribes a recognition threshold and measurement attribute of the financial statement recognition and measurement of a tax position taken or expected to be taken in a tax return.

Management evaluates the Plan's tax positions on an annual basis for any uncertain positions, both past and current. If management determines that a past and/or current tax position is uncertain and is more likely than not to be unsustainable under audit, then a valuation allowance is recorded. As of December 31, 2022, management has determined that all past and current tax positions were likely to be realizable and sustainable upon examination and that the calculation of a tax liability was not necessary.

Tax years ended December 31, 2019 through 2021 remain subject to possible examination by the Internal Revenue Service.

Subsequent Events

Plan management has evaluated subsequent events and transactions that occurred after December 31, 2022 up to the date that the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2 Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Pooled separate accounts: Valued using third party pricing services. These services use, for example, model-based pricing methods that use observable market data as inputs. Broker dealer bids or quotes of securities with similar characteristics may also be used.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – TAX STATUS

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. The Plan holds investments managed by John Hancock Life Insurance Company, the trustee of the Plan, which qualify as party-in-interest investments. The Plan's payments of custodial fees to the trustee, as well as audit fees, qualify as party-in-interest transactions.



