Opinion on Financial Statements

We have audited the financial statements of Sunland Asphalt Employee Stock Ownership Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of February 28, 2023 and December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the period ended February 28, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of February 28, 2023 and December 31, 2022 and 2021, and the changes in its net assets available for the period ended February 28, 2023 and the year ended December 31, 2022, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Plan Liquidation Basis of Accounting

As further described in Note 1 to the financial statements, the Plan Sponsor, Sunland Holdings Company (formerly Sunland Asphalt & Construction, Inc.), terminated the Plan effective January 13, 2021. In accordance with accounting principles generally accepted in the United States of America, the Plan uses liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. (1) Description of the Plan

The following description of the Sunland Asphalt Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Sunland Asphalt Employee Stock Ownership Trust (the "Trust") is the trust established under the Plan.

A. General - Sunland Asphalt & Construction, Inc. (the "Company") established the Plan effective as of January 1, 2009. Effective, January 1, 2013, the Plan was amended and restated. The Plan operated as a leveraged employee stock ownership plan ("ESOP") and was designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended ("IRC"), and was subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan was administered by the Plan Committee and a Plan Administrator, comprising persons appointed by the Company's Board of Directors. Miguel Paredes was the Trustee of the Plan. Effective December 21, 2020, Sunland Holding Company became the plan Sponsor and assumed and undertook all such obligations with respect to the trustee of the Trust. The Trust exchanged all of its shares of the Company for Shares of Sunland Holding Company as of December 21, 2020. Therefore, Sunland Holding Company held the ESOP shares for the benefit of the participants of the ESOP at December 31, 2020.

On January 13, 2021 ("Termination Date") 100% of the Company's stock was purchased by Huron Capital, a private equity company. As part of this transaction, the Company changed its name to Sunland Asphalt & Construction, LLC. Immediately thereafter, the ESOP was terminated and all of the Company's shares held by the ESOP were redeemed by the Trust for \$33,500,000 as full consideration for the redemption. The proceeds of the sale were allocated to each participant's other investment account in the ratio in which the cumulative number of shares allocated to the Company stock account bears to the total cumulative number of shares of the Company stock allocated to participant accounts. All participants who had not incurred forfeitures as of January 1, 2020 become 100% vested. On October 4, 2022, the Plan received a favorable determination letter to terminate the Plan. No new employees were eligible to participate in the Plan, and no contributions were authorized after the Termination Date. The investments of the Trust was limited to investments intended to preserve the principal of such assets consistent with the requirements of ERISA. The Trust continued to be maintained until the accounts of all participants were distributed, which occurred in February 2023.

Prior to the Termination Date, employees of the Company became eligible to participate in the Plan retroactively to the first day of the Plan year in which the employee completed one year of service and had attained 21 years of age. For purposes of eligibility, a year of service was defined as the completion of 1,000 hours of service by an employee. Eligible employees could enter the Plan on the first day of January of each year.

B. Contributions - Prior to the Termination Date, the Company could make a discretionary contribution that would be expected to be sufficient to meet the minimum debt service requirements. There were no contributions authorized by the Company for the period ended February 28, 2023 or the year ended December 31, 2022.

C. Dividends and other income - The declaration of dividends by the Company or other distributions made by the Company on shares owned by the Plan was discretionary. No dividends were declared for the period ended February 28, 2023 or the year ended December 31, 2022.

D. Participant accounts - The Plan was a defined contribution plan under which a separate individual account was established for each participant. Prior to the Termination Date, each participant's account was credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. In order to be credited with an allocation, the employee had to have worked at least 1,000 hours during the Plan year or their death, disability or retirement date must have fallen within the Plan year. Allocations of contributions were based on a participant's eligible compensation, relative to total eligible compensation. Allocations of Plan earnings were based on participant account balances as defined in the Plan document. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

E. Vesting - Prior to the Termination Date, participants vested in the Company's contributions, plus earnings thereon, based on years of service as follows:

F. Forfeitures - Forfeitures of nonvested accounts were allocated to remaining Plan participants in accordance with the Plan document. During the period ended February 28, 2023 and the year ended December 31, 2022, there were no forfeitures of non-vested accounts and there were no forfeited non-vested accounts as of February 28, 2023 and December 31, 2022 and 2021.

G. Payment of benefits - Distributions from the Plan for reasons of death, disability, retirement or attaining normal retirement age as defined in the Plan agreement were to commence as soon as administratively feasible following the end of the Plan year in which such event occurred. Distributions from the Plan for reasons other than death, disability, retirement or attaining normal retirement age for participants with balances exceeding \$25,000 generally were made during the sixth Plan year following the Plan year in which the participant's employment was terminated.

Prior to the Termination Date, account balances exceeding \$25,000 were paid in equal annual installments over a 5-year period. If total vested value of the account was \$25,000 or less, distribution was made in a lump sum as soon as administratively feasible after the close of the Plan Year in which employee terminated.

Effective as of the Termination Date, participants were able to elect to receive a cash distribution of up to 75% of their entire vested balance as of December 31, 2020 prior to the receipt of a favorable determination letter from the IRS. Upon receipt of a favorable determination letter, participants were able to receive a distribution of their remaining balance.

H. Termination of the Plan - The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company terminated the Plan effective January 13, 2021 and all participant's became 100% vested in their account balances.

- I. Administrative expenses** - Administrative expenses were paid by the Company. There were certain expenses of the Plan paid for by the Company that were not expected to be reimbursed by the Plan. There were no administrative expenses paid by the Plan during the period ended February 28, 2023 and during the year ended December 31, 2022.
- J. Voting rights** - The Trustee voted all Company stock held as part of the Plan's assets. However, each participant was entitled to direct the Trustee as to the manner in which voting rights on the Company's common stock attributable to the shares allocated to his or her account are to be exercised.
- K. Put option** - Under federal income tax regulations, employer stock that is held by a plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option was a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price was representative of the fair market value of the stock. The Company was able to pay for the purchase with interest over a period of five years. The purpose of the put option was to ensure that the participant has the ability to ultimately obtain cash.
- L. Diversification** - Prior to the Termination Date, diversification was offered to eligible participants so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. A participant who had attained age 55 and completed 10 years of participation in the Plan could have elected to diversify a portion of their account. Diversification was offered to each eligible participant over a six-year period. During the first five years, a participant could diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changed to 50 percent.

(2) Summary of significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting - The Plan was terminated effective January 13, 2021. As a result, the Plan's financial statements as of February 28, 2023 and December 2022 and 2021, and for the period ended February 28, 2023 and the years ended December 31, 2022 and 2021, have been prepared on the liquidation basis in accordance with U.S. GAAP.

Management's use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Actual results could differ from those estimates.

Investment valuation - Shares of the Company's common stock were valued at fair market value, which was determined by an annual independent appraisal. Purchases and sales of investments were recorded on a trade date basis. Income was recorded on the accrual basis. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits paid to participants are recorded in the period in which they are paid.

(3) Fair value measurement

The investments in the Plan were stated at fair value in accordance with the Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement* ("ASC 820"). ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

There were no investments held by the Plan as of February 28, 2023 and December 31, 2022 and 2021.

(4) Income tax status

The Plan received a favorable determination letter dated November 14, 2014 from the Internal Revenue Service stating that the Plan was qualified, and the trust established under the Plan is tax-exempt, under the appropriate sections of the IRC. The Company and the Plan Administrator believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC through its termination.

(5) Subsequent events

Subsequent events - The Plan has evaluated subsequent events through October 11, 2023 which is the date the financial statements were available to be issued.
