## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). As a result, all investments were transferred from the Plan into the Clean Harbors 401(k) Plan on July 31, 2023. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

**NOTE A – DESCRIPTION OF PLAN**

The following description of the Thompson Industrial Services, LLC (“the Company”) 401(k) Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General.* The Plan is a defined contribution plan covering substantially all employees of the Company who have completed three months of service. For matching and discretionary contributions, employees will be eligible if they have completed 1,000 hours and one year of service. Service with the following predecessor employers shall be counted for eligibility purposes: Thompson Construction Group, Inc. and Petrochem Services Group, Inc. (if a part of the acquisition on November 16, 2018). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors performance.

*Contributions.* Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate. The automatic deferral rate begins at 3% and increases 1% each year up to a maximum of 10% and are invested in a designated balanced fund until changed by the participant. The Company matches 50% of the first 3% of eligible compensation that a participant contributes to the Plan. For the seven-months ended July 31, 2023 and for the year ended December 31, 2022, the Company made discretionary matching contributions equal to \$153,588 and \$397,107, respectively. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors.

*Participant Accounts.* Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting.* Participants are immediately vested in their contributions plus actual earnings thereon. The Company’s discretionary match and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service and a participant is 100% vested after six years of credited service.

*Notes receivable from participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The outstanding notes are secured by the Participant's account and bear interest at reasonable fixed rates ranging from 4.25% to 9.25%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through weekly payroll deductions.

*Payment of benefits.* On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

*Forfeited Accounts.* At July 31, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$25,559, respectively. In 2023, the entire forfeited nonvested accounts were transferred from the Plan into the Clean Harbors 401(k) Plan on July 31, 2023.

*Merger.* On March 31, 2023, the Board of Directors of Clean Harbors, a controlling party of Thompson Industrial Services, LLC approved the merger of this Plan into the Clean Harbors Savings and Retirement Plan ("Clean Harbors 401(k) Plan"), effective August 1, 2023. As a result, all investments were transferred from the Plan into the Clean Harbors 401(k) Plan on July 31, 2023.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates.* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

*Investment Valuation and Income Recognition.* Investments held by a defined contribution plan are required to be reported at fair value (except for fully benefit-responsive investment contracts, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

The Plan's investments are stated at fair value. All Plan assets were transferred to the Clean Harbors 401(k) Plan before close of business on July 31, 2023.

*Notes Receivable From Participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of July 31, 2023 or December 31, 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Excess Contributions Payable.* Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. At July 31, 2023, there were no excess contributions accrued and no corrections were required to be made.

*Payment of Benefits.* Benefits are recorded when paid.

*Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation of fair value investments.

*Subsequent Events.* Subsequent events were evaluated through February 27, 2024, which is the date the financial statements were available to be issued.

**NOTE D – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820 Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in the active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2023 and December 31, 2022.

*Mutual Funds.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Changes in Fair Value Levels:* The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The plan administrator evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the seven-months ended July 31, 2023, all assets were transferred out of levels 1, 2, or 3.

**NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

As detailed in Note B, the Plan sponsor pays for the Plan audit and certain plan administrative expenses. Therefore, the transactions of both the Plan auditor and Plan sponsor are party-in-interest transactions. Further, certain Plan investments are managed by Fidelity Investments Institutional Operations Company (“FIIOC”). FIIOC is wholly owned by Fidelity Workplace Services, the recordkeeper, as defined by the Plan. The Plan assets paid FIIOC \$30,193 for recordkeeping services. Additionally, the Plan assets paid USI Advisors, Inc. \$19,391 for investment advisory services.

**NOTE F – PLAN TERMINATION**

As stated in Note A, the Company was acquired by Clean Harbors on March 31, 2023. The Plan was merged into another plan on July 31, 2023. Participants became 100% vested in their employer contributions.

**NOTE G – TAX STATUS**

The Plan has not obtained a determination letter from the Internal Revenue Service (“IRS”) stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan is relying on the IRS approval of the non-standardized prototype plan that it is utilizing. The IRS determined and informed Fidelity Management & Research Co. on March 31, 2014 that the prototype Plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator believes the Plan has undertaken no uncertain positions as of July 31, 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
