## Independent Auditors' Report

The Plan Administrator and Plan Participants  
Associated Home Care, LLC 401(K) Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of the Associated Home Care, LLC 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of September 30, 2023, and the related statement of changes in net assets available for benefits for the period from March 30, 2023 through September 30, 2023, and the related notes to the financial statements.

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to the Financial Statements

(1) Description of plan

The following description of the Associated Home Care, LLC 401(K) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan which was established on March 30, 2023 to provide retirement benefits for employees of Associated Home Care, LLC (the "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was established when assets totaling \$2,944,573 were transferred into the Plan from the Amedisys Holdings, LLC 401(k) Plan. In connection with the sale of Associated Home Care, LLC on February 10, 2023, the Plan was terminated effective March 30, 2023. Participants became 100% vested in their accounts, and all assets were distributed by September 30, 2023, the date of final termination.

(b) Contributions

Participants are not permitted to make contributions to the Plan.

(c) Participant accounts

Each participant's account is credited (charged) with the transferred assets, and allocations of investment earnings (losses), and administrative expenses. Allocations are based on participant's compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

All account balances are fully vested.

(e) Payment of benefits

A participant's account was distributed based upon the participant's election under the Plan document upon retirement, death, disability or termination of employment. Retirement was defined under the Plan document as age 65. In-service withdrawals were permitted upon the attainment of age 59½. For participants, who do not elect for their distribution, who have a balance exceeding \$1,000 but less than \$5,000, there will be a mandatory distribution made in the form of a rollover into an IRA.

(f) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the processing of distributions are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits were recorded when paid.

(3) Certified information

Certain information reported and disclosed in the accompanying financial statements, including net appreciation in fair value of investments, interest and dividend income and interest on notes receivable from participants for the period from March 30, 2023 to September 30, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Bank of America, N.A. ("BoA").

(4) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved 401(k) profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the non-standardized pre-approved plan was designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(5) Related party and party-in-interest transactions**

As described in Note (1), the Plan paid expenses to various service providers, which qualify as party in interest transactions.

**(6) Risks and uncertainties**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
