Report on the Audit of the Financial Statements

Opinion on the 2021 and 2022 Financial Statements

We have audited the accompanying financial statements of City Pipe & Supply Corp. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits in liquidation as of February 3, 2022, December 31, 2021 and December 31, 2020, and the related statements of changes in net assets available for benefits in liquidation for the period ended February 3, 2022 and the year ended December 31, 2021, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits in liquidation of City Pipe & Supply Corp. Employee Stock Ownership Plan as of February 3, 2022, December 31, 2021 and December 31, 2020, and the changes in its net assets available for benefits in liquidation for the period ended February 3, 2022 and the year ended December 31, 2021, in accordance with accounting principles generally accepted in the United States of America.

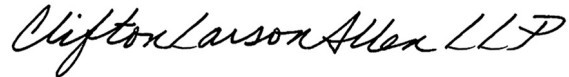

NOTE 1 DESCRIPTION OF PLAN

The following description of the City Pipe & Supply Corp. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

City Pipe, Inc. (Company) established the Plan effective January 1, 2005. The Plan was last restated effective January 1, 2016 to conform to recent tax legislation and last amended effective December 31, 2019 to terminate the Plan. The Plan is a defined contribution plan intended to constitute an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC). The Plan covers all employees of the Company who had completed the eligibility requirements including the completion of one year of service. An eligible employee began participation on the first day following the completion of the eligibility requirements. The Plan was designed to invest primarily in securities issued by the Company and is authorized to borrow money for such investments. It is subject to the provisions of ERISA, as amended

Plan Termination

Effective August 19, 2019, the Company entered into a Stock Purchase Agreement providing for the sale of all the Company's issued and outstanding common stock held by the Plan with to Russell Metals (an unrelated entity). Pursuant to the Stock Purchase Agreement, the stock was sold and the Plan was frozen. Participants became 100% vested in their accounts on August 19, 2019 and therefore there were no changes to vesting provisions. The Plan was terminated effective December 31, 2019.

The Company filed a determination letter request with the Internal Revenue Service (IRS) on April 22, 2020 and received a favorable determination letter dated November 17, 2020. Subsequently, the interests of each participant in the trust fund were distributed to such participant or his or her beneficiary by February 3, 2022.

Contributions

The Plan was frozen August 19, 2019, and no further contributions to the Plan were made by the employer. Contributions by Plan participants are not permitted by the Plan.

Payment of Benefits

The amount to be distributed is based upon the account valuation date immediately preceding the distribution.

Vesting

Effective August 19, 2019, all participants became 100% vested.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting in conformity with accounting principles generally accepted in the United States of America. The Plan terminated effective December 31, 2019 and received IRS approval to terminate on November 17, 2020 which is the date that management determined liquidation was deemed imminent. In accordance with a accounting principles generally accepted in the United States of America, the Plan prepared these financial statements on the liquidation basis of accounting.

Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. Investment earnings which were reasonably estimated at December 31, 2020 were included in accrued income expected to be earned in liquidation in the statement of net assets in liquidation available for benefits. Expenses which were reasonably estimated at December 31, 2020 were included in accrued expenses expected to be incurred in liquidation in the statement of net assets in liquidation available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Purchases and sales are recorded on a trade-date basis. Investment income is recorded on the accrual basis.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2022, the date the financial statements were available to be issued.

NOTE 3 OTHER RECEIVABLES

Other receivables reflected on the statement of net assets available for benefits in liquidation as of December 31, 2020 are due from Russell Metals and were collected in 2021. Amounts related to the settlement of excess escrow funds from the sale of company stock in 2019 are recorded as other income during 2020 when such amounts became estimable, approximately \$6.2 million.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2021 and 2020.

The Money Market Fund is valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

NOTE 5 PLAN TAX STATUS

The Plan has been designed to qualify under Section 401(a) of the IRC. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 401(a). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. On November 17, 2020 the IRS approved the termination of the Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits in liquidation.

NOTE 7 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets are held by the trustee of the Plan. The trustee makes distributions to participants. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
