### **Emphasis of Matter – Plan Merger**

As described in Note A to the financial statements, the Plan authorized a merger with the Zelis Healthcare 401(k) Retirement plan effective January 30, 2023 and transferred all assets by April 30, 2023.

### Note A – Description of Plan

The following description of the Payspan Inc. 401(k) Plan and Trust (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan that was established effective January 1, 1998 and was most recently restated January 1, 2021. All full-time employees of Payspan, Inc. (the “Company” or the “Employer”) are eligible to participate after attaining the age of 21 and upon completion of three months of service. Employees become participants on the first day of the month coinciding with or next following the date they satisfy the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan authorized a merger with the Zelis Healthcare 401(k) Retirement plan effective January 30, 2023. The Plan assets were transferred by April 30, 2023.

#### Administration

The accounting records are maintained by the Company. The Plan’s assets for the year were held and managed by Voya Institutional Trust Company (the “Custodian”). Contributions are held by the Custodian, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

#### Contributions

Participants may contribute up to 90% of pre-tax annual eligible compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. The maximum participant deferral for the period from January 1, 2023 to April 30, 2023 was \$22,500. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service (“IRS”) limitations of \$7,500 for the period from January 1, 2023 to April 30, 2023.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated qualified default investment alternative fund until changed by the participant. The deferral rate is set to increase by 1% annually, not to exceed 10% of eligible compensation. Automatically enrolled participants may elect to increase or decrease percentages and may elect to stop the auto-increase, within the Plan’s provisions.

The Company may make matching contributions, at its discretion, as a percentage of the participant’s elective deferrals to the Plan.

Participants may make Roth deferral contributions to the Plan. The Plan also allows participants to contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan.

There were no participant or Employer contributions for the period from, January 1, 2023 to April 30, 2023, the date all assets were distributed from the Plan (in liquidation) as described in Note B.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and the Company’s matching or non-elective contribution amounts, if applicable. Each participant’s account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant’s account. Allocations of Plan earnings or losses are based on each participant’s investment fund balance in proportion to the total investment fund balance.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in Employer matching contributions is based on years of continuous service. Participants must work at least 1,000 hours during the year to be credited with a year of service. A participant is 100% vested upon death, disability, retirement age, or after five years of credited service as follows:

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime lending rate at the date of the loan, which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Loan terms may not exceed five years, unless the loan is used for the purchase of a primary residence. No more than two loans may be outstanding at a time for a participant and loans may not be consolidated or refinanced.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon terms of the Plan document. Loans are considered in default as of the end of the quarter subsequent to the quarter in which the payment was due.

#### Distribution of Benefits

On termination of service due to death, disability or retirement, a participant (or beneficiary) may elect to receive his or her account balance as a lump-sum distribution or in installment payments. Participants may not withdraw their contributions until they attain age 59½ years, prove a financial hardship under specific circumstances, or terminate employment. In the event of a financial hardship withdrawal, the participant is precluded from making contributions to the Plan for six months following the distribution.

#### Forfeitures

For both April 30, 2023 and December 31, 2022, forfeited non-vested accounts totaled approximately \$0 and \$41,000, respectively. During the period from January 1, 2023 to April 30, 2023, the Company used approximately \$42,000 of its forfeitures for Plan expenses.

#### Plan Termination

As described in Note A, the Company amended the Plan effective January 30, 2023 to terminate the Plan and distribute its assets in accordance with the provisions provided by ERISA. The Plan has determined that the liquidation basis presentation of the assets for the Plan period ended April 30, 2023, the date all assets were distributed from the Plan, and for the period from January 1, 2023 to April 30, 2023, approximate or equal fair market value. No significant changes were required to present the financial statements on a liquidation basis. As of January 30, 2023, in accordance with the Plan adoption agreement, all participants' balances became fully vested in all types of contributions received in the Plan. All appropriate accounting provisions of the Plan continued to apply until the accounts of all participants had been distributed.

### Note B – Summary of Significant Account Policies

#### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

#### Valuation of Investments

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as described in Note G. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the valuation policies utilizing information provided by the Custodian. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded at the ex-dividend date.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

#### Fair Value Measurements (continued)

<i>Level 1</i>	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
<i>Level 2</i>	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means.  If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
<i>Level 3</i>	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used from the period January 1, 2023 to April 30, 2023 and the year ended December 31, 2022.

*Money market funds:* Valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Valued at the NAV provided by the Custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments as of April 30, 2023 and December 31, 2022.

Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at April 30, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 to April 30, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian, a qualified institution. As of April 30, 2023 and December 31, 2022, and for the period from January 1, 2023 to April 30, 2023, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note D – Income Tax Status

The Plan has received a determination letter from the IRS dated June 30, 2020 stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation under Section 401 of the IRC. The Plan Administrator and its qualified tax counsel do not anticipate that changes in the Plan after the date of the amendments covered by the IRS determination letter will affect the qualified and tax-exempt status of the Plan.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

### Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note F – Party-In-Interest Transaction

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are managed by the Custodian. Transactions related to these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as exempt party-in-interest transactions. Fees to parties-in-interest by the Plan for services amounted to approximately \$17,000 during the period from January 1, 2023 to April 30, 2023.

### Note G – Fully Benefit-Responsive Investment Contracts

The Plan invests in a guaranteed interest account (Voya Fixed Account, “the Fund”) provided through a group annuity contract. Under the Fund, a crediting rate is established and is credited with contributions and charged for participant withdrawals and administrative expenses charged by the custodian of the Fund. The guaranteed interest account issuers are contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan,) (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exempt under ERISA. Effective January 30, 2023 the Plan terminated and as of April 30, 2023 the Plan had no fully benefit-responsive investment contracts.

### Note H – Subsequent Events

Subsequent events have been evaluated through March 1, 2024, which is the date the financial statements were available to be issued.

### **Emphasis of Matter – Plan Merger**

As described in Note A to the financial statements, the Plan authorized a merger with the Zelis Healthcare 401(k) Retirement plan effective January 30, 2023 and transferred all assets by April 30, 2023.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ### Note A – Description of Plan

The following description of the Payspan Inc. 401(k) Plan and Trust (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan that was established effective January 1, 1998 and was most recently restated January 1, 2021. All full-time employees of Payspan, Inc. (the “Company” or the “Employer”) are eligible to participate after attaining the age of 21 and upon completion of three months of service. Employees become participants on the first day of the month coinciding with or next following the date they satisfy the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan authorized a merger with the Zelis Healthcare 401(k) Retirement plan effective January 30, 2023. The Plan assets were transferred by April 30, 2023.

#### Administration

The accounting records are maintained by the Company. The Plan’s assets for the year were held and managed by Voya Institutional Trust Company (the “Custodian”). Contributions are held by the Custodian, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

#### Contributions

Participants may contribute up to 90% of pre-tax annual eligible compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. The maximum participant deferral for the period from January 1, 2023 to April 30, 2023 was \$22,500. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service (“IRS”) limitations of \$7,500 for the period from January 1, 2023 to April 30, 2023.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated qualified default investment alternative fund until changed by the participant. The deferral rate is set to increase by 1% annually, not to exceed 10% of eligible compensation. Automatically enrolled participants may elect to increase or decrease percentages and may elect to stop the auto-increase, within the Plan’s provisions.

The Company may make matching contributions, at its discretion, as a percentage of the participant’s elective deferrals to the Plan.

Participants may make Roth deferral contributions to the Plan. The Plan also allows participants to contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan.

There were no participant or Employer contributions for the period from, January 1, 2023 to April 30, 2023, the date all assets were distributed from the Plan (in liquidation) as described in Note B.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and the Company’s matching or non-elective contribution amounts, if applicable. Each participant’s account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant’s account. Allocations of Plan earnings or losses are based on each participant’s investment fund balance in proportion to the total investment fund balance.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in Employer matching contributions is based on years of continuous service. Participants must work at least 1,000 hours during the year to be credited with a year of service. A participant is 100% vested upon death, disability, retirement age, or after five years of credited service as follows:

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime lending rate at the date of the loan, which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Loan terms may not exceed five years, unless the loan is used for the purchase of a primary residence. No more than two loans may be outstanding at a time for a participant and loans may not be consolidated or refinanced.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon terms of the Plan document. Loans are considered in default as of the end of the quarter subsequent to the quarter in which the payment was due.

#### Distribution of Benefits

On termination of service due to death, disability or retirement, a participant (or beneficiary) may elect to receive his or her account balance as a lump-sum distribution or in installment payments. Participants may not withdraw their contributions until they attain age 59½ years, prove a financial hardship under specific circumstances, or terminate employment. In the event of a financial hardship withdrawal, the participant is precluded from making contributions to the Plan for six months following the distribution.

#### Forfeitures

For both April 30, 2023 and December 31, 2022, forfeited non-vested accounts totaled approximately \$0 and \$41,000, respectively. During the period from January 1, 2023 to April 30, 2023, the Company used approximately \$42,000 of its forfeitures for Plan expenses.

#### Plan Termination

As described in Note A, the Company amended the Plan effective January 30, 2023 to terminate the Plan and distribute its assets in accordance with the provisions provided by ERISA. The Plan has determined that the liquidation basis presentation of the assets for the Plan period ended April 30, 2023, the date all assets were distributed from the Plan, and for the period from January 1, 2023 to April 30, 2023, approximate or equal fair market value. No significant changes were required to present the financial statements on a liquidation basis. As of January 30, 2023, in accordance with the Plan adoption agreement, all participants' balances became fully vested in all types of contributions received in the Plan. All appropriate accounting provisions of the Plan continued to apply until the accounts of all participants had been distributed.

### Note B – Summary of Significant Account Policies

#### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

#### Valuation of Investments

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as described in Note G. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the valuation policies utilizing information provided by the Custodian. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded at the ex-dividend date.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

#### Fair Value Measurements (continued)

<i>Level 1</i>	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
<i>Level 2</i>	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means.  If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
<i>Level 3</i>	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used from the period January 1, 2023 to April 30, 2023 and the year ended December 31, 2022.

*Money market funds:* Valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Valued at the NAV provided by the Custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments as of April 30, 2023 and December 31, 2022.

Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at April 30, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 to April 30, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian, a qualified institution. As of April 30, 2023 and December 31, 2022, and for the period from January 1, 2023 to April 30, 2023, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note D – Income Tax Status

The Plan has received a determination letter from the IRS dated June 30, 2020 stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation under Section 401 of the IRC. The Plan Administrator and its qualified tax counsel do not anticipate that changes in the Plan after the date of the amendments covered by the IRS determination letter will affect the qualified and tax-exempt status of the Plan.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

### Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note F – Party-In-Interest Transaction

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are managed by the Custodian. Transactions related to these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as exempt party-in-interest transactions. Fees to parties-in-interest by the Plan for services amounted to approximately \$17,000 during the period from January 1, 2023 to April 30, 2023.

### Note G – Fully Benefit-Responsive Investment Contracts

The Plan invests in a guaranteed interest account (Voya Fixed Account, “the Fund”) provided through a group annuity contract. Under the Fund, a crediting rate is established and is credited with contributions and charged for participant withdrawals and administrative expenses charged by the custodian of the Fund. The guaranteed interest account issuers are contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan,) (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exempt under ERISA. Effective January 30, 2023 the Plan terminated and as of April 30, 2023 the Plan had no fully benefit-responsive investment contracts.

### Note H – Subsequent Events

Subsequent events have been evaluated through March 1, 2024, which is the date the financial statements were available to be issued.
