## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and  
Plan Participants and Beneficiaries of  
the Advanced Revenue Management LP 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Advanced Revenue Management LP 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, the governing body of Advanced Revenue Management LP 401(k) Plan approved a plan of liquidation effective July 31, 2022, and management determined liquidation is imminent. As a result, Advanced Revenue Management LP 401(k) Plan has changed its basis of accounting from the going-concern basis of accounting to the liquidation basis used in presenting the financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Advanced Revenue Management LP 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

SEPTEMBER 30, 2023 AND DECEMBER 31, 2022

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Advanced Revenue Management LP 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan provisions.

General

The Plan, as amended and restated, was established January 1, 2008 as a defined contribution plan covering all eligible employees of Advanced Revenue Management LP (the "Company") except non-resident aliens, employees covered by a collective bargaining agreement, and employees of Northwest Anesthesiology & Pain Services, P.A. (including leased employees). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Termination of Plan

The Company has the right to terminate the Plan subject to the provisions of ERISA. During 2022, the Company ceased business operations. On August 5, 2022, the Company amended and terminated the Plan with an effective date of July 31, 2022, making liquidation of the Plan imminent. As of July 31, 2022, employee contributions ceased. Upon termination of the Plan, former participants with investment balances became 100% vested in their plan benefits. Benefits are to be paid to participants and beneficiaries in lump-sum amounts within a reasonable period after the effective date of the Plan termination.

Plan Entry Dates

*Elective Deferrals* – Prior to the termination of the Plan, entry dates were immediate, and employees could begin contributing upon their employment commencement date.

*Safe Harbor and Discretionary Nonelective Profit-Sharing Contributions* – Prior to the termination of the plan, completion of one year of service, as defined, during the relevant eligibility computation period, employees of the Company were eligible to receive a safe harbor and discretionary nonelective profit-sharing contribution. Entry dates were the first day of the first month and of the seventh month of the Plan year.

Contributions

Prior to the termination of the plan, participants could elect to contribute 100% of eligible compensation into the Plan, subject to certain limitations, deferred on a pre-tax basis. Participants could also designate some or all of their contributions as an after-tax Roth contribution, also subject to limitations. The contribution limit applies to any calendar year and is adjusted annually by the Internal Revenue Service. Participants who have attained the age of 50 before the end of the plan year could make additional pre-tax catch-up contributions. The Plan allows rollover contributions from other qualified retirement plans. The Plan is participant directed. Participants could change their contribution rates at the beginning of each payroll period and investment options at any time.

NOTE 1: DESCRIPTION OF THE PLAN (Continued)

Prior to the termination of the Plan, the Company could contribute a safe harbor nonelective employer contribution for each eligible participant in an amount equal to 3% of such participant's eligible compensation for such plan year. The Company could also make a discretionary nonelective employer contribution to all eligible participants. For the year ended December 31, 2022, the Company elected to make a discretionary nonelective employer contribution in an amount equal to 1% of each participant's eligible compensation for the plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Benefits paid to participants under the Plan are limited to the vested balance in each participant's account.

Vesting and Payment of Benefits

All participant contributions and safe harbor contributions vest immediately. Prior to termination of the plan, nonelective profit-sharing contributions vested according to the schedule below. Upon termination of the Plan, former participants with investment balances became 100% vested in their plan benefits.

Normal retirement age under the Plan was the later of age 65 or the 5<sup>th</sup> anniversary of participation in the Plan. Upon a participant's death, termination, retirement, disability, or attainment of age 59½, the vested funds in the participant's account are available to be distributed in a lump-sum payment. Participants could request a distribution at the time of termination or elect to leave the account invested in the Plan until a later date if their balance exceeds \$5,000. The Plan also allowed for hardship withdrawals from a participant's salary deferral account.

Forfeiture Account

The Plan controlled forfeiture account, which is funded from the non-vested portions of terminated participants' account balances, serves to reduce administrative expenses of the Plan and employer contributions. No forfeitures were used to reduce the employer's matching contribution during the period ended September 30, 2023. As of December 31, 2022, the Plan retained \$3 in forfeitures.

NOTE 1: DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants

Prior to the termination of the Plan, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Interest rates on loans were stated at reasonable rates. Loans were repaid in level installments through payroll deductions for periods ranging up to five years and in certain situations may have exceeded five years. Loans were secured by the participant's vested account balance to the extent of the principal amount of the loan plus accrued interest.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

On August 5, 2022, a decision was made to terminate the Plan effective July 31, 2022. As a result, the financial statements have been prepared on the liquidation basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP"). Under the liquidation basis of accounting, the Plan assets have been measured at the amount of the expected cash proceeds from liquidation as of the measurement date and any costs of liquidation are accrued for.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative fees when incurred. As of September 30, 2023 and December 31, 2022, no allowance was considered necessary by management. Delinquent notes receivable from participants are reclassified as benefit payments based upon the terms of the Plan document.

Administrative fees

Certain expenses of maintaining the Plan are paid directly by the Company and are therefore excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative fees. Other investment-related expenses are included in net appreciation in fair value of investments.

Benefit Payments

Benefits are recorded when paid.

NOTE 3: FAIR VALUE MEASUREMENTS

The Plan measures the fair value of Plan assets as the price that would be received to sell an asset in the principal market for that asset. These measurements are classified into a hierarchy framework by the inputs used to perform a fair value calculation. The hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

As required by FASB ASC 820-10, financial assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. The Company's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of the fair value of assets and liabilities and their placement within the fair value hierarchy levels. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market: Interest-bearing cash is valued based on the short-term cash component as of the measurement date.

Level 2: Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of September 30, 2023 and December 31, 2022.

NOTE 5: INCOME TAX STATUS

The Plan has adopted a Non-Standardized Prototype plan, which obtained its latest opinion letter on March 31, 2014, in which the Internal Revenue Service (“IRS”) stated that the prototype document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Plan did not have unrecognized tax benefits as of September 30, 2023 and December 31, 2022 and does not expect this to change significantly over the next twelve months. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of September 30, 2023 and December 31, 2022, the Plan has not accrued interest or penalties related to uncertain tax positions.

NOTE 6: PARTY-IN-INTEREST TRANSACTIONS

There were no party-in-interest transactions as of the period ended September 30, 2023.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
