The financial statements comprise the statements of net assets available for benefits as of February 28, 2023 (In Liquidation), and December 31, 2022 (Ongoing) and the related statement of changes in net assets available for benefits for the two-month period ending February 28, 2023 (In Liquidation), and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, Significant audit findings, and certain internal control-related matters that we identified during the audit.

***Emphasis of Matter***

As described in Note 1 to the financial statements, the Board of Directors of Vindex LLC approved a termination effective February 28, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the ongoing accrual

basis used in presenting the financial statements as of December 31, 2022 (Ongoing), to the liquidation basis used in presenting the financial statements as of February 28, 2023, and for the two-month period then ended (In Liquidation). Our opinion is not modified with respect to that matter.

#### 1. **Description of the Plan**

The following is a brief description of the Vindex LLC Retirement Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan document, related adoption agreement and individual statements provided to each Plan participant for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a qualified defined contribution pension plan covering eligible employees who are members of a controlled group which includes Vindex LLC and various affiliated companies who have elected to participate in the Plan (collectively, the “Company”). The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan investments are administered and held in a trust by the Plan’s trustee, Fidelity Management Trust Company (the “Trustee”), which also serves as the custodian of the Plan. The Trustee is qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Fidelity Workplace Services LLC, an affiliate of the Trustee, is the record-keeper of the Plan. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document. The Trustee, the record-keeper and the Plan administrator are appointed by the Company.

The Board of Directors of the Company elected on February 16, 2023, to liquidate and terminate the Plan, effective February 28, 2023, and to distribute Plan assets as soon as administratively practicable. In accordance with Plan provisions, the Sponsor vested 100% of the Plan’s assets as of February 28, 2023.

##### **Eligibility**

The Plan is available to all employees of the Company who have attained the age of 21 and completed 1,000 Hours of Service. The Plan excludes those employees who are: (1) Employees covered by a collective bargaining agreement, (2) Nonresident aliens who received earned income from services performed within the United States, (3) Leased employees, (5) Part-time, temporary, or seasonal employees. Entrance in the Plan is on the first day of each calendar month after meeting the eligibility requirements above.

##### **Participant Contributions**

Participants in the Plan may make a pre-tax contribution generally not to exceed 90% of eligible compensation and subject to the Internal Revenue Service Code (“IRC”) limits as discussed below. Compensation per the Plan document means wages, tips and other compensation on Form W-2. Compensation is adjusted to exclude fringe benefits, expense reimbursements, moving expenses, deferred compensation, and welfare benefits. Roth 401(k) contributions are not permitted.

#### 1. Description of the Plan

##### **Participant Contributions**

For 2023, the maximum amount of compensation that may be considered for deferral purposes by participants and employer contributions is \$330,000. For 2023, total participant contributions are limited to a maximum of \$22,500. Additionally, for 2023, individuals who are at least 50 years of age can make a “catch-up” contribution not to exceed \$7,500. The maximum annual addition for 2023 that may be contributed or allocated to a participant’s account under the Plan shall not exceed the lesser of 100% of a participant’s compensation or \$66,000.

##### **Rollover Contributions**

An eligible employee may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as rollover, with certain restrictions. The Plan will not accept rollovers of after-tax employee contributions.

##### **Investments**

Participants, in accordance with the Plan document, direct the Trustee to invest their contributions into various investment options offered by the Plan.

##### **Vesting**

Participants are fully and immediately vested in their voluntary and rollover contributions and Plan earnings thereon.

##### **Participant Accounts**

The Plan administrator establishes and maintains a separate account for each participant, which is credited for rollover and voluntary contributions the participants make, Company matching and profit-sharing contributions and Plan earnings. Income earned and net appreciation or depreciation on Plan investments are allocated in proportion to the participant’s account balances in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### 1. Description of the Plan

##### **Notes Receivable from Participants**

Each participant may borrow up to the lesser of: (1) 50% of the present value of the participant's vested interest in the account or (2) \$50,000, less currently outstanding notes receivable. The notes are secured by the vested balances in the participant's account. No note shall be less than \$1,000 and only one note at a time is allowed. The notes shall bear a reasonable rate of interest as determined by the Plan administrator. During 2023, the outstanding notes bear interest ranging from 3.50% to 7.00% per annum. Any such borrowings are to be repaid within five years unless the note is for the purchase of a principal residence for which a repayment period may not extend beyond 10 years. A note becomes immediately due and payable upon a participant's termination of employment, death, or disability.

##### **Forfeitures**

Upon termination of employment participants forfeit their non-vested balances. These accounts may be used to reduce future Company contributions or to pay administrative expenses. At February 28, 2023 (In Liquidation), and December 31, 2022 (Ongoing), the forfeited non-vested account balance was \$0 and \$3,287, respectively. No forfeited amounts were used to pay administrative expenses for the two-month period ended February 28, 2023 (In Liquidation).

##### **Retirement**

The normal retirement age is defined as when the participant reaches the age of 65. At the normal retirement date, the participant is entitled to 100% of their account balance. Early retirement is not permitted.

##### **Distributions of Benefits**

Distributions to participants are available upon the following events: retirement, termination of employment, the attainment of age 59 ½ or death. A participant's benefit consisting of his/her entire vested account balance can be paid in the form of either a lump sum distribution or on an installment basis. A participant with an account balance in excess of \$5,000 may elect to defer payment until attainment of the normal retirement age of 65. A participant's written consent will be required because of termination of employment for any distribution before age 65 if his/her vested account balance is greater than \$5,000. The Plan also provides for hardship withdrawals to participants meeting certain requirements as described in the Plan document. Upon written request, participants may withdraw all or a portion of their after-tax contributions. Participants must begin receiving Required Minimum Distributions, under IRS guidelines, upon reaching the age of 73.

#### 1. Description of the Plan

##### **Administrative Expenses**

Administrative expenses may be paid out of the Plan or by the Company. The Company incurred certain administrative expenses relating to the Plan without charge to the Plan during 2023.

#### 2. Summary of Significant Accounting Policies

##### **Basis of Accounting**

The Plan maintained its accounting records and financial statements under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”). Effective February 28, 2023, the Board of Directors of the Vindex LLC terminated the Plan. As a result, the Plan’s financial statements as of February 28, 2023 (In Liquidation), and for the period January 1, 2023 through February 28, 2023 (date of liquidation), have been prepared under the liquidation basis of accounting, in accordance with GAAP. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. There are no reconciling differences in the accounting between the two accounting methods. Accordingly, the liquidation basis of accounting, for reporting purposes, is effective January 1, 2023.

##### **Use of Estimates and Assumptions**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Dividend income is recorded on the ex-dividend date. Interest income is accrued when earned. The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation of the fair value of its investments, which included the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### 2. Summary of Significant Accounting Policies

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents. No allowance for credit losses has been recorded as of February 28, 2023 (In Liquidation), or December 31, 2022 (Ongoing).

##### **Payment of Benefits**

Benefit payments to participants or beneficiaries are recorded when paid.

##### **Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks including but not limited to, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

##### **Income Tax Status**

The Plan is an adoption of a non-standardized pre-approved plan that received an Internal Revenue Service ("IRS") opinion letter on June 30, 2020, stating that the pre-approved plan, as then designed, was then in compliance with the applicable requirements of the IRC. An employer adopting this pre-approved plan is considered to have a plan qualified under Section 401(a) of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the trust established under the Plan is tax-exempt. No provision for income taxes has been included in the financial statements since the Plan has no unrelated business income tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or the IRS. The Plan administrator has analyzed the tax position taken by the Plan and has concluded that as of February 28, 2023 (In Liquidation), and December 31, 2022 (Ongoing), there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements.

#### 2. Summary of Significant Accounting Policies

##### **Income Tax Status**

The Plan is subject to routine audits by the DOL or the IRS, however, there are currently no audits for any tax periods in progress.

##### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through February 22, 2024, which is the date the financial statements were available to be issued.

#### 3. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA, which it elected to do, effective February 28, 2023, as discussed in Note 1. When the Plan is terminated, the Plan assets will be allocated to provide benefits to those eligible under the terms of the Plan in the order of priority specified in the Plan document and as otherwise required by ERISA.

#### 4. Investments

For the two-month period ended February 28, 2023 (In Liquidation), the Plan's investments appreciated (including gains and losses on investments bought and sold, as well as held during the period) in value by \$240,894.

#### 5. Fair Value Measurements

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### 5. Fair Value Measurements

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2023 (In Liquidation), and December 31, 2022 (Ongoing):

**Interest-bearing cash and mutual funds:** Valued at the daily closing price as reported by the fund. Interest-bearing cash and mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in Fair Value Levels**

**6. Related Party and Party-in-Interest Transactions**

Certain Plan investments were shares of funds managed by an affiliate of the Trustee. Administrative expenses are paid to the Trustee and its affiliate who acts as the record-keeper of the Plan. Transactions with the Trustee and its affiliates qualified as party-in-interest transactions. Notes receivable due from Plan participants also qualified as party-in-interest transactions. The above transactions are not, however, considered prohibited transactions under CFR 408 (b) of the ERISA regulations.
