The plan sponsor, Biocept, Inc., filed a voluntary petition for relief under Chapter 7 of the United States Bankruptcy Code on October 13, 2023. The Office of the United States Trustee appointed Alfred T. Giuliano to serve as the Chapter 7 trustee in the bankruptcy case.

Due to the Chapter 7 bankruptcy filed by the plan sponsor, information/documentation that would have been provided by the plan sponsor to the auditor was unavailable, so the opinion of an independent qualified public accountant was unable to be obtained for this filing. Additionally, the cost of meeting the requirement to obtain the opinion of an independent qualified public accountant would have been borne by the plan’s participants and would have served only to reduce the amounts available for distribution to those participants.

For the reasons listed above, exemption is requested from the requirement to obtain the opinion of an independent qualified public accountant for this filing.
