Notes to Financial Statements
December 31, 2022 and 2021**

A. Description of Plan

The following description of Interfolio 401K P/S Plan (the "Plan") provides only general information. Participants should refer to the Plan Document or the Summary Plan Description for a more complete description of the Plan's provisions.

General

Interfolio, Inc. (the "Company") is the Plan sponsor and Plan administrator. Effective June 1, 2022, the Company was acquired by Elsevier. Plan participants were merged into the RELX Inc. US Salary Investment Plan beginning with payroll deductions and matching for the first payroll in December 2022. Participant account balances were transferred to the RELX Inc. US Salary Investment Plan, and the Interfolio Plan was terminated effective March 15, 2023.

The Plan is a defined contribution, tax-deferred retirement plan covering all employees of the Company, with certain exclusions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Cycle 3 Restatement

The Internal Revenue Service (IRS) requires qualified retirement plans that use pre-approved plan documents to be amended and restated every six years to reflect changes in the Internal Revenue Code (IRC) and IRS regulations. Effective January 1, 2022, the Plan's documents were restated in compliance with this requirement.

Eligibility

Covered employees who are at least 21 years of age and have three months of service with the Company are eligible to participate in the Plan. Employees may begin participation in the Plan on monthly entry dates.

Contributions

Participants may contribute up to 100% of compensation, as defined in the Plan documents, not to exceed the maximum salary deferral limit and other limitations established by law. Participant contributions may be made as pre-tax 401(k) contributions, Roth 401(k) contributions, or both. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code. Participants also may make rollover contributions of distributions from other retirement plans and certain IRAs, subject to Plan provisions.

The Plan allows employer safe harbor matching contributions. During 2022, through the final pay date of November, 2022, the Company made safe harbor matching contributions in the amount of 100% of employee deferrals each pay period up to 4% of eligible employee compensation, as defined. All participant and employer contributions were invested according to the direction of the participants.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and employer contributions. Investment earnings, losses, and changes in market value are allocated based upon the investment experience of each holding in a participant's account. Certain transactional costs and service charges, if any, are allocated to the specific accounts

involved in the transaction or receiving the service. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms require amortization of principal and interest over a period not to exceed five years, with certain exceptions. Participants may have up to two loans outstanding at a time. The loans are secured by the balance in the participant's account. The loan interest rate is set at two percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits

Plan participants are eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, upon disability and at death. Benefit payments are limited to the value of the participant's vested interest in his or her account. Benefit payments may be elected as a lump-sum payment equal to the value of the participant's vested interest in his or her account or as a direct rollover to another qualified plan. Partial withdrawals are available to meet IRS minimum distribution requirements. Accounts with vested balances less than \$5,000 may be cashed out of the Plan upon severance of employment. Hardship withdrawals are allowed, subject to Plan provisions and applicable laws. In-service withdrawals are allowed, subject to Plan provisions and applicable laws.

Vesting

Participants are 100% vested immediately in their own elective deferral contributions, employee rollover contributions, employer safe harbor matching contributions and earnings thereon. Employer non-safe harbor matching contributions and earnings thereon are subject to a vesting schedule based on the number of years of credited service. Non-vested profit sharing balances are subject to forfeiture upon termination of employment.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited non-vested balances were \$3,079 and \$3,601, respectively. Forfeited amounts may be used to reduce Company contributions or administrative expenses in accordance with Plan documents. No forfeitures were used by the Plan during 2022 to reduce Company contributions or pay administrative expenses.

B. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect

the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Except for the Voya Fixed Account, investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Voya Fixed Account is valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. The loans are secured by vested participant account balances. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Per-use transaction fees are charged directly to specific participant accounts for certain services, such as processing loans, in-service withdrawals, distributions, and other transactions. In addition to per-use transaction fees, participants with account balances share in the operational expense of the Plan. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events for disclosure in these financial statements through October 3, 2023, the date the financial statements were available to be issued. See Note A regarding transfer of Plan participant accounts to a new plan.

C. Information Prepared and Certified by the Plan Trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Voya Institutional Trust Company, the trustee of the Plan, has certified as to the completeness and accuracy of investments at fair value, investments at contract value, notes receivable from participants, dividends and interest, net appreciation or depreciation in fair value of investments, and interest on notes receivable from participants in these financial statements and the supplemental schedule, summarized as follows:

D. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability. Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds: Common collective trust funds are valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay

withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Guaranteed Interest Contract

The Voya Fixed Account investment is a guaranteed interest contract issued by Voya Retirement Insurance and Annuity Company ("VRIAC" or "Voya"). Voya maintains the contributions in a general company account and is contractually obligated to repay principal and a specified interest rate to the Plan. A single interest crediting-rate is applied to all Fixed Account assets regardless of when contributions are made. Voya periodically resets the crediting interest rate based on changes in markets, subject to the contractual guaranteed minimum interest crediting rate of 1.00%. The effective annual crediting interest rate at December 31, 2022 and 2021, was 1.04% and 1.00%, respectively. The Voya Fixed Account contract value was \$15,288 and \$9,820 at December 31, 2022 and 2021, respectively.

The Voya Fixed Account is a fully benefit responsive investment contract and therefore is presented at contract value on the statements of net assets available for benefits. Contract value is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus interest credited, and less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, subject to provisions for transfers to "competing investment options."

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its financial obligations may be affected by future economic and

regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events, such as termination of the contract by the Plan sponsor, may be subject to a market value adjustment and limit the ability of the Plan to transact at contract value with the issuer of the contract. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

F. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

G. Party-In-Interest Transactions

Voya Retirement Insurance and Annuity Company ("VRIAC" or "Voya") is the recordkeeper of the Plan and receives fees for recordkeeping services that are included in fees and other expenses. Voya also receives fees for other administrative services that are included in fees and other expenses. Voya Institutional Trust Company is the trustee of the Plan and receives fees for services that are included in fees and other expenses. A financial advisor receives fees for services and commissions that are included in net appreciation or depreciation in fair value of investments. The Company provides the Plan with accounting and administrative services, for which no fees are charged to the Plan. The Plan allows loans to participants. These transactions qualify as exempt party-in-interest transactions.

H. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100 percent vested in their accounts and the Company will arrange for distributions as soon as administratively feasible. See Note A regarding transfer of Plan participant accounts to a new plan.

I. Tax Status

The Internal Revenue Service has determined and reported in its opinion letter dated June 30, 2020, that the form of the adopted pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes the Plan is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no uncertain tax positions have been taken or are expected to be taken that would require recognition or disclosure in the financial statements.
