INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Mid-States Packaging, Inc. Employee Savings & Investment Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mid-States Packaging, Inc. Employee Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets (liquidation basis) available for benefits as of December 31, 2022 and of net assets available for benefits as of December 31, 2021 (ongoing), and the related statements of changes in net assets (liquidation basis) available for benefits for the year ended December 31, 2022 and of changes in net assets available for benefits for the year ended December 31, 2021 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2022 and 2021, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, Mid-States Packaging, Inc., the Plan Sponsor, was acquired by Quantix SCS on December 1, 2022. On that date management approved a plan of liquidation of the Mid-States Packaging, Inc. Employee Savings & Investment Plan and determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Audit of the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules of delinquent participant contributions and assets (held at end of year) as of December 31, 2022 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2022 (LIQUIDATION BASIS) AND 2021

1. DESCRIPTION OF THE PLAN

The following description of Mid-States Packaging, Inc. Employee Savings & Investment Plan (the "Plan") provides information for general purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all employees of Mid-States Packaging, Inc. (the Company). The Plan was established on March 15, 1994 and was restated effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees must complete six months of service and be at least 21 years old to participate in the Plan. One of the owners of the Company served as the plan administrator and the Company has designated a Committee who is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan Termination – Effective December 1, 2022, the Company was acquired by Quantix SCS. Per the terms of the acquisition agreement, Quantix SCS and the Company adopted a resolution effective December 1, 2022 to terminate the Plan. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ended employee and employer contributions into the Plan and ended the processing of new participant notes. See Note 2 for description of resulting liquidation basis of accounting for 2022 financial statements.

Participants were directed to request direct distributions from the Plan and as of May 2023 all Plan assets were fully distributed. All notes receivable balances not fully paid were deemed distributed to the participants. The remaining balance of the forfeiture account was used to offset plan expenses. Effective October 1, 2023, former employees of the Company who were active employees of Quantix became eligible to participate in the Quantix SCS 401(k) Plan.

Contributions – Prior to the Plan's termination, each year, participants could contribute up to 100% of their eligible compensation, as defined in the Plan, as pre-tax or after-tax deferrals. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2022, The Plan included an auto-enrollment provision for all employees unless participants affirmatively elected not to contribute to the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation. The Company could make discretionary employer matching and profit-sharing contributions determined by the Company. The Company would determine in its sole discretion how much, if any, it would make as an employer contribution. Participants had to meet the eligibility criteria to receive any employer contributions. In 2022 and 2021, the Company voted to make a discretionary matching contribution of 1.5% of the participant's eligible compensation up to \$1,500 annually per participant. There were no discretionary profit-sharing contributions to the Plan in 2022 and 2021. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

1. DESCRIPTION OF THE PLAN (CONTINUED)

Participants' Accounts – Prior to the termination, each participant's account was credited with the participant and Company's contributions as well as allocations of the Plan earnings (losses). Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting – Prior to December 1, 2022, the date management elected to terminate the Plan, participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution was based on years of continuous service. A participant became 100 percent vested after six years of continued service.

Notes Receivable from Participants – Prior to the Plan's termination, participants were permitted to borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50 percent of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, as determined by the Committee, was based on prevailing market conditions at the time of the loan and fixed over the life of the loan. The Plan did not permit loan payments to exceed five years except for residential loans. A participant could have two loans outstanding at any time. Principal and interest were paid ratably through periodic payroll deductions.

Payment of Benefits – Prior to the Plan's termination which resulted in distribution of participant balances in full by May 2023, vested benefits were paid to participants or their beneficiaries upon the participants' retirement, death, disability, or termination of employment with the Company. Distributions were made in lump-sum payments. In-service withdrawals of all or any portion of participant's vested balance were available in certain limited circumstances, as defined by the Plan. Hardship withdrawals were allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals were strictly regulated by the IRS.

Forfeitures – At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$5,198 and \$13,592, respectively. Forfeitures may be used to reduce future employer contributions or to pay for Plan expenses. During 2022, \$9,278 in forfeiture balances were used to offset plan expenses, respectively. In 2021, \$118 in forfeiture balances were used to offset plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The 2022 financial statements have been prepared on the liquidation basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP). The Company adopted a resolution effective December 1, 2022 to terminate the Plan. As a result, the Plan's financial statements as of December 31, 2022 and for the year ended December 31, 2022 have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of December 31, 2022 would be fair value. There were no material changes to the 2022 financial statements as a result of applying the liquidation basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition – Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events – The Plan has evaluated subsequent events through October 16, 2023, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED AND PROVIDED BY QUALIFIED INSTITUTIONS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, dividend income and interest income on notes receivable from participants for the years ended December 31, 2022 and 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Life Insurance Company, Inc. (Transamerica) for the period from January 1, 2021 to March 16, 2021, Transamerica Financial Life Insurance Company, Inc. (Transamerica Financial) for the period from March 17, 2021 to December 31, 2021, and Ascensus Trust Company (Ascensus) for the period from January 1, 2022 to December 31, 2022 (the trustees of the Plan). Transamerica, Transamerica Financial and Ascensus are qualified institutions.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as: (a) quoted prices for similar assets and liabilities in active markets, (b) quoted prices for identical or similar assets and liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, or (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts ("PSA") – valued daily based on the market value of the underlying net assets in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quotes pricing inputs which are used to determine the net asset value (NAV) of the PSA which is not publicly quoted. These securities are classified as Level 2. The redemption frequency of each of these PSA's is daily, and there are no redemption restrictions.

4. FAIR VALUE MEASUREMENTS (CONTINUED)

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022 and 2021.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Ascensus, Transamerica Financial and Transamerica. Ascensus and Transamerica Financial and Transamerica are qualified institutions as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to Ascensus for administrative services amounted to \$4,610 in 2022. Fees paid to Transamerica Financial for administrative services amounted to \$20,682 in 2021 and fees paid to Transamerica for administrative services amounted to \$3,450 in 2021.

6. INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan participated in a fully benefit-responsive investment contract with Transamerica Financial in 2021. The Plan held an investment in the Transamerica Stable Value Advantage Account with Transamerica Financial. Because the investment contract was fully benefit-responsive, contract value was the relevant measurement for that portion of the net assets available for benefits attributable to the investment contract. Each Stable Value Fund is an investment choice backed by the general account of the insurance company. The assets in the general account were supported by the financial stability of the insurance company, which declared interest rates and backed the principal and interest of this investment choice. Any guarantees were subject to the claims paying ability of the insurance company. Although plan participants generally could withdraw assets from the fund without restrictions, Transamerica Financial could have applied a hold on the Plan's assets for a period of up to 270 days. Additionally, Transamerica Financial could have imposed up to a 12-month delay period on all withdrawal requests from all plan sponsors at the plan level. The total contract value for this contract at December 31, 2021 was \$398,999.

7. TAX STATUS OF THE PLAN

Effective January 1, 2022, the Plan adopted a pre-approved defined contribution plan document sponsored by Ascensus, which has been determined by the Internal Revenue Service, in an opinion letter dated June 30, 2020, to be in accordance with applicable sections of the Internal Revenue Code (the Code). The plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

9. COMPLIANCE MATTERS

During 2021 and 2020, it was discovered that the Company was improperly excluding bonus and/or vacation payments for purposes of the Plan's definition of eligible compensation.

During 2021 and 2020 and 2019, the Company failed to remit employee contributions totaling \$15,751, \$59,681 and \$121,369, respectively, within the time frame deemed to be within DOL regulations for timely remittances.

The untimely remittances and errors in eligible compensation identified above, individually and collectively, were not expected to have a material impact on the net assets reported by the Plan. Therefore, the Company elected not to make corrective measures to the affected participants as of December 1, 2022, the date the Plan was terminated.

10. RISKS AND UNCERTAINTIES

The Plan participates in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
