**1. Description of Plan**

Jack Williams Tire Co., Inc. (the Company) sponsors the Jack Williams Tire Co., Inc. 401(K) Profit Sharing Plan and Trust (the Plan). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. This Plan was terminated on June 02, 2023, see Note 6 for more information.

*General*

The Plan is a defined contribution retirement plan covering substantially all employees of Jack Williams Tire Co., Inc. (the Company) who are at least 21 years old and must have completed 1 year of service which is defined as at least 1,000 hours of service in a 12-month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Each year participants in the Plan may contribute a dollar amount or percentage of pretax compensation, as defined in the Plan up to \$22,500 and \$20,500 for years ended December 31, 2023 and 2022, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company matches employee contributions to the Plan. The employer matches 100% of employee contributions up to 3%, and 50% from 3% to 5%, of the compensation as defined by the Plan. Employer matching contributions will not exceed 4% of compensation as defined by the plan. The Plan provides for a Company discretionary contribution, which is allocated to each eligible employee in proportion to his or her compensation as a percentage of the compensation of all eligible employees. There was no discretionary contribution made in 2023 and 2022.

*Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested account balances. Allocations are based on participant compensation or contributions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct all contributions into various investments offered by the Plan.

*Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of credited service and a 20% annual graded vesting schedule beginning after two years of completed service and 100% vested after six years of credited service.

*Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant is eligible to receive a distribution of their vested account balance. The normal form of benefit payment is a lump sum distribution. A participant may also elect to receive their benefit payment in installments as provided by the Plan. The Plan also provides for in-service withdrawals for hardship reasons.

*Participant Loans*

Participants may borrow from their investment fund account a minimum of \$1,000 and up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates ranging from 4.25% to 6.50% which are commensurate with local prevailing rates. All loans were repaid at the time of termination of the plan.

*Forfeited Accounts*

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures may be used to reduce future employer contributions or pay Plan expenses. No forfeitures were reallocated in 2023 and 2022. At June 02, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$67,999, respectively.

**2. Summary of Significant Accounting Policies**

*Basis of Accounting*

The financial statements of the Plan are prepared using the liquidation basis of accounting due to the Plan termination.

*Estimates*

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 02, 2023 and December 31, 2022.

*New Accounting Pronouncements*

In June 2016, the FASB issued ASU No. 2016-13, Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments. The ASU introduces a new accounting model, the Current Expected Credit Losses model (CECL), which requires earlier recognition of credit losses and additional disclosures related to credit risk. The CECL model utilizes a lifetime expected credit loss measurement objective for the recognition of credit losses for loans and other receivables at the time the financial asset is originated or acquired. The expected credit losses are adjusted each period for changes in expected lifetime credit losses. This model replaces the multiple existing impairment models in current GAAP, which generally require that a loss be incurred before it is recognized. The new standard also applies to receivables arising from revenue transactions, such as contract assets and accounts receivables. The standard has been applied prospectively with no adjustment to retained earnings needed.

*Allowance for Credit Losses*

When the company records customer receivables, contract assets, and financing receivables arising from revenue transactions, the company records an allowance for credit losses for the current expected credit losses (CECL) inherent in the asset over its expected life. The allowance for credit losses is a valuation account deducted from the amortized cost basis of the assets to present their net carrying value at the amount expected to be collected. Each period the allowance for credit losses is adjusted through earnings to reflect expected credit losses over the remaining lives of the assets. We evaluate debt securities with unrealized losses to determine whether any of the losses arise from concerns about the issuer's credit or the underlying collateral and record an allowance for credit losses, if required.

*Contributions*

Contributions to the Plan from employees are recorded in the period that payroll deductions are made from Plan participants.

*Fair Value Accounting*

Investments are reported at fair. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Valuation techniques used in fair value measurements need to maximize the use of observable inputs and minimize the use of unobservable inputs. A valuation method may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. Furthermore, although the Plan's Investment committee believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions could result in different fair value measurements at the reporting date. The expanded disclosure requirements are included in Note 3.

*Income Recognition*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold during the year.

*Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan did not have excess contributions to the applicable participants. The Plan would distribute excess contributions prior to March 15 of the year following the excess contribution per IRS guidelines.

*Administrative Expenses*

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. The employer absorbs recordkeeping, accounting, legal, and trustee service fees. Transaction-based fees are associated with optional services offered under the Plan and are charged directly to participant accounts for particular plan features that may be available. A Plan expense account (the "ERISA account") is maintained to hold revenue sharing funds the Plan receives from Ascensus Trust Company pursuant to an agreement between Ascensus Trust Company and the Plan.

*Administrative Expenses, continued*

These revenue sharing funds are available to pay qualified Plan administrative expenses. For the year ended June 02, 2023 and December 31, 2022, \$0 and \$28,650 were used to pay Plan expenses, respectively.

Mutual Fund management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

*Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

*Concentrations*

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 02, 2023 and December 31, 2022.

Mutual Funds are valued at quoted market prices, which represent the Net Asset Value (NAV) per share at the close of the financial markets. The NAV is based on the value of the underlying assets owned by the investment, minus its liabilities, and then divided by the number of shares outstanding. Mutual funds report NAV daily and are required to transact at that price.

Collective Investment Trusts for which quoted market prices are not available are determined by the net asset value (NAV) of shares held by the Plan at year end. Management has used the NAV as a practical expedient to fair value disclosure.

**4. Investments**

The Plan's investments in mutual funds and collective investment trusts (including interest and dividends and gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$298,023 for the period ended June 02, 2023.

**5. Related Party Transactions and Party in Interest Transactions**

Ascensus Trust is the Trustee and recordkeeper of the Plan. Effective November 26, 2018, Ascensus Trust provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Ascensus LLC. Ascensus LLC receives revenue from mutual fund service providers for services Ascensus LLC provides to the funds. This revenue is used to offset certain amounts owed to Ascensus LLC for its administrative services to the Plan.

**6. Plan Termination**

On May 9, 2022, Jack Williams Tire company was sold, and participation in the plan ceased as of that date. The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions. On June 02, 2023, the Company formally terminated the plan by resolution of the Plan's Board. All account balances were distributed to the participants, who had the option to take a distribution or rollover the balance to another qualified plan.

**7. Risks and Uncertainties**

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**8. Tax Status**

Effective February 20, 2009, the Company adopted a Prototype Standardized Profit-Sharing Plan with CODA. This prototype plan obtained a favorable opinion letter from the Internal Revenue Service dated March 31, 2008. The Plan has not obtained a determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements.

Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal Form 5500 for years before 2021.
