INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of SchoolCo Intermediate LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of January 3, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits in liquidation for the period January 1, 2023 through January 3, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SchoolCo Intermediate LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 3, 2023 and December 31, 2022 and for the period January 1, 2023 through January 3, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SchoolCo Intermediate LLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note F to the financial statements, the Sponsor of SchoolCo Intermediate LLC 401(k) Plan approved the termination of the Plan to merge into New Story Retirement Plan as of January 1, 2023 and management determined liquidation is imminent. As a result, the SchoolCo Intermediate LLC 401(k) financial statements are presented on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTE A – DESCRIPTION OF THE PLAN

The following description of SchoolCo Intermediate LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering substantially all employees of SchoolCo Intermediate LLC, Rebecca School, LLC and Aaron School, LLC collectively, (the Sponsor). The Plan began accepting contributions on May 5, 2022; although the Plan was made effective on January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

As disclosed in Note F to the financial statements, the Plan terminated as of January 1, 2023 and merged into New Story Retirement Plan effective January 3, 2023.

2. Eligibility

Each employee is eligible to make contributions to the Plan on the first day of the month following the attainment of age twenty-one and sixty days of service.

3. Contributions

Each year, participants may contribute up to 90% of eligible pretax compensation as defined in the Plan agreement. Participants who have attained age 50 before year end are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified defined benefit or defined contribution plans (rollover) and may make Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may only modify their elective deferrals on the first day of each quarter.

The Sponsor makes a discretionary matching contribution for participants who have attained one year of service if decided by the Sponsor. There were no matching contributions during the period January 1, 2023 through January 3, 2023.

4. Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions and (b) Plan earnings and losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

NOTE A – DESCRIPTION OF THE PLAN – Continued

5. Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance subject to certain limitations described more in the Plan Agreement. The loans are secured by the balance in the participant's account. The notes bear interest at prime plus 2.00% at the time of origination which ranges from 4.25% to 6.50%. Interest and principal payments are made through regular payroll deductions and participants can make payments directly outside of payroll to pay loan in full.

6. Vesting

Participants are vested immediately in their contributions plus earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 3 years of service.

7. Payment of Benefits

Upon termination of service due to death, disability, early retirement, normal retirement or termination of service due to other reasons, a participant or the participant's estate or beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in the participant's account, but may opt for partial withdrawals. Hardship withdrawals are permitted by the Plan.

8. Forfeited Accounts

Forfeited non-vested account balances are applied to reduce future Sponsor contributions or pay administrative expenses. Forfeited non-vested accounts totaled \$-0- and \$140 as of January 3, 2023 and December 31, 2022, respectively. No forfeitures were used to reduce Sponsor contributions or Plan expenses during the period January 1, 2023 through January 3, 2023.

9. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless paid by the Sponsor. Expenses paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in the net depreciation of fair value of investments.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting. See Note F for more detail regarding the Plan termination and merger.

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note D for discussion of fair value measurements.

Purchases and sales of securities are reported on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

4. Payment of Benefits

Benefits are recorded when paid.

5. Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through March 7, 2024, the date the financial statements were available to be issued.

NOTE C – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at January 3, 2023 and December 31, 2022, and net depreciation in fair value of investments, interest and dividends for the period January 1, 2023 through January 3, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (Empower) the custodian of the Plan.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The hierarchy includes three levels. Level 1 includes instruments whose inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 includes instruments whose inputs to the valuation methodology include quoted market prices for similar assets or liabilities in active markets, quoted market prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 includes instruments whose inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts valued at the net asset value, which is based on the values of the underlying investments as determined by quoted market prices, less any liabilities.

Fair Value of Investments in Entities that use NAV

The common collective trust investment objective is to preserve invested principal while providing a competitive current rate of return. There are no restrictions on redemption and there were no unfunded commitments as of January 3, 2023 and December 31, 2022.

NOTE E –RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Empower is the record keeper for the Plan. Therefore, transactions with Empower qualify as party-in-interest transactions. Certain fees incurred by the Plan are included in net depreciation in the fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

NOTE F – PLAN TERMINATION AND MERGER

The Sponsor terminated the Plan effective January 1, 2023 and the assets were fully liquidated and merged into New Story Retirement Plan. Management considered liquidation of the Plan to be imminent as of December 31, 2022. On January 3, 2023 the amount of assets transferred to the New Story Retirement Plan as a result of the Plan merger was \$3,198,329.

NOTE G – TAX STATUS OF THE PLAN

The Plan is a qualified prototype plan under Section 401(a) of the Internal Revenue Code (IRC) from Empower. The Internal Revenue Service (IRS) issued an opinion letter to NOVA 401K Associates Inc. dated June 30, 2020 stating that its prototype plan document was designed in accordance with IRC requirements as of that date.

Although the Sponsor has not applied for a determination letter for the Plan, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan has not taken any uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits in liquidation.

Participants may also make rollover contributions representing distributions from other qualified defined benefit or defined contribution plans (rollover) and may make Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may only modify their elective deferrals on the first day of each quarter.

The Sponsor makes a discretionary matching contribution for participants who have attained one year of service if decided by the Sponsor. There were no matching contributions during the period January 1, 2023 through January 3, 2023.

4. Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions and (b) Plan earnings and losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

NOTE A – DESCRIPTION OF THE PLAN – Continued

5. Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance subject to certain limitations described more in the Plan Agreement. The loans are secured by the balance in the participant's account. The notes bear interest at prime plus 2.00% at the time of origination which ranges from 4.25% to 6.50%. Interest and principal payments are made through regular payroll deductions and participants can make payments directly outside of payroll to pay loan in full.

6. Vesting

Participants are vested immediately in their contributions plus earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 3 years of service.

7. Payment of Benefits

Upon termination of service due to death, disability, early retirement, normal retirement or termination of service due to other reasons, a participant or the participant's estate or beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in the participant's account, but may opt for partial withdrawals. Hardship withdrawals are permitted by the Plan.

8. Forfeited Accounts

Forfeited non-vested account balances are applied to reduce future Sponsor contributions or pay administrative expenses. Forfeited non-vested accounts totaled \$-0- and \$140 as of January 3, 2023 and December 31, 2022, respectively. No forfeitures were used to reduce Sponsor contributions or Plan expenses during the period January 1, 2023 through January 3, 2023.

9. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless paid by the Sponsor. Expenses paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in the net depreciation of fair value of investments.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting. See Note F for more detail regarding the Plan termination and merger.

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note D for discussion of fair value measurements.

Purchases and sales of securities are reported on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

4. Payment of Benefits

Benefits are recorded when paid.

5. Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through March 7, 2024, the date the financial statements were available to be issued.

NOTE C – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at January 3, 2023 and December 31, 2022, and net depreciation in fair value of investments, interest and dividends for the period January 1, 2023 through January 3, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (Empower) the custodian of the Plan.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The hierarchy includes three levels. Level 1 includes instruments whose inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 includes instruments whose inputs to the valuation methodology include quoted market prices for similar assets or liabilities in active markets, quoted market prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 includes instruments whose inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts valued at the net asset value, which is based on the values of the underlying investments as determined by quoted market prices, less any liabilities.

Fair Value of Investments in Entities that use NAV

The common collective trust investment objective is to preserve invested principal while providing a competitive current rate of return. There are no restrictions on redemption and there were no unfunded commitments as of January 3, 2023 and December 31, 2022.

NOTE E –RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Empower is the record keeper for the Plan. Therefore, transactions with Empower qualify as party-in-interest transactions. Certain fees incurred by the Plan are included in net depreciation in the fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

NOTE F – PLAN TERMINATION AND MERGER

The Sponsor terminated the Plan effective January 1, 2023 and the assets were fully liquidated and merged into New Story Retirement Plan. Management considered liquidation of the Plan to be imminent as of December 31, 2022. On January 3, 2023 the amount of assets transferred to the New Story Retirement Plan as a result of the Plan merger was \$3,198,329.

NOTE G – TAX STATUS OF THE PLAN

The Plan is a qualified prototype plan under Section 401(a) of the Internal Revenue Code (IRC) from Empower. The Internal Revenue Service (IRS) issued an opinion letter to NOVA 401K Associates Inc. dated June 30, 2020 stating that its prototype plan document was designed in accordance with IRC requirements as of that date.

Although the Sponsor has not applied for a determination letter for the Plan, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan has not taken any uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits in liquidation.
