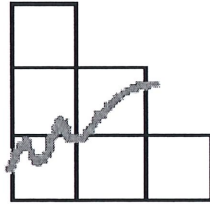

INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
the Community Resource Project, Inc. Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Community Resource Project, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of May 31, 2023 and September 30, 2022, and the related statement of changes in net assets available for benefits for the eight month period ended May 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Community Resource Project, Inc. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 31, 2023 and September 30, 2022, and for the eight month period ended May 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Community Resource Project, Inc. Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of a Matter - Basis of Accounting

As discussed in Note 11 to the financial statements, the Board of Directors of Community Resource Project, Inc. approved a plan of liquidation on July 28, 2022. All assets were liquidated May 31, 2023. As a result, the Plan used the liquidation basis of accounting in presenting the September 30, 2022 and May 31, 2023 financial statements. Our opinion is not modified with respect to the matter.

Responsibilities of Management for the Financial Statements

NOTES TO THE FINANCIAL STATEMENTS

MAY 31, 2023

• NOTE 1 - DESCRIPTION OF PLAN

The following description of the Community Resource Project, Inc. Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- 1) *General*: The Plan is a defined contribution plan adopted October 1, 1995, covering all employees of Community Resources Project, Inc. (the Organization) who have one year of service and are 21 years or older. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Board of Trustees oversees governance of the Plan.
- 2) *Contributions*: The Organization contributes, at its discretion, an amount equal to a percentage of base compensation. Employer contributions are directed by the participants and invested in a variety of mutual funds and insurance contracts.
- 3) *Participant Accounts*: Each participant’s account is credited with the allocations of (a) the Organization’s contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- 4) *Vesting*: Participants are vested in the Organization’s contribution based on years of continuous service. A participant is 100 percent vested after six years of credited service.
- 5) *Funding Policy*: It is the policy of the Organization to fully fund all participant accounts as required by ERISA.
- 6) *Payment of Benefits*: On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or may elect a systematic withdrawal plan (installment plan).
- 7) *Forfeitures*: Forfeitures are used to reduce the employer liability for current contributions and to pay for administrative expenses. The amount of forfeitures used to pay administrative expenses was \$1,416 and \$8,345 for the eight month period of May 31, 2023 and September 30, 2022.
- 8) *Administration Costs*: A portion of administration costs are currently being paid by the employer. (See above on 7).
- 9) *Plan Termination*: By approval of its Board of Trustees, the Company terminated the Plan on September 30, 2022. In the event of the termination, participants became 100 percent vested in their employer contributions. See Note 10.

NOTES TO THE FINANCIAL STATEMENTS

- **NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

- 1) *Basis of Accounting:* The financial statements of the Plan are prepared under the accrual basis of accounting.
- 2) *Investment Valuation and Income Recognition:* The Plan's investments are stated at fair value except for the fully-benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

- 3) *Estimates:* The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- 4) *Payment of Benefits:* Benefits are recorded when paid.
- 5) *Date of Management's Review:* Subsequent events were evaluated through March 1, 2024, which is the date the financial statements were available to be issued.

- **NOTE 3 - RELATED PARTY TRANSACTIONS/IDENTITY OF INTEREST TRANSACTIONS**

Related Party: Management of the employer participates to the same extent as other employees.

Identity of Interest: Fees paid by the Plan for investment management service and recordkeeping were \$22,814 to Standard Retirement Services for the eight month period ended in May 31, 2023. The Plans auditor was paid \$7,500 for the eight month period ended May 31, 2023 by the Company. The trustees of the Plan are Charles Schwab Trust Bank and Standard Insurance Company.

- **NOTE 5 - TAX STATUS**

The Plan participates in a Volume Submitter Profit Sharing sponsored by Standard Retirement Services, Inc. This Plan was identified as acceptable by the IRS on June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan's administrator and council believe the Plan is currently being designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe the Plan is qualified and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

- **NOTE 6 - CONCENTRATION OF CREDIT RISK ARISING FROM INVESTMENTS IN UNINSURED ACCOUNTS**

The Plan's investments are currently all held with Charles Schwab Bank and Standard Life Insurance Company. These funds are uninsured and are not guaranteed. The value is based on current market value that varies daily. The availability of funds is based on the financial strength of the mutual funds and the insurance company. Uninsured balances total \$-0- and \$1,857,048 at May 31, 2023 and September 30, 2022.

• NOTE 7 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit, except for fully benefit-responsive investment contracts, which are reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available, and Level 3 inputs were used when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted prices in active markets on actual assets held by the Plan at year end.

Level 2 Fair Value Measurements

The pooled separate accounts are divided into investment divisions called "Sub-Accounts". Each Sub-Account invests in shares of an underlying mutual fund.

Sub-Account values are measure in terms of 'Accumulated Units'. The Accumulation Units of a Sub-Account are assigned a unit value on a daily basis at the end of each day the New York Stock Exchange (NYSE) is open for trading, as of the close of the NYSE on that day (this is called a "Valuation Day"). To determine the current Accumulation Unit Value for a Sub-Account, the prior Valuation Day's Accumulation Unit Value is multiplied by the Net Investment Factor. The Net Investment Factor is used to measure the investment performance of a Sub-Account from on Valuation Day to the next. The Net Investment Factor for each Sub-Account equals the net asset value (NAV) per share of the underlying Fund held in the Sub-Account at the end of the current Valuation Day, divided by the net asset value (NAV) per share of the underlying Fund held in the Sub-Account at the end of each prior Valuation Day, minus any daily mortality and expense risk and administration charges, if applicable.

The shares of the underlying Fund are valued at net asset value (NAV) on a daily basis. A complete description of the valuation method used by the underlying Fund may be found in the underlying Fund's prospectus.

- **NOTE 8 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2017, the Plan entered into a benefit-responsive investment contract with Standard Insurance Company. Standard Insurance Company maintain the contributions in a general account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The total fair value of the investment contract at May 31, 2023 and September 30, 2022, was \$-0- and \$10,758, respectively. The crediting interest rate is based on an agreed-upon formula with the issuer, but it may not be less than 1% for Standard Insurance Company. Such interest rates are reviewed on a quarterly basis for Standard Insurance Company for resetting. Certain events limit the Plan's ability to transact at contract value with Standard Insurance Company. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs and the liberalization of plan withdrawal or transfer rules. The plan was terminated and all funds in the contract were distributed.

- **NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

- **NOTE 10 – PLAN TERMINATION**

On July 28, 2022, the Board of Directors approved an amendment to terminate the Plan effective September 30, 2022. All participants became 100 percent vested in the Plan upon termination and were provided the option to have their account balance rolled into the Organization's 403(b) Plan, receive a lump sum distribution, or rolled into another qualified plan or IRA. All of the Plan's assets were distributed as of May 31, 2023.
