Original Effective Date:	April 1, 1974.
Last Restatement:	January 1, 2020.
Plan Eligibility:	Employee members of Local 168 U.E.R.M.W.A. are eligible to enter the plan on their date of employment.
Vesting Service:	A Participant earns one year of vesting service in each Plan Year in which the Participant has 1,000 or more Hours of Service.
Benefit Service:	A Participant accrues 2/10 years of benefit service by working at least 200 hours in a plan year. For each additional 200 hours worked, another 1/10 year of benefit service is granted, up to a full year with 1,800+ hours.
Normal Retirement Date:	The first day of the calendar month coincident with or next following attainment of age 65.
Early Retirement Date:	The first day of any calendar month as elected by the Participant following attainment of age 55 and completion of 15 years of vesting service.
Normal Retirement Benefit:	\$14.55 per month per Year of Benefit Service for any Participant with at least one hour of service on or after March 1, 2004. Participants without an hour of service after March 1, 2004 benefit according to the rate specified in earlier negotiated contracts between the employer and the union.
Early Retirement Benefit:	A Participant's early retirement benefit shall be calculated the same as for normal retirement, except that the normal retirement benefit is reduced by 1/15th for each of the first five years and 1/30th for the next five years by which the early retirement date precedes the normal retirement date.
Disability Benefit:	A Participant incurring a Total and Permanent Disability while an employee prior to retirement age but after attainment of age 40 with at least 15 years of vesting service shall receive a disability benefit after the disability has continued for six consecutive months. The disability benefit shall be the accrued benefit as of the anniversary date following termination reduced actuarially to take into account the participant's age. Benefits shall continue until the earlier of (1) discontinuation of Social Security Disability Benefits, (2) death, or (3) normal retirement age. Upon attainment of normal retirement age, the Participant shall be entitled to a retirement benefit under the same conditions as any other Participant.

Termination Benefit: The normal retirement benefit based on actual Years of Benefit Service as of the date of termination, vested according to the schedule below.

Vesting Schedule: A Participant shall become vested in accrued benefits according to the following schedule:

Notwithstanding any other provision of the Plan to the contrary, a Participant's vested interest in his accrued benefit shall be 100% upon his death, or on his normal retirement date if he is employed by an employer, regardless of whether he has completed the number of years of service required under the above schedule for 100% vesting.

Pre-retirement Death Benefit: If a Participant dies prior to the Participant's Retirement Date, a death benefit of \$1,000 plus the minimum spouse's death benefit shall be payable to the surviving spouse. If the Participant has no surviving spouse, a death benefit of \$1,000 will be paid to the Participant's Beneficiary.

Normal Form of Benefit: Straight Life Annuity.

Optional Benefit Forms: 100%, 75%, 66.67%, or 50% Joint and Survivor Annuity; Five-, Ten-, or Fifteen-year Certain and Life Annuity; Five-, Ten-, or Fifteen-year Certain Period Only Annuity.


