### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Findaway 401(k) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of October 2, 2023, and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023, through October 2, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 2, 2023, and December 31, 2022, and for the period from January 1, 2023, through October 2, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). As discussed in Note 1 to the financial statements, plan management of the Findaway 401(k) approved a plan of liquidation and termination effective July 31, 2023, and Plan assets were liquidated through October 2, 2023. Our opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

## NOTES TO THE FINANCIAL STATEMENTS

## 1. DESCRIPTION OF PLAN

The following description of Findaway 401(k) (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Termination of Plan

Effective July 31, 2023, the plan sponsor adopted a resolution to terminate the Plan and a plan of liquidation was adopted. Final distributions were made according to participant elections and Plan provisions through October 2, 2023. The following notes to the financial statements describe the Plan's policies that were in effect for the period from January 1, 2023, through October 2, 2023.

General

The Plan was a defined contribution plan covering substantially all non-union and non-seasonal employees of Findaway World, LLC (the Company) who had attained 18 years of age and had completed 30 days of employment with the Company. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator oversaw governance of the Plan. The Plan's Investment Committee determined the appropriateness of the Plan's investment offerings, and monitored investment performance, and reported to the plan administrator.

Contributions

Each year, participants could make voluntary pre-tax and Roth contributions up to 100% of their eligible compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants could direct the investment of all contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation and their contributions invested in a target retirement date fund until changed by the participant. The Company could, at its discretion, make matching contributions. During 2023, the Company made matching contributions of 100% of the first 2% of participant compensation contributed to the Plan. The Company could also authorize discretionary profit-sharing contributions to the Plan for the related year. No discretionary profit-sharing contributions were authorized for the period from January 1, 2023, through October 2, 2023. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

## NOTES TO THE FINANCIAL STATEMENTS

## 1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

A separate account was maintained for each participant. Each participant's account was credited with the participant's contributions, rollover contributions, allocations of the Company's contributions, and Plan earnings or losses as defined by the Plan agreement. Allocations of the Company's discretionary profit-sharing contributions were given only to participants employed at the end of the Plan year, and were based on participants' compensation for the Plan year relating to the contribution. Plan earnings or losses were allocated daily based on each participant's account balance. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions and all employer contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes were secured by the balance in the participant's account. The loan interest rate, determined at inception, was set at Prime (7.50% at December 31, 2022,) as defined, plus 1.00% in accordance with the Plan's loan policy. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Upon termination of the Plan, participants received lump-sum distributions equal to their account balance in accordance with the participants' election and the Plan provisions. Prior to the Plan termination, upon termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a future period. If the participant's account balance was between \$1,000 and \$5,000, the plan administrator made an automatic rollover of the account balance to a qualified individual retirement account. If the participant's account balance was less than \$1,000, the plan administrator directed the custodian or trustee to make a lump-sum distribution. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. In-service distributions of a participant's 401(k) account balance could be authorized at any time by the plan administrator when the employee reached age 59 ½, qualified for a deemed severance distribution, upon disability, or under certain hardship conditions.

## NOTES TO THE FINANCIAL STATEMENTS

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

Investments held by a defined contribution plan were required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value was the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants normally could receive if they initiated permitted transactions under the terms of the Plan.

Use of Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All Plan assets were liquidated by close of business on October 2, 2023. During 2023, prior to the liquidation and as of December 31, 2022, investments were reported at fair value by Empower Trust Company, LLC (Empower Trust) and Empower Annuity Insurance Company of America (Empower), the custodian and trustee, respectively, of the Plan (except for fully benefit-responsive investment contracts, which were reported at contract value). Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Assets of the Plan were held in separate accounts of a trust administered by Empower Trust and Empower as of December 31, 2022, representing investments in mutual funds and a guaranteed investment contract.

## NOTES TO THE FINANCIAL STATEMENTS

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of December 31, 2022. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits were recorded when paid.

Plan Expenses

The Plan's administrative expenses were paid either by the Plan or the Company as provided by the Plan agreement. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Income Taxes

In accordance with GAAP, the plan administrator was required to evaluate tax positions taken by the Plan and recognize a tax liability for any significant uncertain position that more likely than not would not be sustained upon examination by the IRS. As of October 2, 2023, and December 31, 2022, and for the period from January 1, 2023, through October 2, 2023, the Plan did not have a liability for unrecognized tax benefits. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

## 3. INFORMATION CERTIFIED BY CUSTODIAN AND TRUSTEE

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023, through October 2, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust and Empower, the custodian and trustee, respectively.

## NOTES TO THE FINANCIAL STATEMENTS

## 4. FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2 Other significant observable inputs including: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 Inputs are significant and unobservable (including the Plan's own assumptions used to determine value)

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Assets measured at fair value at December 31, 2022, were comprised of Level 1 mutual funds totaling \$5,336,480.

The Plan did not hold any level 3 assets during the period from January 1, 2023, through October 2, 2023.

## 5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan had a fully benefit-responsive investment contract with Empower. Empower maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

## 5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)

The guaranteed investment contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they initiated permitted transactions under terms of the Plan. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate was based on a formula established by the issuer, but could not be less than zero percent. The crediting interest rate was 0.93% at December 31, 2022. Such interest rates were reviewed on a quarterly basis for resetting.

## 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Empower Trust and Empower. Empower Trust and Empower were the custodian and trustee, respectively, as defined by the Plan and, therefore, such transactions qualified as party-in-interest transactions.

Empower Trust and Empower provided certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Empower Trust and Empower. Empower Trust and Empower received revenue from mutual fund service providers for services Empower Trust and Empower provided to the funds. This revenue received by Empower Trust and Empower from such mutual fund service providers was remitted to the Plan's trust on a monthly basis in accordance with the terms of the MSA. Such amounts could be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2023, the revenue applied to expenses totaled \$9,059. The Plan or the Company could remit payments to Empower Trust and Empower for administrative expenses not covered by revenue sharing.

These party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

## 7. TAX STATUS

The Plan had adopted a prototype plan provided by Great-West Trust Company, LLC (Great-West Trust). Great-West Trust received an opinion letter dated June 30, 2020, from the IRS stating that the prototype plan was acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees.
